This has reference to the highlights of discussion and agreements made during the special meeting on the Secretary Cimatu's Directives held on the 04th of May 2021 at 10:00 AM via Zoom Teleconference.

Secretary Roy A. Cimatu instructed to conduct a meeting with all Undersecretaries, all Assistant Secretaries, all the Regional Executive Directors (REDs), all Provincial Environment and Natural Resources Officers (PENROs), all Community Environment and Natural Resources Officers (CENROs) and Directors of Policy, Planning Service and Financial and Management Service concerning the implementation of NGP.

Secretary Cimatu delivered his opening message highlighting that the field offices especially the CENROs have the responsibility on the success of the NGP. Further, he also mentioned that Philippine's lumber demand per year is approximately five (5) million cu. m. but the Philippines can only produce one (1) million cu. m. which are mostly from private plantation while the other four (4) million cu. m. are imported. Lastly, he mentioned the refocusing of ENGP implementation and for the preparation for the upcoming FY 2022 Budget Deliberation.'

Highlights of the Meeting

Secretary Roy A. Cimatu instructed to convene a special meeting on NGP to provide a venue for consultation and discussion with the DENR field offices, especially the REDs, PENROs and CENROs, on refocusing of ENGP implementation as well as to prepare for the upcoming FY 2022 Budget Deliberation. The Secretary emphasized that the success and failure of ENGP depends on the PENROs and CENROs who are the frontliners in ENG implementation.

To start the meeting, The Assistant Secretary for Policy, Planning and Foreign Assisted and Special Projects and Director, FMB in Concurrent Capacity Marcial C. Amaro, Jr. presented the Philippine forest cover, wood demand and supply, refocused ENGP objectives, Secretary Cimatu's directives, and proposed policy issuances. The estimated forest cover in the Philippines is 7,014,154 hectares. Among the Regions, Region 2 has the most forest cover with 1.05 Million hectares and among the provinces, Palawan has the most forest cover with 0.69 Million hectares. Moreover, the estimated wood demand of the Philippines (CY 2015) is 4.956 Million cubic meters while the average annual wood supply is 819,360 cubic meters, which is 17% of the wood demand. The country has a deficit of 83% in wood supply that resulted in the importation of wood. These two factors, forest cover and wood demand and supply are the basis for refocusing ENGP objectives. Based on the projected harvestable area and yield from NGP Bamboo and timber plantations, the country would be self-sufficient in terms of wood demand by the year 2034 if we plant 40,000 hectares of Bamboo and 35,000 hectares of Timber every year from 2021-2025.

The refocused ENGP objectives generally include increasing forest cover and enhancing biodiversity in protection forest and meeting the wood demand/deficit in production forest. In line with this, the directives of the Secretary include the following:

- Secure funding for enhancement planting of graduated NGP sites; prioritize CY 2011 plantations for FY 2022
- Enhance Urban Forestry

- Reactivate seedling production and distribution program
- Strict compliance on species choice/mix for planting
- Inventory: old reforestation projects/areas (BF/RA, BFD, DENR); LGU initiatives on forest/tree park establishment; private forest/tree plantations
- Deployment of Greening Guardians in all CENROs/Implementing PENROs
- Submission of best photos of "growing forests" in NGP plantations

Moreover, to implement these directives and achieve the objectives, the following policies were proposed, to wit:

- Enhancement of Graduated NGP sites (viz Delisting)
- Government Share in Harvest of NGP Plantations
- Program Support for Private Tree Plantations e.g. DENR-DBP MOA on DBP Tree Plantation Financing Program (August 2019), coverage of crops in NGP plantations in Philippine Crop Insurance Corporation (PCIC)

• (Revisit) RA 9175 or Chainsaw Act of 2002 for stricter regulation of chainsaws

Way-forward:

- 1. Refocused ENGP objectives will be implemented next year (CY 2022) and planting should start in May, if possible.
- 2. Submission of geotagged photos of Old Reforestation projects and new projects.
- 3. Highlight Old Reforestation Projects for the appreciation in the Congress.
- 4. Disseminate discussion on the meeting and supervise personnel to improve survival rate.
- 5. Maximize areas for wood production as this is the major intention other than fruit trees.
- 6. Field Offices to submit additional issues and concerns in writing through proper channels.
