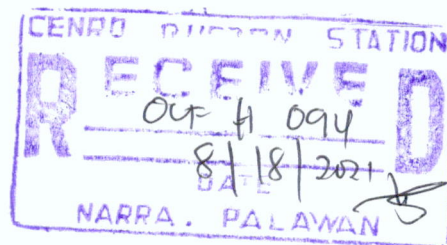



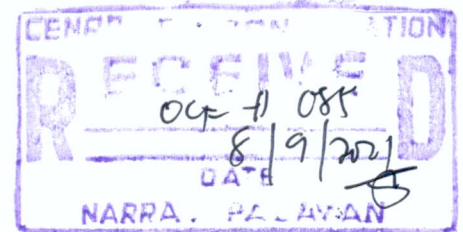

Please be informed that the undersigned conducted fieldwork on August 6, 2021 in Sitio Boong, Bgy. Dumangueña, Narra, Palawan to monitor the construction of TMPA bunkhouse. Despite that the Mobilization Fund was not yet released to the PO, the TMPA was able to construct the said bunkhouse thru the initiative of Officers and active members. As of that date, the following were accomplished by the PO:

1. Installation of trusses, purlins and studding;
2. Hauling of materials such as G.I. roof and sawali for walling;
3. Installation of G.I. roof;
4. Installation of bamboo slats flooring of two (2) rooms;
5. Installation of Sawali walls of the two (2) rooms.

Labor was done by PO Officers and members. Attached are attendance sheet and geo-tagged photographs.















4. Installation of wooden beams.












REMINDERS

1. An annual registration fee shall be paid upon registration and every year thereafter on or before the last day of January, using BIR Form No. 0605.
2. Filing of required tax return/s to conform with the above tax types, whether with or without business operation, to avoid penalties.
3. For new business registrants, application for registration of manual Books of Accounts (B/As) shall be before the deadline for filing of the initial quarterly income tax return or annual income tax return whichever comes earlier, from the date of registration. Registration of new set of manual B/As shall be before its use.
4. Immediately inform the district office in case of transfer/cessation of business and other changes in registration information by filing BIR Form No. 1905.
5. For Self-Employed Individuals (SEI) whose gross sales and/or receipts and other non-operating income does not exceed P3,000,000 and who opted to avail of the 8% income tax rate, the tax type Percentage Tax (PT) shall not be reflected in the Certificate of Registration (COR). However, at the start of each taxable year, such SEI shall be automatically subjected to graduated income tax rates and required to file quarterly percentage tax return (BIR Form No. 255(Q)) and option to replace the COR to reflect "PT", unless qualified and opted to avail of the 8% income tax rate annually.
