ACCOMPLISHMENT FOR THE MONTH OF AUGUST 2021**

Respectfully submitted is the progress/status report of this Office pertaining to the accomplishment as of August 30, 2021 of Tagbisay Multi-Purpose Association (TMPA), beneficiary of CBFM-CARP Agroforestry Project for CY 2021-2022, to wit:

- A. **Construction of Bunkhouse.** About 70% of the construction of the bunkhouse is completed with two (2) restroom, installed G.I roofing and sawali wall, and meeting area (*geo-tagged pictures are attached hereto*);
- B. **Seedling Production.** The TMPA have produced an additional 2,271 seedlings as per inspection activity conducted last August 10, 2021. As of this date, they have raised a total of 29,071 seedlings, equivalent to 52% physical accomplishment;



- C. **Financial Performance.** As of this date, the total amount of Php 1,035, 000.00 has been obligated but no disbursement yet because TMPA has no existing Tax Identification Number (TIN). TIN is a necessary requirement for the opening of account with LANDBANK. On July 30, 2021, TMPA managed to register with the Securities and Exchange Commission (SEC) with its new name **TAGBISAY – UPLAND FARMERS' ASSOCIATION, INC. (TUFAI)** and successfully obtained its TIN (*copy of SEC and TIN are attached hereto*).

Please be informed that this Office forwarded a Memorandum Report dated September 2, 2021 regarding the registration of TMPA to its new name TUFAI containing the Certification stating that association has same set of officers, membership and organization as per request of CBFM-PO President thru Resolution No. 11, series of 2021 of the organization.
