Sir,

Anent your letter dated August 18, 2021, endorsing the Notices of Violation and Order to Vacate for the issuance of Demolition Order for the structures constructed and maintained by Mr. Israel Gomez and Beberly Gomez and Ten Knots Development Corporation (TKDC) within the legal easement in Cadlao Island, Bgy. Buena Suerte, El Nido, Palawan which are in violation of Article 51 of the Presidential Decree 1067 and Section 20(v) of the Republic Act 11038 or the ENIPAS Act of 2018, I would like to inform your good office that this office decided to hold in obeyance the issuance of Demolition Order for the abovementioned structures.

This decision is made after receiving the letter of Ten Knots Philippines Incorporated (TKPI) dated 21 August 2021 and the letter of Angara Abello Concepcion Regala & Cruz Law Offices dated 2 September 2021. From the contexts of the aforementioned two letters, dated 21 August 2021 and 2 September 2021 respectively, the Notices of Violation and Order to Vacate and the Forest Land Use Agreement for Tourism Purposes (FLAg-T) are conflicting documents/issuances both of your department which create confusion to this office as to which of these documents shall prevail over the other. Thus, kindly clarify this concern to this office for our proper guidance.

Attached herewith are: (1) copy of the letter of Ten Knots Philippines Incorporated (TKPI) dated 21 August 2021 and (2) copy of the letter of Angara Abello Concepcion Regala & Cruz Law offices and its Annexes "A" "B" and "C" for your comments.

Dear Mayor Lim:

Greetings!

We write to you regarding our property at Cadlao Sabang covered by a Forest Land Use Agreement for Tourism Purposes (FLAg-T).

- 1. The subject parcel measures 3.206 hectares in Cadlao Sabang, between titled properties of Ten Knots.
- 2. Waiver of Rights between Armando Dajao and Ten Knots Development Corporation was executed on 27 August 1997.
- DENR PENRO issued a Special Use Permit (SUP) (Bathing Establishment) to Ten Knots
 Development Corporation covering 5.0 hectares of public forest land of said area on 6
 November 1998. Supporting documents include a SEP Clearance issued by PCSD signed by then
 PCSD Chairman Congressman Alfredo E. Abueg, Jr. on 23 September 1998.
- 4. As per DENR AO 2004-28 Section 13, the SUP may be converted to a Forest Land Use Agreement for Tourism Purposes (FLAgT) that is good for 25 years. Ten Knots availed itself of this agreement and was issued a FLAgT for said Cadlao Sabang property on 27 December 2005. Among the supporting documents to this is a PAMB endorsement signed by your good office as Vice Chairman and Presiding Officer of the PAMB.
- 5. Since 2005, Ten Knots has been paying a yearly lease rental to DENR in addition to the RPT to the Municipal Assessor. Annually and sometimes quarterly, DENR personnel visit our FLAgT areas, including that in Cadlao Sabang.
- 6. In 2017, Ten Knots discovered that titles were issued by the DENR to a certain Noel Tampe and Baberlyn Gomez, with areas overlapping with the FLAgT of Ten Knots. We are questioning the issuance of these titles. In fact, we had a technical conference with DENR in 2017 at the office of Mr. Bayani Mantubig and we await another technical conference with the current DENR officers in charge of this matter.

7. The FLAgT area of Ten Knots includes a portion of the 40-meter easement. As per Section 58 of C.A. No. 141, Section 59, DAO DENR 2004-24, DAO DENR 2004-28, the DENR may execute an agreement with an applicant to occupy, develop, utilize, and manage the foreshore lands, which includes the 40-meter easement.

We stand by our FLAgT.

The metes and bounds extend to what is included as the 40-meter easement, as presented to and surveyed by the DENR Team led by then PASU Loreto Rodriguez and Mr. Gaudencio Valdeztamon of the Office of the CENRO in 2004, and approved by the then Chief of the Forestry Resources Conservation Division Jose M. Difuntorum and the then Regional Executive Director Vicente S. Paragas.

Our existing fence delineates our FLAgT boundaries as per agreement with the DENR surveyors in 2004.

Our SUP was issued in 1998 and was converted to FLAgT in 2005. This precedes the titles issued to certain individuals in 2015, and our FLAgT should be respected by DENR. We maintained presence in the area since the transfer of rights from Mr. Dajao in 1997. There were no other occupants in the area except for Ten Knots since 1997. Ten Knots was never informed of plans to survey the area in the name of those individuals.

We hope that this clarifies matters.

Forest Land Use Agreement for Tourism Purposes No. DENR IV-MIMAROPA-12302030-0010

Dear Hon, Gacot-Lim:

We write on behalf of our client, **Ten Knots Philippines**, **Inc.** ("TKPI"), in relation to Forest Land Use Agreement for Tourism Purposes No. DENR IV-MIMAROPA-12302030-0010 ("FLAGT").

To recall, on 21 August 2021, TKPI wrote your good office regarding its FLAGT covering 3.206 hectares of forest land located at Cadlao Island, Brgy. Buena Suerte, El Nido. As mentioned in said letter, TKPI recently discovered that Noel Tampe and Baberlyn Gomez secured original certificates of title ("OCTs") which cover areas that overlap with TKPI's FLAGT. TKPI is questioning the issuance of these titles and is in the process of investigating how they obtained titles to parcels of land previously identified as forest land by the Department of Environment and Natural Resources ("DENR"), and which in fact they never occupied.

In this regard, we wish to inform you of TKPI's correspondences with the Community Environment and Natural Resources Office ("CENRO"):

- a. On 26 July 2021, the CENRO wrote TKPI to facilitate the conduct of an actual ground survey to determine the metes and bounds of the area covered by its FLAGT, pursuant to a 19 May 2021 Memorandum from the Regional Executive Director. Said survey will be conducted with the assistance of TKPI's geodetic engineer.¹
- b. On 10 August 2021, TKPI received the CENRO's 6 August 2021 Third and Final Notice of Violation and Order to Vacate ("NTV"), which was also addressed to Israel and Baberlyn Gomez.² In the NTV, the

- CENRO ordered TKPI to remove its guard house and perimeter fence which is within the 40-meter easement area.³ The easement area is covered by TKPI's FLAGT.
- c. On 17 August 2021, TKPI wrote the CENRO requesting that the actual ground survey be conducted sometime between 13 to 17 September 2021 due to the availability of its geodetic engineer.
- d. On 23 August 2021, TKPI wrote the CENRO confirming receipt of the NTV, reiterating that its occupation of the 40-meter easement area should be respected. TKPI also informed the CENRO that it is awaiting the actual ground survey pursuant to its 26 July 2021.⁴

TKPI is currently awaiting the schedule of the: (1) next technical conference with the DENR to discuss the overlap on TKPI's FLAGT and Noel Tampe's and Baberlyn Gomez' OCTs; and (2) actual ground survey to be conducted by the CENRO. These are necessary for a definitive resolution of the pending issues discussed above.

Following Department Administrative Order Nos. 2004-24 and 2004-28, the DENR may execute agreements to occupy, develop, utilize, and manage foreshore lands. Undeniably, the 3.206 hectares of forest land covered by the FLAGT includes the 40-meter easement, within which the perimeter fence and the guard house are situated. To date, TKPI remains to be in open and peaceful possession of the forest land subject of the FLAGT. Thus, TKPI respectfully reiterates its position that its FLAGT, which is valid until 31 December 2030, must be respected.

We shall continue to apprise your good office of the developments regarding this matter.

THIRD AND FINAL NOTICE OF VIOLATION AND ORDER TO VACATE

Sir.

Greetings!

This pertains to the first and second Notices to Vacate dated February 5, 2021 and May 6. 2021 respectively, issued to you by this Office pertaining to the guard house and perimeter fence constructed within the easement of Cadlao Island, Bgy. Buena Suerte, Fl Nido, Palawan. Please be reminded that constructing and maintaining the above structures violate the following laws:

Presidential Decree 1067 also known as the Water Code of the Philippines which states that:

Article 51. The banks of rivers and streams and the shores of the seas and lakes throughout their entire length and within a zone of three (3) meters in urban areas, twenty (20) meters in agricultural areas and forty (40) meters in forest areas, along their margins are subject to the easement of public use in the interest of recreation, navigation, floatage, fishing and salvage. No person shall be allowed to stay in this zone longer than what is necessary for recreation, navigation, floatage, fishing or salvage or to build structures of any kind.

2. Republic Act No. 7586 (NIPAS Act of 1992) as amended by Republic Act No. 11038 or the Expanded NIPAS Act of 2018) which states that:

Section 24(paragraph 4). Structures found within the forty (40)-meter easement shall be demotished unless proven necessary to protect the shoreline and mitigate habitat destruction. The PAMB shall levy a reasonable fee for the use of such easement for their communed operations. Wharves shall be kept accessible to the public.

In view hereof, you are hereby **ordered** to completely remove the structures you constructed inside the 40-meter easement area upon receipt of this Notice. Further, refrain from further introducing developments in the area unless otherwise with clearance from the PAMB and permits from concerned government offices.

For inquiries regarding this matter, you may visit the PAMO of ENTMRPA located along Real Street, Bgy. Masagana, Municipality of El Nido, Palawan.

We are hoping that you will immediately comply this order.
