## Rationale

Every September, we celebrate the Maritime and Archipelagic Nation Awareness Month (MANA Mo), as declared through Presidential Proclamation No. 316 s. 2017, which aims to promote maritime domain awareness.

As part of this year's celebration, a Philippine Priority Seascapes Week will be observed highlighting some of the country's priority seascapes, namely the West Philippine Sea, the Philippine Rise Marine Resource Reserve, and the Verde Island Passage.
