The Biodiversity Management Bureau, together with its partner agencies in the National Cave Committee, will be conducting the “**Learning Event on Assessment of Different Cave Values**” through a three-day webinar series. This Learning Event aims to:

1. Capacitate DENR personnel in assessing cave values such as geological, hydrological, paleontological, archaeological, and cultural;
2. Enable DENR personnel to conduct sound assessment of cave values with the use of standard assessment methods/parameters; and
3. Improve the cave assessment form based on the comments and suggestions of participants and trainers on the parameters of each cave values.

The Learning Event will be divided into three (3) sessions to be held on 23-25 June 2021. The sessions will cover topics on basic parameters included in the assessment form and assessment methods in the field of geology, hydrology, archeology/paleontology and historical/cultural studies.

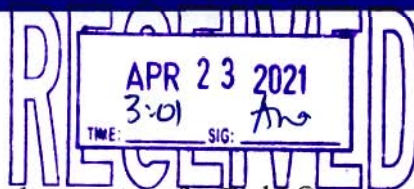
