
Respectfully forwarded is the re: above subject.


Please be informed that on April 27, 2021 at around 9:00 A.M., the MES personnel headed by Chief, Forest Protection and Enforcement Section, Forester Marces C. Lasangen apprehended one (1) unit under boat construction in Cabugan Island, Barangay I, Roxas, Palawan allegedly owned by Mr. and Mrs. Rey Lanosa. A total of 59 pieces of Apitong and Gmelina lumber and hull with equivalent volume of 659 board feet.

Furthermore, the apprehended undocumented forest products (boat under construction) were hauled to this Office for safekeeping and proper disposition in accordance with DAO 97-32.

SUBJECT : **SPOT REPORT ON THE APPREHENDED UNDER CONSTRUCTION MOTOR BOAT (BANCA) IN CABUGAN ISLAND, BARANGAY I, ROXAS, PALAWAN.**



Please be informed that on April 27, 2021 around 9:00 AM, the undersigned together with CIG Palawan and Coast Guard Station Roxas proceeded to Sitio Cabugan Island, Barangay I, Roxas, Palawan to conduct verification on the received information of alleged construction of Motor Boat (Banca) using undocumented lumbers.

Around 9:30 AM, the team arrived in the said area and conducted search on above mentioned report. In a while, the team found One (1) unit under construction motor boat (Banca) along the walkway, near the houses therein within the 40 meters water easement zone of the area.

Immediately, the team conducted investigation on the person present in the area which was Ms. Analou Lanosa. According to her, the said under construction motor boat (Banca) is owned by them. The boat hull (Casco) and lumbers being used was being procured by her and his husband (Mr. Rey Lanosa) in Roxas (no exact location and name of lumber dealer mentioned).

Ms. Lanosa didn't able to present any legal document of the boat hull (Casco) and lumbers when asked, Forester I Marces Lasangen explained to Ms. Lanosa the violation of the law she committed, narrated the Miranda rights to her and declared the apprehension of the said under construction boat (Banca).

In addition, the Purok Chairman, Mr. Eriberto Cuenca, and Barangay Tanod, Mr. Jhonny Alpasan, were present in the area and also informed on the matter to witness the same. The following are the accessories utilize in the under construction Motor Boat (Banca)

The team prepared and issued apprehension receipt to Ms. Lanosa. The said under construction motor boat (Banca) with total estimated value of Php. 31,969.55 is hauled and brought to the DENR CENRO Roxas Compound, Barangay III (Poblacion), Roxas, Palawan for safekeeping and proper disposition.

The undersigned hereby recommend that Administrative hearing must be undertaken on the violators. Speed Boat or Motor Boat must also be issued to this Office to be utilize in island patrolling, detection, surveillance and, monitoring of illegally-sourced forest product and illegal forest activities.




