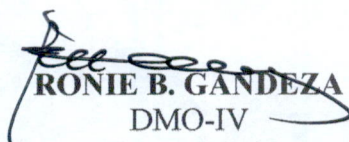

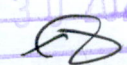
Please be informed that on April 28, 2021, at around 10:00 A.M. while conducting foot patrol at Sitio Marupic, Barangay Minara, Roxas, Palawan, the Patrol Sector II led by Forest Ranger Lemuel L. Bacalla apprehended one (1) unit power chainsaw from the possession, control and custody of Ms. Lea Avila and her two sons, both are minors. The apprehending officers were able to catch the perpetrators in the act of sawing one (1) standing Gmelina species. In addition, the perpetrators failed to present pertinent documents supporting the legality of their activity therefore they have violated Section 77 of P.D. 705 as amended and R.A. 9175, The Chainsaw Act of 2002.

Further, the apprehended equipment was deposited to this Office for safekeeping and proper disposition in accordance with DAO 97-32.

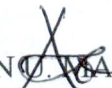
This is in connection with forest protection and foot patrol activities, please be informed that last April 28, 2021 at about 10:00 in the morning while conducting foot patrol at the vicinities of Sitio Marupic Barangay Minara, Roxas, Palawan, the undersigned with Forest Tech. I Nolly D. Billones heard a roaring sound of machine at the left side portion of Sitio Marupic, Minara, Roxas, Palawan. The undersigned immediately proceeded to the area where the sound came from and upon approaching we saw the two sons of Ms. Lea Avila (Operator and Helper) holding a Chainsaw machine or caught in the act of sawing of one (1) Gmelina species with a diameter of 35 centimeter and 10 meters length, at this instance the undersigned demanded any legal papers/permit to support their activities but they have nothing to show us.

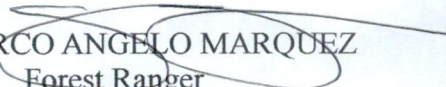
Further, it is sad to state that we were not able to apprehend said Gmelina Species due no one were take custody in the area and said apprehended power chainsaw were already turned over to the Chief, Forest Forest Protection and Law Enforcement Marces C. Lasangen for safekeeping purposes and for proper disposition.

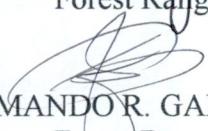

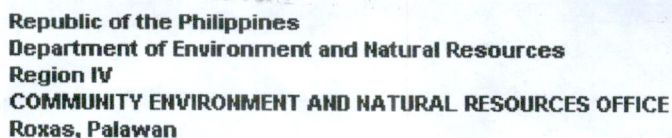

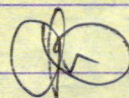
