Nang ipasok po namin ang kaso sa DENR MALA PANGHUKU- MAN ang pinaimbestiga ay bakit nagkaroon ng bagong Lot No. 569 at Lot No. 570 ang lote ni Ricardo Gomez, ng magkaroon ng panga- lawang Cad Survey Cad 1037 D EL NIDO CADASTRE. FOR imbestiga- tion ang utos. Pilit na pinaiimb- tiga ito pero walang nangyari at para malaman namin ang nangyari, kami ang nagrese- arch halos umabot ng limang taon (5 years) ang pag-uutos na mag-imbestiga pero bigo kami. Sobrang hirap ang dinanas namin Manila- Palawan vice- versa walang tumulong sa amin at ng mapagtagumpayan namin ang tunay na status ng Cad 1037 D na ito'y Ghost Cad Survey dahil ito'y walang legal at orihinal na pinagmulan, kinontrol ang Formal Hearing Investigation upang hindi namin matanggap ang Judicial Court Order.
