
Respectfully submitted herewith is the report of Planning Officer Rachel H. Appie on the results of the conducted coordination with the barangays of Salogon, Samariniana, Saraza and Amas of the Municipality of Brooke's Point, Palawan regarding the submission of project proposal for twenty million pesos (Php 20,000,000.00) support fund of the National Task Force to End Local Communist Armed Conflict (NTF-ELCAC).

As per report, the budget proposal has already been submitted to the Provincial Government of Palawan and other supporting documents were accomplished by the Provincial Planning and Development Office. However, for reference and record, copies of barangay resolutions were provided to this office. As indicated on the resolutions, only Barangay Salogon has identified Livelihood Program – Cash for Work activities amounting to Php 1,500,000.00 intended for different works and activities which will still be identified by the target communities. Per report, Brgy. Salogon might identify activities pertaining to forest rehabilitation and tree planting in NGP areas depending on the endorsement of communities therein.

Attached herewith are copies of barangay resolutions of the four (4) barangays.



This pertains to the verbal instruction thru Facebook Group Chat of Palawan Planning Officers to coordinate with the barangays of Salogon, Samariniana, Saraza and Amas of the Municipality of Brooke's Point, Palawan regarding the submission of project proposal for the 20 million pesos support fund of the National Task Force to End Local Communist Armed Conflict (NTF-ELCAC).

Per coordination with the Punong Barangays of the barangays, they have informed the undersigned that they have already submitted their proposal to the Provincial Government of Palawan. Documents supporting the proposals were all accomplished by the Provincial Government thru the Provincial Planning and Development Office therefore the only document they have on record was the barangay resolution indicating the specific activities, project title and amount intended to use the fund.

Conferring with the provided barangay resolutions, most of the activities identified by the barangays are construction of buildings and farm to market roads. Only Barangay Salogon has a proposed amount intended for Livelihood Program-Cash for Work amounting to Php 1,500,000.00. During the discussion with Punong Barangay Freddie D. Bocobo, it was informed that the specific Cash-for-Work activity is yet to determine upon consultation with the target communities but stated that some of these activities might be related to forest rehabilitation and/or tree planting activity in the NGP area which was requested for re-validation due to the reported result of the Validation Team.
