Regional SAKM Sub-Cluster Tasks

I. Regional SAKM Cluster Mission

Provide the RTF with timely and accurate regional situation assessments and analyses, to be the basis for policy and decision-making on CTG and concerns on governance, through:

- a) Collect, validate and fuse intelligence
- b) Conduct Information Operations (IO) to promote Government programs and projects
- c) Conduct Covert Influence Operations (COVIN) to counter CTG organizing
- d) Conduct counterintelligence (CI) operations against CTG infiltration of Government

II. SAKM Cluster Subgroups

1. **Socio-economic Subgroup** focuses on social and economic intelligence/concerns
 - a) Basic Services
 - b) Infrastructure and Resource Management
 - c) Livelihood and Poverty Alleviation
 - d) E-CLIP and Amnesty
2. **Peace and Security Subgroup** concentrates on peace, order and security concerns:
 - a) Sectoral Unification, Capacity Building and Empowerment
 - b) Localized Peace Engagement
 - c) Peace, Law Enforcement and Development Support
 - d) Local Government Empowerment
3. **Legal and International Concerns Subgroup** focuses on CTG's international networking as well as legal/aboveground activities:
 - a) Legal Cooperation
 - b) International Engagement
4. **Stratcom Subgroup** provides update and vital intelligence/information needed by the STRATCOM Cluster for its narratives, campaign, information operations and other efforts.
5. **Counterintelligence Subgroup** handles counterintelligence activities and requirements of all NTF-ELCAC Clusters. It helps attain strategic objectives of SAKM concerning CI, through:

- a) Gather CI on corruption, government projects to help the NTF craft people-oriented campaigns and programs;
 - b) Assist the government in delivering best services to the people;
 - c) Gather information on efforts of different groups to oust the administration and to block such campaign; and
 - d) Provide intelligence/CI support to all NTF clusters.
6. **Special Concerns Subgroup** covers concerns not addressed by other subgroups and developments, both domestic and foreign that have strategic implications on the activities of the NTF-ELCAC.
