Subject: Letter of Complaint against Mrs. Josefina Molo Marin, et al, for Violation of
Quarrying Law and Environmental Law.

Dear Sir,

1. This is to report and complain to your office the illegal activities being done by Mrs. Josefina Molo Marin and 8 of her workers, all residents of Barangay Macalas, Romblon, Romblon for illegally mining/extracting sand and gravel in commercial quantity (about 5,000 sacks already taken) inside my property at Sitio Agbay-ang, Barangay Macalas, resulting to massive destruction to my property and the environment. Mrs. Josefina Molo Marin and her workers are ignoring the Stone Markers (Mojon) planted on the boundaries by authorized surveyors. I believe, their activities are in violation of the Quarrying Law, Environmental Law and pursuant to Section 138 of the Local Government Code of 1991. The names of the 8 workers are as follows: Michael Molina, Mark Malay, Maricris Malay, Elmo Magante, John Magante, and a certain MacMac, Ann, and Anit.
2. Mrs. Josefina Molo Marin and her 8 workers had been mining on said place since third week of March 2021, one week after I went to Manila on March 16, 2021 for medical treatment. Today I am still in Manila for health reasons. Mrs. Josefina Molo Marin and her workers does not touch my property when I am present there and now that I am in Manila, they took advantage of my absence, ignoring reminders from my caretaker Mr. Jordan Rubio. Forwarded herewith are 32 pictures of the illegal quarrying.
3. In this regard, I humbly request your good office to kindly investigate on the matter and issue Cease and Desist Order to Mrs. Josefina Molo Marin and her 8 workers for quarrying with "No Permit", and impose other sanctions as found appropriate.
