- The implementing People's Organization (Campong It Mapangarapan It Palawano) together with SOC Resources must adhere to the provisions of the Expanded National Integrated Protected Area System (ENIPAS) or R.A. 11038, Wildlife Resources Protection and Conservation Act, Indigenous People's Rights Act (IPRA) and Strategic Environmental Plan (SEP) for Palawan, Ancestral Domain Management Plan (ADMP) of CAMPAL and other relevant environment policies, must abide by the rules and regulations of MMPL-PAMB and support the policies and programs of MMPL on ecosystem protection and biodiversity conservation;
- The MMPL-PAMB and Protected Area Office staff must be recognized to do quarterly monitoring activity in the area;
- The CAMPAL and SOC Resources must strictly implement and comply with the mitigating measures stipulated in the Initial Environmental Examination (IEE) Report;
- The CAMPAL and SOC Resources must secure Environmental Compliance Certificate (ECC) before implementing the project. on a sulamilar to the PANNE for a carpy. The CAMPAL together with SOC Resources must submit to the MMPL-PAMB thru the Protected Area Office
- its quarterly activity reports and plans.
- Any violation of the terms and conditions stipulated herein may mean revocation of this endorsement,
