SUBJECT : **RECONSTITUTION OF MINE REHABILITATION FUND
COMMITTEE AND MULTIPARTITE MONITORING TEAM FOR
MINING COMPANIES AND MINERAL PROCESSING PLANTS IN
PALAWAN**

The Mines and Geosciences Bureau – MIMAROPA Region is in the process of reconstituting all existing Mine Rehabilitation Fund Committee (MRFC) and Multipartite Monitoring Team (MMT) for mining companies and mineral processing plants in Palawan.

Pursuant to Section 183 of DENR Administrative Order (DAO) No. 2010 – 21, Revised Implementing Rules and Regulations of R.A. 7942, otherwise known as the *Philippine Mining Act of 1995*, the MRFC shall be composed of the following:

1. Regional Director of the Mines and Geosciences Bureau as Chairperson;
2. Regional Executive Director of the DENR as Co-Chairperson;
3. Regional Director of EMB as Member;
4. Representative from the LGU as Member;
5. Representative from the local NGO/PO/Civil Society/Church as Member; and
6. Representative of the Contractor/Permittee as Member.

On the other hand, the MMT shall serve as the monitoring arm of said Committee and shall be composed of the following in accordance with Section 185 of the same DAO:

1. Representative from the Regional Office as Head;
2. Representative from the Department Regional Office as Member;
3. Representative from the EMB Regional Office as Member;
4. Representative of the Contractor/Permit Holder as Member;
5. Representative from the affected community(ies) as Members;
6. Representative from the affected ICCs, if any, as Member; and

7. Representative from an environmental NGO.

Relative thereto, as principal member to the MRFC being the Head of DENR MIMAROPA Region, respectfully requesting for the name of your authorized alternate representative to the said Committee. Likewise, the name/s of the principal and alternate representatives of the agency to the MMT, preferably from the Community Environment and Natural Resources Office where the mining and mineral processing companies are located.
