SUBJECT : **DEFIANCE OF ORDER TO REPRESENT THE OFFICE IN THE GRAND PULONG-PULONG SET BY HON. MAYOR RONALDO M. MORADA OF BANSUD, ORIENTAL MINDORO**

This has reference to your Memorandum with regard the above subject. Please be informed that I have received the instruction from the In-Charge, Administrative Unit the day before the scheduled meeting. The instruction was not given directly to me by the OIC-CENRO because of his absence on that particular day. Based on the instruction the assembly time of said meeting was scheduled at 6:30 in the following morning and the meeting proper which is in Brgy. Malo is very far from the assembly place which is the municipal hall.

Having lived in Calapan City and has to go to the Municipality of Bansud early the next morning, I informed the In-Charge, Administrative Unit that I cannot attend to the said meeting because by that time there's no public utility vehicle travelling from Calapan City to the southern part of Mindoro as early as even 4:00 in the morning to catch up with the group. Travel time from Calapan City to Bansud may take at least two and half hours.

Another dilemma is in going back to Calapan City in the afternoon after the meeting. Because of the pandemic, public transport is limited especially when it is already late in the afternoon. Unlike you, being the OIC CENRO, you have the "authority" to use the office vehicle or ask your subordinate with his personal car to ferry you to Occidental Mindoro even during Office/working days which is already out of jurisdiction.
