In 2016, the Department of Environment and Natural Resources through the Biodiversity Management Bureau published the first edition of the Atlas of Philippine Inland Wetlands and Classified Caves. This provided various thematic and composite GIS base maps that served as tools for informed management decisions or interventions. Currently, the Bureau is spearheading its updating to reflect the newly inventoried inland wetlands and newly classified caves, as well as coastal wetlands. The Atlas is targeted for production and publication by end of June this year.

Part of its lead-off activities is the conduct of a series of Consultation-Meetings on the Enhancement of the Knowledge Management System for the Philippine Wetlands and Caves that was held on October last year to solicit relevant inputs from the DENR Regional/Field Offices. As one of the agreements reached during said activity, the Bureau will be conducting a final Consultation-Workshop for the Drafting of the 2021 Atlas on Wetlands Including Classified Caves. Said activity aims to present the consolidated forms and geospatial data from the regional submissions for review and validation.

The consultation-workshop will be online via Zoom on 28 May 2021 at 9:00 AM – 12:00 NN. May we then invite you and/or your technical representative – preferably your caves, inland wetlands, and coastal and marine focal/s, and GIS/data manager – to join us in the said consultation-workshop.
