Republic Act No. 11285, An Act Institutionalizing Energy Efficiency and Conservation, Enhancing the Efficient Use of Energy, and Granting Incentives to Energy Efficiency and Conservation Projects, otherwise known as Energy Efficiency and Conservation Act, was signed and approved on April 12, 2019.
