CONCEPT NOTE

INTERNATIONAL SYMPOSIUM ON WASTEWATER AND SEPTAGE MANAGEMENT

June 02, 2021 | 8:00 AM to 12:00 NN Via Zoom (Online) Platform

Rationale / Background

The Clean Water Act of 2004 or RA 9275 is a milestone legislation that addresses the call for an integrated, holistic, decentralized, and participatory approach to abating, preventing, and controlling water pollution.

The Department of Environment and Natural Resources (DENR) is designated as the lead government agency responsible for the implementation and enforcement of RA 9275 or the Clean Water Act (Chapter 3, Section 19). It shall issue orders against any person or entity and impose fines, penalties, and other administrative sanctions to compel compliance with water quality regulations and the provisions of this (Clean Water) Act (Chapter 3, Section 9r).

Section 28 of Chapter 5 of the CWA rules that any person who commits any of the prohibited acts or violates any of the provision of the Clean Water Act or its implementing rules and regulations shall be fined by the (DENR) Secretary, upon the recommendation of the PAB of not less than Ten thousand pesos (P10,000.00) nor more than Two hundred thousand pesos (P200,000.00) for every day of violation. The fines shall be increased by ten percent (10%) every two (2) years to compensate for inflation and maintain such fines' deterrent function. Further, the (DENR) Secretary, upon recommendation of the PAB, may order the closure, suspension of development or construction, or cessation of operations or, where appropriate disconnection of water supply, until such time that proper environmental safeguards are put in place and/or compliance with the Clean Water Act or its rules and regulations are undertaken.

Stricter provisions for fines and imprisonment are provided for in the same section (28) of the CWA for gross negligence and other violations resulting in serious injury or loss of life and/or irreversible water contamination of the surface, ground, coastal and marine water.

The Department of Interior and Local Government (DILG) in its Memorandum Circular (MC) No. 2019-62 qualifies the prohibited acts under the MC (Section 6.7) that include:

- 1. Failure of LGUs to enact Sewage Treatment and Septage Management Ordinance (SSMO)
- 2. Failure of commercial establishments to comply with the requirement of taking adequate wastewater facilities
- 3. Refusal to desludging as required by the MC
- 4. Refusal of new and existing residential customers to connect to available sewer lines. Commercial, industrial, governmental, and institutional structures/establishments have the option to construct their own full wastewater treatment facility as required by DENR or LLDA or to connect to existing available sewer line subject to the pre-treatment requirement of the sewerage service provider
- 5. Dumping of septage and untreated wastewater to drainages, canals, rivers, and other natural and artificial waterways and other open areas
- 6. Desludging and transporting of septage without the necessary permits and accreditation from the authorized permitting agencies
- 7. Hiring/availing the services of illegal/non-accredited desludger, transporter by any person or establishment to desludging septic tanks or dispose of their wastewater
- 8. Those acts prohibited by Section 27 of RA 9275 (the Philippine CWA of 2004), and
- 9. Failure to comply with Section 79 (a) and (b) of PD 856 (Code on Sanitation of the Philippines)

Failure to enforce the prescribed rules as stipulated in the DILG MC as prohibited acts carries the following penal provisions:

- 1. All local officials and/or employees who fail to implement the provisions of the MC may be held administratively liable
- 2. In the exercise of their supervisory powers, the Governors and Mayors should commence disciplinary actions against local officials who fail to carry out the mandate of the law and their responsibilities.

The Department of Health (DOH) promulgated Administrative Order (AO) No. 2019-0047 prescribing the National Standard on the Design, Construction, Operation, and Maintenance of Septic Tank Systems. The Penal Provisions adopted by the AO are those found under Section 103 of the Sanitation Code of the Philippines, which carries the punishment of imprisonment and fines determined upon the discretion of the court.

The NEDA Infrastructure Committee-approved Philippine Water Supply and Sanitation Master Plan (PWSSMP) reports that around 74% of households are connected to onsite or offsite treatment and are considered safely managed. But for these onsite treatment systems such as septic tanks to be considered safely managed, they must employ an effective septage management program. Otherwise, it shall be construed as a failure to comply with the requirements of safely managed systems. The same Master Plan designates two deadlines for meeting national targets, the Philippine Development Plan (PDP) that ends in 2022 needs to meet a 97% access to sanitation, while the target set in the

Sustainable Development Goals that are to be accounted by the end of 2030 shall meet a 100% access to sanitation.

Objectives

The International Symposium on Wastewater and Septage Management hopes to accomplish the following objectives:

- 1. To orient and provide cutting-edge information to officials and staff from EMB and other Philippine Departments on effective and efficient implementation of wastewater and septage management programs that are compliant with the provisions of the Philippine Clean Water Act of 2004.
- 2. To identify and resolve implementation issues and challenges at the local level in the context of the targets set and with the resources and guidance provided at the national, and
- 3. To plan and set commitments by EMB and other relevant government agencies participating in the symposium for organizing, assisting, and monitoring the compliance of local government agencies and sanitation service providers to the requirements of the Philippine Clean Water Act of 2004 and other relevant regulations and national programs.

Expected Outputs

The expected outputs are the following:

- 1. A firm understanding of the requirements of relevant laws, policies, and programs on wastewater and septage management
- 2. An appreciation of best practices and innovations on the implementation of wastewater and septage management programs, and
- 3. Action Plan (next steps/resolutions) to be implemented by EMB and relevant agencies following the symposium.
