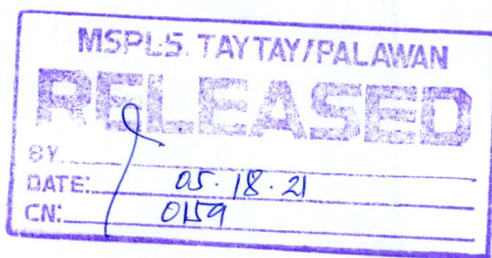
Respectfully forwarding is the memorandum dated April 27, 2021 from Forest Ranger Ricardo S. Tandoc concerning the above subject.

This report is respectfully submitted pursuant to the memorandum of the Undersecretary for Field Operations, Enforcement and Muslim Affairs dated July 01, 2020.

WHAT

This is the report of the apprehended ninety (90) pieces Apitong lumber with a total volume of two thirty (230) board feet at Barangay Liminangcong, Taytay, Palawan.

WHEN

The apprehension was done in the evening of April 23, 2021 and the report was submitted in the Office on April 28, 2021 along with geotagged photos and Tally sheet.

WHERE

The apprehension was undertaken at Barangay Liminangcong, Taytay, Palawan.

WHO

The apprehending team was composed of personnel from Forest Product Monitoring Station –VI Forest Rangers Ricardo S. Tandoc, Forest Protection Officers Richard M. Valones, Erwin C. Balvin, Noel A. Mendaza and Rocky E. Dalabajan.

The said forest product was taken and seized in violation to Section 77 of Presidential Decree 705 as amended otherwise known as Revised Forestry Code of the Philippines as stated as "Any person who shall cut, gather, collect, or remove timber or other forest product from any forest land, or timber from alienable or disposable public lands, or from private lands, without any authority, OR POSSESS TIMBER OR OTHER FOREST PRODUCTS WITHOUT THE LEGAL DOCUMENTS AS REQUIRED UNDER EXISTING FOREST LAWS AND REGULATIONS, SHALL BE PUNISHED WITH THE PENALTIES IMPOSED shall be guilty of qualified theft as defined and punished under Article 309 and 310 of the Revised Penal Code.

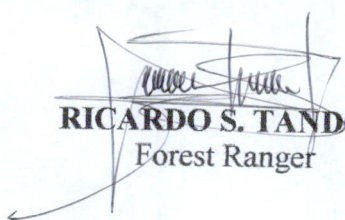
HOW

On the night of April 23, 2021, the team assigned at Ranger Station Barangay Tumbod, Taytay, Palawan received a call from concerned citizen. According to him one boat loaded of illegal sawn lumber presently navigate to Barangay Liminangcong. The team immediately conducted/responded and proceeded to the area resulting the apprehended of certain Jose Canale 61 years old and his wife Teresita Canale 57 years old with his boat white in color no name but registered in Philippine Coastguard Liminangcong with EN1-021520-18467 inside the boat are 50 pcs 1x3x12 and 40 pcs. 1x2x12 all apitong lumber. The team decided to blotter the incident at Barangay Liminangcong with Punong Barangay Lanie G. Abogado and her Barangay Secretary Lanie Tibay and informed Protected Area Superintendent Clarissa P. Pador regarding the said incident.

Please be informed that the said forest product and motorized banca was stockpiled at Protected Area Management Office (PAMO) – FPMS – VI, Barangay Old Guinlo, Taytay, Palawan.

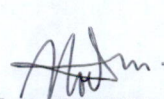
