I am looking for the Technical Description of the following lots owned by my deceased parents who died over 30 years ago.

Lot # 1073 Cad-799 owned by Maria M. Pe

Lot # 2803 Cad-299 owned by Maria M. Pe

Lot # 4933 Cad-299 owned by Teodoro L. Pe

Cenro verified these lots for me but under different Survey Listed Claimant. My parents only owned a portion of these lots and these lots are in Cuyo Palawan and Magsaysay Palawan. I was also told the lots in Cuyo are A&D, alienable and disposable. I had a brother who lived in Cuyo for 25 years but he passed away in January 2021. So, I am trying to change the title of these lots to our names as heirs of our parents but cannot find the titles for these lands.

The Magsaysay Municipal Trial Court was able to give me a Technical Description for lots 2803 and 4933 but they were so blurry and you can hardly read them. They were also listed under different names. They cannot find one for lot 1073.

Please send me the Technical Description for these lots.

Also, do you have the title number of these lots and what are their status - titled or untitled, public lands or adjudicated lands?
