RSC RESOLUTION NO. 2021-02

ENJOINING GOVERNMENT AGENCIES, LOCAL GOVERNMENT UNITS, AND THE PRIVATE SECTOR TO PROVIDE DATA SUPPORT IN THE GENERATION OF PROVINCIAL PRODUCT ACCOUNTS

WHEREAS, pursuant to Philippine Statistical Act of 2013, the Philippine Statistics Authority (PSA) is the central statistical authority of the Philippine government in primary data collection and the development of integrated social and economic statistics including the national accounts:

WHEREAS, the PSA regularly compiles the Quarterly and Annual National Accounts, the Gross Regional Domestic Product and the Gross Regional Domestic Expenditure, Income and Outlay Accounts, Input-Output Accounts, Satellite Accounts including Tourism and Health, and other relevant macroeconomic indicators;

WHEREAS, three pilot compilations of the Provincial Product Accounts (PPA) were done for the provinces of Palawan in 1998 and 2017 and Guimaras in 2006 which can serve as reference in the generation of such account;

WHEREAS, in order to better understand the performance of the economy and to ensure a more effective planning towards economic and social development, the data should be characterized further at the subregional level;

WHEREAS, to respond to local and international commitments such as the Philippine Development Plan (PDP) 2017-2022 Midterm Update and the Sustainable Development Goals (SDGs), more granular statistics is necessary;

WHEREAS, in recognition of the need to generate data on subnational accounts, the Philippine Statistical Development Program (PSDP) 2018-2023 under the Macroeconomic Accounts and Statistics Chapter includes the compilation of provincial product accounts as one of the major statistical programs;

WHEREAS, in line with the generation of PPA to provide a more appropriate measure and assessment of the progress and development of all provinces, it is imperative that the Philippine Statistical System (PSS) institutionalize the provision of data support for the generation of PPA;

WHEREAS, MIMAROPA region will serve as one of the pilot regions for the generation of the PPA along with Central Visayas and Northern Mindanao.

WHEREAS, the Regional Statistics Committee (RSC) of MIMAROPA agreed in the enjoinment of government agencies, local government units and private sectors to provide data support in the generation of PPA.

NOW, THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED, to enjoin government agencies, local government units, and the private sector to provide data support in the generation of the Provincial Product Accounts.

RSC RESOLUTION NO. 2021-01

WHEREAS, Article I of Philippine Statistics Authority (PSA) Board Resolution No. 05, s. 2015, provides for the establishment of Regional Statistics Committees (RSCs);

WHEREAS, the RSC shall serve as the policymaking body on statistical matters and shall serve as the venue for discussion and resolution of statistical issues at the local level:

WHEREAS, the functions of the RSC are to: 1) formulate statistical policies designed to resolve local statistical issues and recommend workable schemes towards improvement of local level statistical system; 2) oversee the implementation in the region of policy decisions made by the PSA Board and the adoption of the prescribed statistical standard methodologies and classification systems; and 3) institute measures to strengthen the statistical capability of the local statistical system;
