I. PRELIMINARIES

 Governor Jose R. Riano, RDC Chairperson called the meeting to order at 9:00 a.m. followed by the singing of the Philippine National Anthem and an invocation, including the singing of MIMAROPA Hymn with the launching of its new AVP.

II. BUSINESS PROPER

A. Declaration of Quorum

RDC Secretary and NEDA MIMAROPA OIC-Assistant Regional Director Bernardino A. Atienza, Jr., called the roll, acknowledged the guests, and declared a quorum. Of the 51 regular members, 35 were present and nine were represented, constituting eighty-six percent attendance. Among the 22 special non-voting members, 12 were present and seven were represented, registering 86 percent attendance.

B. Welcome Remarks and Messages

 In his opening message, RDC Chairperson and Romblon Governor Jose R. Riano welcomed and thanked all the participants for attending the meeting and commended everyone in fulfilling their roles as public servants amidst the crisis brought by the pandemic and devastating typhoons that hit the region in 2020. He expressed his appreciation to certain individuals who selflessly served the MIMAROPA region and extended his well wishes to those who will move to a new place. He also encouraged everyone to exercise their significant role in the development of the region with due diligence.

Governor Riano enumerated several major agenda to be tackled during the meeting. These were: a) Endorsement of FY 2022 Budget Proposals; b) Approval of the MIMAROPA Rehabilitation and Recovery Plan for Areas Affected by Typhoons Quinta, Rolly and Ulysses; c) Adoption of La Niña Action Plan; d) Approval of the Proposed Conduct of Regional Forum on the Full Devolution of Certain Functions of the Executive Branch to LGUs; e) Endorsement for the creation of MARINA MIMAROPA Regional Office; f) Endorsement of Marinduque Economic and Infrastructure Development Projects; g) Approval and adoption of the Guidelines on the Certification of MIMAROPA Regional Pool of Gender and Development Resource Persons (RPGRP); h) Strengthening the integration of nutrition related programs in the Annual Investment Plans of LGUs; i) Approval of CY 2021 RDC work program; j) Approval on the participation of MIMAROPA RDC-PSRs and budget for the RDC-PSRs National Convention 2021; k) Confirmation of the new RGADC Chairperson and Co-Chairperson; and l) Confirmation of RDC ExCom Resolution No. 3-37, s. 2021, Expressing sympathy to the family of the late Hon. Reynaldo V. Umali, Second District of Oriental Mindoro, and gratefully recognize his valuable contributions as member of the MIMAROPA RDC Advisory Committee.

He mentioned that the RDC Secretariat under the able guidance of Director Sumbeling launched the new music video of the region's official hymn, the "Beloved MIMAROPA". He encouraged everyone to proudly share it and let MIMAROPA Region soar higher for the world to see its wonders.

Relative to COVID 19, Governor Riano said that the DOH will report on the current situation and update on the vaccination plan, while DOST will present the featured technology of SUCs.

He added that the project monitoring report, status of RDC-endorsed projects, CY 2020 RDC accomplishment reports as well as the annual/regional economic situationer of the region will also presented to determine how the different sectors performed in 2020.

Likewise, Department of Energy (DOE) Undersecretary Alexander S. Lopez represented MIMAROPA Cabinet Officer for Regional Development and Security and DOE Secretary Alfonso G. Cusi. USec. Lopez read Secretary Cusi's message commending MIMAROPA for doing great despite the challenges and setbacks in 2020. He appreciated the initiative of the MIMAROPA RDC in considering the Social Development Goals 2030, Ambisyon Natin 2040, and the Philippine Development Plan 2017-2022 in the formulation of plans to be implemented in the region.

Moreover, Presidential Adviser for Southern Tagalog Secretary Casimiro M. Ynares, Jr. emphasized the need for proposals that will fast-track infrastructures and increase economic performance of the region. He also expressed his support to the endeavors of the MIMAROPA RDC together with the President towards development of all the regions in the country.

C. Awarding of Plaque of Recognition

The MIMAROPA RDC awarded plaque of recognition to retired ARD Rodrigo M. Marquez of DBM MIMAROPA. The plaque of appreciation was awarded to BGen Antonio R. Lastimosa, SOLCOM, Dir. Zoraida O. Macadindang, DAR, Dir. Gamaliel B. Vicente, Jr., TESDA, and Dir. Lolito R. Tacardon, POPCOM who were all transferred to other regions. The outgoing RGADC Chairperson and Co-Chairperson, Dir. Purificacion R. Arriola, DSWD and Dr. Elsa P. Manarpaac, WPU, respectively, were also given plague of appreciation.

Meanwhile, NEDA Regional Director and RDC Vice Chairperson Sumbeling greeted the RDC members who celebrated their birthdays during the first quarter of the year.

RDC Chairperson Riano requested the RDC Vice Chairperson Sumbeling to preside over the meeting due to equally important activities to attend to.

D. Proposed Agenda

Director Sumbeling presented the proposed agenda. On motion duly seconded, the proposed agenda was approved with the request that DOH-MIMAROPA will present first the COVID-19 situationer and updates on the vaccination plan for the MIMAROPA region.

E. Approval of the Minutes of the 73rd RDC Full Council Meeting

RD Christopher V. Morales of DOT requested to dispense the reading of the minutes of the previous RDC meeting since it was already circulated to all the members one week before the meeting. On motion duly seconded, the minutes of the previous RDC meeting were approved. The members were encouraged to submit to the RDC secretariat their comments on the minutes of the meeting within five (5) working days.

Dir. Ma. Josefina P. Abilay of DOST-MIMAROPA submitted to the secretariat the following comments on the minutes of the previous meeting: a) On Page 17, Line 864, the word "GRDP" should be replaced with "GDP", and b) On Page 17, Line 866, the word "regional" should be replaced with "country's".

F. Matters Arising from the Minutes of Previous Meeting

RDC Secretary Atienza referred the members to the reference folder of the RDC and reported the status of RDC instructions and resolutions passed during the previous meeting.

With regard to the clarification on the 2019 GRDP/GRDE report, Dir. Leni R. Rioflorido of PSA MIMAROPA discussed the three (3) issues and concerns raised during the previous meeting, such as: 1) why the agriculture sector has the lowest share in GRDP despite the region is predominantly agriculture and high in volume of production in some major crops? Director Rioflorido explained that the GRDP has three (3) major economic sections: a) agriculture, forestry, and fishing (AFF) that has no sub-industries; b) industry that includes four sub-industries; and c) services that includes 11 sub-industries. She said that AFF has no sub-industries and stands on its own, thus the reason why the AFF has the lowest share in 2019 GRDP. However, AFF on its own contributed ₽70 billion to the 2019 GRDP which is higher than the contribution of any sub-industries of the two remaining major economic sections. She added that no region in the Philippines is predominantly agriculture. Sixteen regions, including MIMAROPA are predominantly service-based and only CALABARZON region is predominantly industrial; 2) on the query to the submission of data from regional line agencies (RLAs) and local government units (LGUs), Director Rioflorido responded that 100% data submitted by the RLAs and LGUs were considered in the GRDP estimation. Among the regions in the country, MIMAROPA region has the most number of data submitted that comes from the LGUs. She added that other sources of data in the GRDP estimation does not only come from the RLAs and LGUs but also from the difference sources such as, Annual Survey of the Philippine Business and Industry (ASPBI), Quarterly Survey of Philippine Business and Industry (QSPBI), Quarterly Agricultural Statistics Survey, 2018 Family Income and Expenditure Survey, etc.; and 3) on the share and ranking of MIMAROPA region in GRDP and growth rate, she further said that MIMAROPA Region has a total of 2.0% share in the GDP of the country and ranked 13 in terms of percent share among the regions. Among the 17 regions in the country, SOCCSKSARGEN recorded the lowest with 3.5 percent growth rate, followed by MIMAROPA region with 3.9 percent growth rate.

RD Mario S. Baquilod of DOH MIMAROPA presented the COVID-19 Surveillance Updates. He reported that as of March 3, 2021, MIMAROPA has recorded a total of 2,662 cumulative number of COVID-19 cases with only 43 total active cases that are broken down into the following provincial tallies: 20 in Oriental Mindoro, 2 in Palawan, 4 in Marinduque, 8 in Romblon, 2 in Puerto Princesa City, and 7 in Occidental Mindoro.

Out of the 2,662 cumulative number of cases, 2,131 (or 80%) are local, and 531 (or 20%) are imported, 2,553 (or 96%) have recovered, and 61 (or 2%) died due to COVID-19.

As to the status of laboratory, equipment and beds utilization for COVID-19 in the region, Director Baquilod reported the following: 1) of the total 29,508 individual tested for COVID-19, 2,131 turned positive for local cases (ROF and APOR) with 10.5% positivity rate; 2) out of the 31 total ICU beds, 28 beds are still available; 3) out of the 420 total isolation beds, 56 beds are occupied; 4) out of the 140 total ward beds, 4 are occupied; 5) out of the 42 total ventilator beds, 41 beds are still available; and 6) 50% of the total beds for the non-COVID patients are already occupied.

Governor Dolor asked on the availability of cartridges from DOH. He said that the shortage of cartridges contributed to the rapid increase of new cases in Oriental Mindoro. RD Baquilod responded that there's a procurement issue in the DOH Central Office, but he assured the Governor that the supply of cartridges will be available on the second quarter of CY 2021. He added that they are also looking at re-allocating other laboratories for the supply of cartridges to be given to the Oriental Mindoro Provincial Hospital (OMPH).

Dr. Mathew Medrano, Deputy Incident Commander of CHD Vaccination Operations Center of DOH MIMAROPA provided the status of roll-out vaccination program in the region. He informed the body that the Philippine Food and Drug Administration (FDA) grant its emergency use authorization (EUA) of Pfizer-BioNTech on January 14, 2021 and AstraZeneca-Oxford on January 28, 2021. This was recommended by the National Immunization Technical Advisory Group (NITAG) to adopt the prioritization framework for the COVID-19 vaccines and subsequently adopted by the IATF. On February 21, 2021, the EUA of Sinovac-Coronavac was also given. The NITAG recommended upon further review the use of Sinovac for health care workers and adopted by the IATF. He added that Sinovac vaccines is expected to arrive within the day in the provinces of Marinduque, Occidental Mindoro, Oriental Mindoro, Romblon, Palawan and Puerto Princesa City. He also shared a short video presentation on how the vaccines arrived in Marinduque Airport and Occidental Mindoro. The vaccines were directly delivered to the Provincial Health Offices (PHOs) for proper cold storage and distributed to the vaccination posts.

G. Matters for Approval/Endorsement/Confirmation

• FY 2019-2020 Agency Budget Implementation and FY 2022 RDC Budget Review

The RDC sectoral committees, during a special meeting held last January 12-15, reviewed the FY 2022 proposed programs, activities, and projects (PAPs) of the regional line agencies (RLAs), state universities and colleges (SUCs), and government-owned and controlled corporations (GOCCs). The budget review and consultation ensured that the proposed PAPs are consistent with the regional development investment program (RDIP) and supportive of the development thrusts and priorities of the current administration and the region.

The proposed FY 2022 PAPs of the agencies considered the following concerns of the region: (a) establishment of a regional office in the designated regional government center; (b) PAPs for the Balik Probinsya, Bagong Pag-asa Program (BP2); (c) PAPs to end local communist armed conflict (ELCAC); and (d) devolved PAPs or functions under the Local Government Code in relation to the implementation of Supreme Court ruling on the Mandanas-Garcia case.

The summary of FY 2022 budget proposals, report on FYs 2019 and 2020 budget utilization rates, and the status of FY 2021 RDC endorsed budgets of the member agencies of the development administration, economic development, infrastructure development, and social development committees were be presented by their respective committee chairpersons.

The Development Administration Committee (DAC) Chairperson, PSR Darius M. Guerrero, presented the budget utilization rates and the status of RDC endorsed FY 2021 budgets of the following MIMAROPA regional agencies: 2nd Infantry Division, DBM, DILG, DOLE, NAPOLCOM, NEDA, PDEA, PIA, PNP, PSA, and WESCOM. He said for FY 2021 the DAC member agencies endorsed a total of 239 priority PAPs amounting to ₱1.78 billion. Out of the 239 PAPs, a total of 81 PAPs were considered in FY 2021 GAA.

PSR Guerrero reported that the DAC during the FY 2022 budget review and consultation held last January 12 reviewed the ongoing and proposed priority PAPs of its member agencies and recommended RDC endorsement of the FY 2022 budget proposals of the following: 2nd Infantry Division with 20 proposed PAPs amounting to ₱43.2 million, DBM with eight proposed PAPs amounting to ₱33.3 million, DILG with 28 proposed PAPs amounting to ₱201.9 million, DOLE with 14 proposed PAPs amounting to ₱114.6 million, NAPOLCOM with five proposed PAPs amounting to ₱9.2 million, NEDA with 11 proposed PAPs amounting to ₱6.8 million, NICA with eight proposed PAPs amounting to ₱5.8 million, PDEA with 26 proposed PAPs

amounting to ₱45.5 million, PIA with seven proposed PAPs amounting to ₱42.9 million, PNP with 157 proposed PAPs amounting to ₱971.6 million, PSA with 26 proposed PAPs amounting to ₱40.8 million, and WESCOM with 25 proposed PAPs amounting to ₱2.9 million. In summary, the DAC recommended RDC endorsement of a total of 335 proposed PAPs amounting to ₱1.52 billion.

On a motion duly seconded, the RDC endorsed the budget proposals of DAC member agencies to their respective agency central offices (ACOs) for inclusion in the FY 2022 agency budget proposals.

For the economic sector, the EDC Chairperson PSR Rodne R. Galicha presented the budget utilization rates for FYs 2019-2020, the status of RDC endorsed budget proposals, the percentage of RDC endorsed projects included in the GAA, and the share to the national agency budgets of the following MIMAROPA regional agencies: BFAR, CDA, DA, DAR, DENR, DOST, DOT, DTI, EMB, MGB, PCA and PCSD.

PSR Galicha said that for 2019, BFAR and DOT reported 100% budget utilization rate; DA with 99.62% and DOST with 99.87%. For 2020, DOST reported 100% budget utilization, while BFAR almost achieved 100% budget utilization rate, which is slightly lower than the 2019 budget utilization rate. He further cited that BFAR, DA, and DENR recorded decreases in budget utilization rates while DAR and DOST have improved its utilization.

For the status of RDC endorsed projects included in the GAA, PSR Galicha mentioned that the batting average in terms of number of PAPs ranges from 24.13% to 100% and in terms of amount ranges from 10.26% to 64.08%. He added that the share of the economic sector agencies budgets to their national agency budgets ranges from 1.32 percent to 4.53 percent. This was relatively higher compared to last year's share in the FY 2020 GAA.

PSR Galicha reported that during the budget review and consultation held last January 13, the EDC recommended RDC endorsement of the FY 2022 budget proposals of economic sector agencies subject to modifications based on the comments of the Committee. The following were the revised FY 2022 budget proposals of economic sector agencies under Tier 1 and Tier 2 duly signed by their respective head of agency on set deadline: BFAR with 30 proposed PAPs amounting to ₱861 million, CDA with 19 proposed PAPs amounting to ₱34 million, DA with 78 proposed PAPs amounting to ₱8.5 billion, DAR with eight proposed PAPs amounting to ₱86 million, DENR with five proposed PAPs amounting to over ₱1.4 billion, DOST with 15 proposed PAPs amounting to ₱185 million, DOT with 12 proposed PAPs amounting to ₱70 million, DTI with seven proposed PAPs amounting to ₱138 million, EMB with 12 proposed PAPs amounting to ₱130 million, MGB with six proposed PAPs amounting to ₱46 million, PCA with 12 proposed PAPs amounting to more than ₱357 million, and PCSD with five proposed PAPs amounting to ₱366 million. In summary the EDC recommended RDC endorsement of a total of 209 proposed PAPs amounting to ₱2,243,420 billion.

RD Joel B. Valera of DTI raised his concern that the implementation of the Supreme Court ruling on the Mandanas-Garcia petitions in 2022 will greatly affect their agency's budget and activities specifically their provincial offices.

Marinduque Governor Presbitero J. Velasco, Jr. clarified on the position of the local government units (LGUs) relative to the devolution of functions. He said that the devolution should be gradual to consider the readiness of the LGUs to handle certain responsibilities. He suggested an in-depth study, analysis, and scrutiny of the pros and cons of the implementation

of Mandanas-Garcia Case Ruling. RD Valera expressed his desire to get Governor Velasco as speaker in their Office on the Mandanas-Garcia case ruling.

Director Sumbeling shared that at the RDC secretariat level, a proposed research study on the readiness of the MIMAROPA LGUs is being crafted. She added that a regional forum on the full devolution of certain functions of the Executive Departments of the National Government to the Local Government Units will be conducted, and DBM will also review the agencies' proposal in view of the Mandanas-Garcia case ruling.

On a motion duly seconded, the RDC endorsed the budget proposals of EDC member agencies to their respective agency central offices (ACOs) for inclusion in the FY 2022 agency budget proposals.

For the infrastructure sector, the IDC Co-Chairperson PSR Delfin M. Natal, Jr. presented the budget utilization rates and the status of RDC endorsed FY 2021 budgets of the following agencies in MIMAROPA: DOTr, DPWH, LTO, NIA, NTC, LWUA, MARINA 4, NEA, PCG Palawan, and PCG Southern Tagalog. He said for FY 2021 the IDC member agencies endorsed a total of 127 PAPs amounting to ₱117 billion. Out of the 127 PAPs, a total of 43 PAPs amounting to ₱21 billion were considered in FY 2021 GAA. He further cited that the share of the infrastructure development sector agencies budget to their national agency budget ranges from 0 percent to 3.129 percent.

 PSR Natal reported that during the budget review and consultation held last January 14, the IDC recommended RDC endorsement of the FY 2022 budget proposals of infrastructure sector agencies subject to modifications based on the comments of the Committee. The following were the revised FY 2022 budget proposals of infrastructure sector agencies under Tier 1 and Tier 2 duly signed by their respective head of agency on set deadline: DOTr proposed 17 PAPs amounting to ₱2.398 billion, DPWH proposed 23 PAPs amounting to ₱185 million, LTO proposed eight PAPs amounting to ₱90.95 million, NIA proposed 17 PAPs amounting to ₱3.244 billion, LWUA proposed four PAPs amounting to over ₱1.283 billion, NTC proposed eight PAPs amounting to over ₱35.011 million, CGD Palawan proposed eight PAPs amounting to ₱86.815 million, and CGD Southern Tagalog proposed nine PAPs amounting to over ₱80 million. In summary, the IDC recommended RDC endorsement of a total of 115 proposed PAPs amounting to ₱9.525 billion.

NPC and DICT Luzon Cluster 3, who were not able to present their FY 2022 budget proposal during the IDC meeting were requested to present during the meeting. Ms. Carmela Valencia of DICT Luzon Cluster 3, proposed seven PAPs amounting to ₱1.362 billion, while NPC representative, Mr. Roger Lived proposed 14 PAPs amounting to ₱757 million.

On the DICT's proposal, RD Ma. Josefina P. Abilay of DOST raised her concern on reliable internet connectivity of the region. DICT representative responded that the internet connectivity depends on the TELCO's service providers. However, she said that DICT's initiative is to intensify the implementation of Free-Wifi for all projects in the region. Director Abilay requested the DICT to provide the body a concrete plan of what will be the real status of internet connectivity of the MIMAROPA region by the end of 2021. Director Sumbeling requested the DICT to present the roadmap of the region's internet connectivity for FY 2022 in the next RDC meeting.

Governor Velasco requested DICT to provide Tech4ED (Technology for Education, to gain Employment, train Entrepreneurs towards Economic Development) digital transformation center for the province of Marinduque. DICT responded that they don't have an office space in Marinduque to accommodate the request of the Governor. Governor Velasco said that there

is already a designated lot for the digital transformation center in Marinduque. He assured that the needed office space will be provided to DICT. Director Sumbeling suggested that the land acquisition for the digital transformation center of Marinduque and establishment of regional office should be included in the revised FY 2022 budget proposal of DICT.

PSR Oscar Ricaflanca raised his concern on telco service provider's poor internet connection. Director Sumbeling requested PSR Ricaflanca to write a formal letter of complaint to DICT and provide them with the details for their appropriate action.

Director Valera raised his concern on the upgrading of internet account from personal to corporate. DICT representative said that the concern of Director Valera will be referred directly to TELCOs Main Office. With regards to application, she added that TELCOs have designated personnel in every province of the region who will handle the account of the applicants. Director Sumbeling said that the primary concern is how to increase the bandwidth and address the problem on poor internet connection to be able to accommodate all the government offices in the MIMAROPA region. DICT representative responded that it is really the concern of TELCOs. She shared that the provinces of Palawan and Oriental Mindoro already have the internet fiber connection which is the best option for fast and reliable internet connectivity.

On the inquiry of MinSCAT on the withholding of free-WiFi installation in their main campus, DICT representative said that they will look into the concern of MinSCAT, the soonest. With more questions being directed to DICT, Director Sumbeling requested the members to submit to the secretariat all the issues and concerns and requested the DICT to answer all the queries in the next RDC meeting.

PSR Galicha also raised his concern on the environmental impact of DPWH projects especially on the coastal areas of San Fernando, Romblon. He said that his relatives were greatly affected by the extraction of sand in the area. RD Yolanda L. Tangco of DPWH responded that they will act immediately on the concern of PSR Galicha. She will write and instruct the District Engineer of Romblon to apprise her office on the status of the project and updates will be provided to PSR Galicha as soon as possible.

Gov. Humerlito A. Dolor of Oriental Mindoro inquired from DPWH if the embankment and perimeter fencing of the proposed Regional Government Center (RGC) will be funded. He said that there are national government agencies (NGAs) requesting a space for the establishment of offices in Calapan City and the funds are already available for the construction of office building. However, the provincial government cannot respond given that the site is under usufruct agreement with the RDC. He added that if the RGC will not be funded, he will write to the RDC to seek possible actions to be undertaken regarding the utilization of the property. DPWH Director Tangco explained that they have been requesting funds for the embankment and perimeter fencing of the proposed RGC site amounting to ₱60 million since 2019. However, the requests were not included in the annual national expenditure program (NEP).

On the NPC's proposal, USec Lopez suggested to come up with one energy plan/project to interconnect each province of the region. The NPC representative responded that the provinces of Oriental Mindoro and Occidental Mindoro already has the transmission interconnection project. Moreover, Governor Velasco asked if their power barge will be returned to Marinduque. The NPC representative said that the power barge is still being used in Bataan and will send it back to Marinduque after its operation.

On a motion duly seconded, the RDC endorsed the budget proposals of IDC member agencies to their respective agency central offices (ACOs) for inclusion in the FY 2022 agency budget proposals.

For the social sector, the SDC Chairperson PSR Marvi R. Trudeau presented the budget utilization rates for FYs 2019-2020, the status of RDC endorsed budget proposals, the percentage of RDC endorsed projects included in the GAA, and the share to the national agency budgets of the following offices in MIMAROPA: DSWD, DOH, DepEd, CHED, POPCOM, TESDA, NNC, NCIP, NCCA, MSC, OMSC, MinSCAT, PSU, RSU, and WPU.

 PSR Trudeau said that for 2019, CHED and TESDA reported 100% budget utilization rate; ten agencies of the social sector achieved above 90% utilization rate; while DepEd, MSC and RSU achieved below 90% utilization rate. For 2020, she further cited that CHED and TESDA still achieved 100 budget utilization rate; only seven agencies achieved more than 90% utilization rate; and six agencies achieve below 90% utilization rate. She added that all agencies recorded decrease in the budget utilization rate except CHED, TESDA, NNC, MSC, and OMSC.

 For the status of RDC endorsed projects included in the GAA, PSR Trudeau said that the percentage in terms of number of PAPs ranges from 4.96% to 100%. DSWD recorded the highest percentage in terms of the number of PAPs and the amount included in the FY 2021 GAA with 78.57% and 88.94% respectively. In summary, the share of the social sector agencies budget to their national agency budgets ranges from 0.03 percent to 3.9 percent.

PSR Trudeau reported that during the budget review and consultation held last January 15, the SDC recommended RDC endorsement of the FY 2022 budget proposals of social sector agencies subject to modifications based on the comments of the Committee. The following were the revised FY 2022 budget proposals of social sector agencies under Tier 1 and Tier 2 duly signed by their respective head of agency on set deadline: DSWD with 15 proposed PAPs amounting to ₱8.03 billion, DOH with 148 proposed PAPs amounting to ₱1.86 billion, DepEd with 14 proposed PAPs amounting to ₱5.23 billion, CHED with three proposed amounting to ₱89.92 million, POPCOM with seven proposed PAPs amounting to ₱95.36 million, TESDA with 112 proposed PAPs amounting to ₱592.26 million, NNC with 20 proposed PAPs amounting to ₱41.77 million, NCIP with 11 proposed PAPs amounting to ₱152.16 million, NCCA with two proposed PAPs amounting to ₱1.4 million, MSC with 12 proposed PAPs amounting to ₱509.52 million, OMSC with 37 proposed PAPs amounting to ₱399.37 MinSCAT with 25 proposed PAPs amounting to ₱387.68 million, RSU with 15 proposed PAPs amounting to ₱635 million, WPU with 16 proposed PAPs amounting to ₱526.22 million, and DHSUD with ten proposed PAPs amounting to ₱67.015 million. In summary the SDC recommended RDC endorsement of a total of 471 proposed PAPs amounting to ₱19.11 billion.

Governor Dolor requested for the inclusion of three PAPs in the proposals of DOH and DepEd. These were: a) Improvement of District Hospital in Roxas; b) Improvement of Oriental Mindoro District Hospital; and c) Construction of 3-storey school building in Puerto Galera Central School. The additional PAPs were all concurred by DOH and DepEd and will be submitted by the Office of the Governor on Monday (March 8).

On a motion duly seconded, the RDC endorsed the budget proposals of SDC member agencies to their respective agency central offices (ACOs) for inclusion in the FY 2022 agency budget proposals.

• Creation of MARINA MIMAROPA Regional Office

Dir. Emmanuel B. Carpio of MARINA 4 presented the proposed creation of MARINA MIMAROPA regional office. Maritime Industry Authority (MARINA) is a government agency mandated to lead a progressive maritime administration for safer people, safer ships, and cleaner environment. He said that the proposed separation of MARINA Regional Office IV into MARINA Regional Office IV-A and MARINA MIMAROPA Regional Office is vital for a more focused maritime administration of the island provinces of the MIMAROPA region. He further cited that MARINA MIMAROPA will have jurisdiction over the regulation and rationalization of the organizational management, ownership and operations of all water transport utilities and other maritime enterprises in the region covering more than 6,428 kilometers of coastline in about 2,000 islands.

 Director Carpio added that MARINA MIMAROPA's jurisdiction will also cover the operation in 37 ports (two base ports; 14 terminal ports; 13 other government ports; and 8 private ports) supervised and monitored by their field offices in the four Port Management Offices (PMOs) of the Philippine Ports Authority;

During the 1st quarter RDC Full Council meeting held on March 4, 2016 in Oriental Mindoro, the MIMAROPA RDC endorsed the creation of a separate MARINA Regional Office for the MIMAROPA Region through Resolution No 2016-054-505. However, the proposal was not favorably acted upon by MARINA Central Office which prompted the MARINA Regional Office IV to again request for the endorsement of their proposal for the creation of MARINA MIMAROPA Regional Office with corresponding organizational structure and budget.

Director Carpio said that the proposed creation of MARINA MIMAROPA Regional Office has a corresponding organizational structure, personnel services, MOOE, capital outlay, and a proposed budget for FY 2022 of ₱65,608,545.84.

The Infrastructure Development Committee (IDC) during its first quarter meeting held on February 5 reviewed and favorably recommended RDC endorsement of the proposal to MARINA Central Office, Department of Transportation (DOTr), and the Department of Budget and Management (DBM).

On a motion duly seconded the endorsement of the proposed creation of MARINA MIMAROPA regional office was approved.

MIMAROPA Rehabilitation and Recovery Plan (RRP) for Areas Affected by Typhoons Quinta, Rolly and Ulysses

The DAC Chairperson PSR Darius M. Guerrero presented the MIMAROPA RRP for Areas Affected by Typhoons Quinta, Rolly and Ulysses. The MIMAROPA RRP for Areas Affected by Typhoons Quinta, Rolly, and Ulysses will serve as guide for the restoration of livelihood and living conditions, rehabilitation and improvement of facilities, and organizational capacities of affected communities, with reduced disaster risk in accordance to "building back better" principle. PSR Guerrero said that the assessment reports and rehabilitation and recovery programs for typhoons Quinta, Rolly, and Ulysses submitted by different agencies were validated during the blended/modified PDNA workshops held virtually on January 14, 15, and 18, 2021. He added that the recent typhoons affected a total of 101,722 households or 413,821 individuals and left an estimated ₱4,186,529,276.70 worth of damages and ₱5,658,049,882.73 worth of losses.

 PSR Guerrero reported that the MIMAROPA Regional Disaster Risk Reduction and Management Council (RDRRMC), during its special meeting held on January 19 through video conferencing, passed a Resolution No. 001, s. 2021 endorsing to the NDRRMC the results of the PDNA conducted for the MIMAROPA Region on the aftermath of Typhoons Quinta, Rolly, and Ulysses 2020 requesting funds thereof in the amount of ₱9,403,527,130.51.

The MIMAROPA RDRRMC, during its first quarter meeting held on January 26 through video conferencing, passed a Resolution No. 002, s. 2021 approving and adopting the MIMAROPA Rehabilitation and Recovery Plan for Areas Affected by Typhoons Quinta, Rolly, and Ulysses in 2020. The proposed programs, projects, and activities for the implementation of the MIMAROPA RRP for Areas Affected by typhoons Quinta, Rolly, and Ulysses in the region is amounting to ₱11,978,560,641.27.

On a motion duly seconded, the MIMAROPA Rehabilitation and Recovery Plan (RRP) for Areas Affected by Typhoons Quinta, Rolly, and Ulysses was approved.

• MIMAROPA La Niña Action Plan

ARD Vicente B. Tuddao, Jr. of DENR MIMAROPA presented the MIMAROPA La Niña Action Plan. The Philippine Atmospheric, Geophysical and Astronomical Services Administration (PAGASA) forecasted a weak to moderate La Niña until the first quarter of 2021. He said that the PAGASA rainfall forecast from January to March 2021 suggests that most parts of the country will likely receive near to above normal rainfall. As a mitigating measure, he further cited that the technical working group (TWG) on Water Resources Management led by DENR MIMAROPA initiated the conduct of an action planning workshop for the formulation of MIMAROPA La Niña Action Plan on December 16, 2020 via online video conference. The workshop aimed to formulate a La Niña Action Plan which will lay down the priority strategies and interventions to mitigate the impact of La Niña in MIMAROPA region.

ARD Tuddao reported that during the first quarter EDC meeting held on February 04, 2021, the draft La Niña action plan which contains the programs, activities, and projects was presented. Because of its cross sectoral concerns, the EDC likewise requested the DENR MIMAROPA to present the action plan to the Council for adoption.

The RDC recognized the need for the MIMAROPA region to adopt the La Niña Action Plan and ensure its immediate implementation to address the disaster risks especially for identified areas in the region that are highly vulnerable and susceptible to flooding, storm surges, and other hydro meteorological hazards.

On a motion duly seconded, the MIMAROPA La Niña Action Plan was approved and adopted.

• Conduct of Regional Forum on the Full Devolution of Certain Functions of the Executive Departments of the National Government to the Local Government Units.

The EDC Chairperson, PSR Rodne R. Galicha presented the proposed conduct of regional forum on the full devolution of certain functions of the executive departments of the national government to the local government units. He said that the DBM MIMAROPA during the RDC FY 2022 budget review and consultation held on January 12 to 15 discussed the Supreme Court (SC) decision on Mandanas-Garcia case and the salient features of the draft Executive Order (EO) on the full devolution of certain functions of the executive branch to local governments units (LGUs). The Mandanas-Garcia case ruling clarified that the internal revenue allotment (IRA) share of LGUs must be computed and sourced from

all national taxes collected and not just from the national internal revenue taxes. He further cited that the SC ruling is expected to be implemented in 2022 and the significant increase in the share of the LGUs from national taxes presents an opportunity to handover to LGUs the remaining functions and services that have been devolved under Section 17 of the Local Government Code.

PSR Galicha reported that the EDC, during its January 13 meeting raised several comments and recommendations on the draft executive order such as the readiness of the local governments in the implementation of the full devolution of certain functions of the executive departments to local governments, among others. The EDC also agreed to solicit the comments of other sectoral committees of the RDC and provide the DBM on consolidated comments for consideration in the finalization of the draft EO.

PSR Galicha shared that the EDC during the abovementioned meeting proposed the conduct of a forum on the full devolution of functions of the executive departments of the national government to local governments for approval of the RDC. The forum shall also serve as an orientation to appraise the MIMAROPA stakeholders on the salient features of the EO upon the issuance of the signed Executive Order.

The RDC recognizes the importance of the orientation on such new policy as it will provide guidance and avenue to address issues and concerns relative to the implementation of the Supreme Court ruling on Mandanas-Garcia case.

On a motion duly seconded, the conduct of regional forum on the full devolution of certain functions of the executive departments of the national government to the local government units was approved.

Director Sumbeling clarified that the regional forum will be conducted upon the release of the signed Executive Order.

• Marinduque Economic Development Projects

 The EDC Chairperson PSR Rodne R. Galicha presented the two (2) proposed economic development projects of the Provincial Government of Marinduque such as 1) Construction of Lapote-Mangyan-Mababad Farm-to-Market Road (FMR) in Mogpog, Marinduque for inclusion in the FY 2022 Budget of DA; and 2) Construction of Lapote-Candahon-Bintakay Farm-to-Market Road (FMR) in Mogpog, Marinduque for inclusion in the FY 2022 budget of DA.

1) Construction of Lapote-Mangyan-Mababad Farm-to-Market Road (FMR)

PSR Galicha reported that the Provincial Government of Marinduque proposed the construction of Lapote-Mangyan-Mababad FMR at Barangays Sumangga and Mangyan-Mababad, Mogpog, Marinduque. The proposed construction connects the major arterial road of Marinduque Circumferential Road and Sitio Lapote of Barangay Sumangga to Barangay Mangyan-Mababad. It has a total length of 1.8 kilometers amounting to ₱21 million which is proposed for funding by the Department of Agriculture (DA) MIMAROPA. The project aims to: 1) improve the linkages among national and barangay road network which leads to trading/growth centers and public markets; 2) reduce cost of production and transporting of agricultural products, and 3) strengthen people access to social and economic services and other infrastructure facilities.

PSR Galicha said that the EDC during its first quarter meeting held on February 04 reviewed and found that the project is compliant with the documentary requirements of the RDC and is aligned with the MIMAROPA Regional Development Plan (RDP) 2017-2022 specifically on Chapter 8 (Expanding Economic Opportunities in Agriculture, Forestry, and Fisheries) and Chapter 19 (Accelerating Infrastructure Development). He added that due to the nature of the project as part of the devolved functions to the local government units per the Mandanas-Garcia case ruling, the DA MIMAROPA conditionally concurred the inclusion of the project in their agency investment program. The EDC likewise favorably recommended RDC endorsement of the proposed project for inclusion in the FY 2022 agency budget subject to compliance with the requirements of DA MIMAROPA.

On a motion duly seconded, the Lapote-Mangyan-Mababad Farm-to-Market Road (FMR) in Mogpog, Marinduque was favorably endorsed for inclusion in the FY 2022 budget proposal of DA MIMAROPA.

2) Construction of Lapote-Candahon-Bintakay Farm-to-Market Road (FMR)

PSR Galicha stated that the proposed construction of Lapote-Candahon-Binatakay FMR connects the three major arterial roads: Marinduque Circumferential Road, Duongan-Bintakay Provincial Road, and Mogpog-Poblacion-Candahon Road. It has a total length of 3.0 kilometers amounting to ₱35 million which is proposed for funding by DA MIMAROPA. The project aims to: 1) improve the linkages among national, provincial, and barangay road network which leads to trading/growth centers and public markets; 2) reduce cost of production and transporting of agricultural products, and 3) strengthen people access to social and economic services and other infrastructure facilities.

He mentioned that the EDC during its first quarter meeting held on February 04 reviewed and found that the project is compliant with the documentary requirements of the RDC and is aligned with the MIMAROPA RDP 2017-2022 specifically on Chapter 8 (Expanding Economic Opportunities in Agriculture, Forestry, and Fisheries) and Chapter 19 (Accelerating Infrastructure Development). He added that due to the nature of the project as part of the devolved functions to the local government units per the Mandanas-Garcia case ruling, DA MIMAROPA conditionally concurred the inclusion of the project in their agency investment program. The EDC likewise favorably recommended RDC endorsement of the proposed project for inclusion in the FY 2022 agency budget subject to compliance with the requirements of DA MIMAROPA.

On a motion duly seconded, the Lapote-Candahon-Bintakay Farm-to-Market Road (FMR) in Mogpog, Marinduque was favorably endorsed for inclusion in the FY 2022 budget proposal of DA MIMAROPA.

• Marinduque Infrastructure Development Projects

 The IDC Co-Chairperson PSR Delfin M. Natal, Jr. presented the proposed infrastructure development projects of the Provincial Government of Marinduque. These are: 1) Infrastructure Projects of Sta. Cruz, Marinduque; 2) Opening of 3km Road in Barangay Libjo to Banal Na Krus, Sta. Cruz, Marinduque; and 3) Poblacion Water Distribution Line Rehabilitation.

1) Infrastructure Projects of Sta. Cruz, Marinduque

PSR Natal presented proposed projects of the Municipal Government of Sta. Cruz, Marinduque such as: a) Construction/Improvement of Public Market Commercial Complex; b) Construction of 288-meter River Control in Barangay Lapu-lapu; c) Construction of 1,000 meters River Control Project with slope protection, structural sheet piles, and retaining wall in Barangay Baliis; d) Construction of 1,800 meters River Control Project in Barangay Manlibunan; e) Road Opening of Dolores-San Antonio; f) Construction of Circumferential Road in Maniwaya; g) Rehabilitation/Concreting of Makulapnit Road 1 (1.8 kilometer) with exception in Barangay Makulapnit; and h) Rehabilitation/Concreting of Makulapnit Road 2 (0.7 kilometer) with exception in Barangay Makulapnit. The estimated total amount of the eight projects is ₱575 million proposed for funding by the Department of Public Works and Highways (DPWH) MIMAROPA.

He reported that the IDC, during its first quarter meeting on February 05, reviewed and found that the projects are compliant with the documentary requirements of the RDC and is aligned with the MIMAROPA RDP 2017-2022 specifically on Chapter 19 (Accelerating Infrastructure Development). He added that the IDC favorably recommended RDC endorsement of the proposed infrastructure projects of Sta. Cruz, Marinduque for inclusion in the DPWH MIMAROPA FY 2022 Budget.

On a motion duly seconded, the proposed infrastructure projects of Sta. Cruz, Marinduque was favorably endorsed for inclusion in the FY 2022 budget proposal of DPWH MIMAROPA.

2) Opening of 3km Road in Barangay Libjo to Banal Na Krus

PSR Natal reported that the Municipal Government of Sta. Cruz, Marinduque proposed the opening of a 3-kilometer road in Barangay Libjo to Banal na Krus, Santa Cruz, Marinduque. The road project is proposed to be funded by the DPWH MIMAROPA amounting to ₱60 million. The project aims to: a) provide access to possible tourism site (Banal na Krus); b) provide access to the highest point in Santa Cruz; c) provide access to camping and trail site stretching from Barangay Libjo, Bangcuangan and San Antonio; d) linkages/connectivity of residents and local farmers to nearby trading centers, public market, health facilities, school and other institutions; and e) increase income of farmers due to the reduction of transportation and hauling cost of agricultural products in the vicinity.

PSR Natal mentioned that the IDC, during its first quarter meeting on February 05, reviewed and found that the projects are compliant with the documentary requirements of the RDC and is aligned with the MIMAROPA RDP 2017-2022 specifically on Chapter 19 (Accelerating Infrastructure Development). He added that DPWH already included the project in the FY 2022 agency budget proposal of DPWH MIMAROPA. The IDC favorably recommended RDC endorsement of the proposed road project subject to the submission of the revised proposal to include the section traversing from the national road to Barangay Bangcuangan.

On a motion duly seconded, the proposed Opening of 3-kilometer Road Project in Barangay Libjo to Banal Na Krus was favorably endorsed for inclusion in the FY 2022 budget proposal of DPWH MIMAROPA.

3) Poblacion Water Distribution Line Rehabilitation

PSR Natal said that the proposed Poblacion Water Distribution Line Rehabilitation in Sta. Cruz, Marinduque aims to: a) upgrade the water distribution line of the municipal water system

for the safe and potable water within reach of every household and commercial establishment; b) replace the old and deteriorated pipelines; c) minimize water losses; d) improve water distribution in the urban area; e) minimize adverse effect of climate change; f) improve water service performance that leads to increase economic productivity; and g) minimize the total cost of duplicated pipes and the number of nodes with pressure deficiency. The proposed project requested the funding of the DPWH MIMAROPA amounting to \$\bigsep\$20 million.

PSR Natal noted that the IDC during its first quarter meeting on February 05, reviewed and found that the project is compliant with the documentary requirements of the RDC and is aligned with the MIMAROPA RDP 2017- 2022 specifically on Chapter 19 (Accelerating Infrastructure Development). DPWH MIMAROPA recommended the referral of the project to LWUA for consideration. The IDC likewise favorably recommended RDC endorsement of the proposed Poblacion Water Distribution Line Rehabilitation in Santa Cruz, Marinduque for inclusion in the FY 2022 agency budget of LWUA.

On a motion duly seconded, the proposed Poblacion Water Distribution Line Rehabilitation Project was favorably endorsed for inclusion in the FY 2022 budget proposal of LWUA.

• Support to RNC Resolution No. 2, series of 2020

 SDC Chairperson PSR Marvi R. Trudeau presented RNC Resolution No. 2, series of 2020, requesting the RDC MIMAROPA through the SDC to enjoin all local government units (LGUs) to strengthen the integration of nutrition-related programs and projects and scale up nutrition-related programs and projects in their 2021-2022 Annual Investment Plans (AIPs) to address the current nutritional problems and the possible effects of COVID-19 pandemic in the health and nutrition situation.

PSR Trudeau reported that the Philippine Plan of Action for Nutrition (PPAN) 2017-2022, an integral part of the Philippine Development Plan 2017-2022, consists of programs and projects that serve as framework for actions that would be undertaken at all levels to address the nutritional problems that have caused deprivation of Filipinos of their right to food and good nutrition. The plan was adopted in the region through RNC Resolution No. 1, s. 2017, "A Resolution Adopting the Philippine Plan of Action for Nutrition 2017-2022." She said that the prevalence of malnutrition according to the 2015 updating survey on the nutritional status of Filipinos conducted by FNRI-DOST remained high and alarming both in the country and in the region. In MIMAROPA, stunting increased from 27.2 percent in 2013 to 31.3 percent in 2015. Moreover, Operation Timbang Plus (OPT+) results showed a minimal decrease in malnutrition prevalence in all indicators from 2018 to 2019. She further cited that the presidential proclamation declaring a state public health emergency throughout the country may cause worsening or deterioration in the nutritional status of the population especially among young children, pregnant and lactating women, the elderly, and persons with disability.

PSR Trudeau added that the National Nutrition Council, through its Nutrition Cluster, provided guidelines on LGU nutrition actions relative to COVID-19 with the following principles: a) malnutrition and other co-morbidities are considered risks for complications in people with COVID-19 if immune system is compromised especially to pregnant, postpartum and/or lactating women, adolescent girls, and the elderly; and b) proper nutrition in the first 1,000 days of a child produces positive impact in the personal health and development of the child and in his/her productivity and family health in adult life.

PSR Trudeau mentioned that the said resolution request the LGUs to take action on the following: 1) embrace the first 1000 days as a banner program for nutrition; 2) finalize their LNAPs in accordance with the PPAN 2017-2022 together with its AIP before the finalization of the overall LGU AIP 2021 and onward; and 3) submit LNAPs with approved funding and submit semestral accomplishment reports to NNC MIMAROPA through the DILG field offices for monitoring and database every January and June. Likewise, the Social Development Committee (SDC), during the SDC-RGADC 1st quarter joint meeting held on February 5, 2021, through videoconferencing, favorably recommended RDC support to RNC Resolution No. 2, s. of 2020.

On a motion duly seconded, a resolution was adopted supporting RNC Resolution No. 2, series, of 2020 to enjoin all LGUs to strengthen the integration of nutrition-related programs and projects and scale up nutrition-related programs and projects and the integration in their 2021-2022 AIPs to address the current nutritional problems and the possible effects of COVID-19 pandemic in the health and nutrition situation.

Guidelines on the Certification of RPGRP

ARD Suzette T. Gannaban-Medina of DepED MIMAROPA presented the Guidelines on the Certification of the Regional Pool of Gender and Development (GAD) Resource Person (RPGRP). As a backgrounder, ARD Medina said that the RDC during its first quarter meeting on March 6, 2020, in Pasay City passed RDC Resolution No. 2020-070-828, approving the Regional Gender and Development Committee (RGADC) Strategic Plan 2020-2025, which contains the RGADC vision and mission for the region, challenges of the committee in fulfilling the functions as the regional arm in mainstreaming GAD in the region, and annual priority activities to be implemented by the committee. It was formulated with the assistance of the Philippine Commission on Women (PCW).

She further cited that to better guide the committee in accomplishing its Strategic Plan 2020-2025, the PCW and RGADC have formulated the RGADC work plan for 2020, which details the major activities of the committee for the year. One of the activities specified in the strategic work plan is the formulation of the certification guidelines for the MIMAROPA pool of experts on GAD, which shall address issues on the limited number of GAD experts in the region. During the 4th quarter SDC and RGADC joint meeting held on November 8, 2019, at Ermita Manila, ARD Medina said that the PCW presented the framework of regional guidelines on the certification of GAD resource pool that served as guide and reference of the RGADC MIMAROPA in crafting its own guidelines. The RGADC Technical Working Group (TWG) meetings held on October 9, 2020, and December 1, 2020, respectively discussed and finalized the draft guidelines prepared by DepEd MIMAROPA. The guidelines specify the processes of application, shortlisting, and certification of GAD resource persons. It also includes the terms of reference, GAD technical assistance referral process, and the roles of the RGADC and PCW in the accreditation of GAD pool of experts.

The SDC-RGADC during its first quarter joint meeting held on February 5, 2021, reviewed and favorably recommended RDC approval and adoption of the guidelines.

On a motion duly seconded, the set of Guidelines on the Certification of the Regional Pool of Gender and Development Resource Person (RPGRP) was approved and adopted.

• Confirmation of RGADC Chairperson and Co-Chairperson

SDC Chairperson PSR Marvi R. Trudeau reported that the MIMAROPA RDC approved the creation of the RGADC through RDC Resolution No. 2018-062-694 during its first quarter full council meeting held on March 20, 2018, in Calapan City.

She said that based on the NEDA-PCW Joint Memorandum Circular 2016-01, which provides for the guidelines for the creation, strengthening, and institutionalization of an RGADC under the RDC. The Committee shall have a Chairperson and a Co-Chairperson as officers. The Chairperson shall be elected from among its members who are regular members of the RDC, while the Co-Chairperson shall be elected from among the members of the RGADC, preferably from among the representatives of civil society or the private sector. The Chairperson and Co-Chairperson shall jointly head the Committee and serve for a period of three years in sync with the term of local elected officials. She also discussed the role and functions of the Chairperson and Co-Chairperson of the Committee.

 PSR Trudeau mentioned that the RGADC Chairperson became vacant on February 01, 2021, upon the assumption of the new DSWD MIMAROPA Regional Director who replaced OIC Regional Director Purificacion R. Arriola. She added that the secretariat of the Committee shall be lodged under the Office of the RGADC Chairperson or an office to be agreed upon by the RGADC members. The Secretariat shall provide technical and administrative support to the Committee; coordinate the preparation of the agenda of Committee meetings; keep a complete record of the minutes of the meetings and other pertinent documents of the Committee; prepare and/or review Committee reports; and perform other duties as may be assigned by the RGADC.

During the RGADC special meeting held on February 26, 2021, via video teleconferencing, Regional Director Fernando R. De Villa, Jr., of Department of Social Welfare and Development (DSWD) MIMAROPA and PSR Juvelyn V. Gumal-in of the Pampamayanang Mangyan Ugnayan, Inc. (PMUI) were elected as Chairperson and Co-Chairperson, respectively.

 On a motion duly seconded, the RDC confirmed Dir. Fernando R. De Villa, Jr., DSWD MIMAROPA and PSR Juvelyn V. Gumal-in (PMUI) as the RGADC Chairperson and Co-Chairperson, respectively.

• CY 2021 RDC Work Program

RDC Vice Chairperson Sumbeling presented the RDC CY 2021 work program and informed the body that the RDC shall oversee the overall coordination in development planning and policy making activities in the region. She added that for CY 2021, key areas of concerns of RDC MIMAROPA were: regional socio-economic and physical planning; policy formulation and coordination; regional investment programming, budget review and implementation; project development and evaluation; monitoring and evaluation of plans, programs and projects; communication and advocacy; and institutional strengthening.

RD Sumbeling requested the members to kindly prioritize the schedule of RDC and sectoral committee meetings. The schedule of RDC full council and sectoral committee meeting as follows:

She mentioned that the priority concerns of the RDC shall serve as guideposts towards the development of the region. The programs, projects and activities contained in the RDC CY 2021 work program are in accordance with RDP 2017-2022 and supportive of the attainment of the development vision for MIMAROPA to make it the destination of choice.

On a motion duly seconded, the CY 2021 Work Program and schedule of meetings of RDC were approved.

• RDC-PSR National Convention 2021

RD Sumbeling presented the budget for the RDC-PSR National Convention 2021. She said that the RDC-PSR National Convention 2021 will be held on April 28-29, via Zoom, which will be hosted by RDC Caraga. The national convention is an annual gathering of PSRs of the RDCs all over the country aims to establish networks and cooperation linkages among PSRs and among regions, strengthen the role of PSRs in regional development, and improving and strengthening partnerships toward global competitiveness.

She further cited that for this year's convention will focus on the PSRs' role in facilitating the recovery of the regions towards achieving resilient and sustainable development amidst the COVID-19 crisis. In addition, the convention is a venue for generating awareness and support for the AmBisyon Nation 2040 and the Updated Philippine Development Plan 2017-2022. The event further provides opportunities for establishing future cooperation between and among delegates and speakers.

Director Sumbeling mentioned that the total estimated cost on the participation of fourteen (14) participants, consisting of the PSRs of RDC MIMAROPA and the RDC Vice-Chairperson and Secretary, in the national convention is P21,000.00, which shall be charged against the RDC Trust Fund. The estimated cost covers budget of P1,000.00 per person for the purchase of sablay (custom/bespoke with "regional accents") to be worn on Day 1 and P500.00 per person for the uniform polo shirt with PSR National Convention 2021 logo/print to be worn on Day 2. She added that not all PSRs might be able to attend the said convention; thus, the proposed amount is the maximum estimated cost. In addition, the cost of the participation of the NEDA Regional Office MIMAROPA staff/secretariat shall be charged against its own funds.

On a motion duly seconded, the proposed budget for the participation of MIMAROPA PSRs to the RDC-PSR National Convention 2021 was approved.

• Confirmation of ExCom Resolution No. 3-37, s. 2021

RD Susan A. Sumbeling reported that on January 7, 2021 former Congressman Reynaldo "RU" Umali of the second district of Oriental Mindoro passed away at the age of 63. Congressman Umali served for three terms as House of Representative of the second district of Oriental Mindoro wherein he has been the Chairperson of Committee on Justice.

She said that Congressman Umali was a member of the MIMAROPA Advisory Committee (AdCom) and actively participated in the AdCom and Regional Development Council (RDC) meetings. She added that Congressman Umali strongly supported the thrust and priorities of

the RDC which he openly urged the regional line agencies and local government units to be more aggressive in proposing projects that will redound to an inclusive growth in the region.

Director Sumbeling mentioned that the RDC appreciated and honored the contributions of Congressman Reynaldo V. Umali for the development of MIMAROPA region, and is deeply saddened by his untimely demise. On January 13, 2021 RDC Executive Committee, through referendum approved Resolution No, 3-37 s. 2021, "Expressing Sympathy to the Honorable Representative of the Second District of Oriental Mindoro during the 15th, 16th, and 17th Congresses and to the Family of former Congressman Reynaldo "RU" V. Umali". As prescribed in the RDC Manual of Operations, all resolutions of the Executive Committee shall be confirmed by RDC during its full council meeting.

On a motion duly seconded, RDC ExCom Resolution No. 3-37, series of 2021 was confirmed.

H. Matters for Information

• DOE-DILG JMC 2021-01

USec Felix William B. Fuentebella of Department of Energy briefed the body on the Department of Interior and Local Government (DILG)-Department of Energy (DOE) Joint Memorandum Circular No. 2021-01 on the Guidelines for the LGUs to Facilitate the Implementation of Energy Projects. The guidelines provides policies to facilitate, fast track, and speed up the processing, regulation, development, and implementation of energy projects which may include, generation, transmission, and distribution.

USec Fuentebella mentioned that the DILG in support of the DOE enjoins all LGUs to implement the directive of President Duterte on the implementation of energy projects through the issuance of the policy. The DILG prescribes the draft ordinance for consideration of the LGUs to comply with the guidelines concerning fees and other charges.

The purpose of the guidelines are the following: a) to establish, strengthen and integrate the national energy plans, programs, policies and mechanisms into the local development plans, with respect to energy safety practices, energy efficiency and conservation, energy resiliency, and energy planning which includes energy access and resource development; b) to harmonize and fast-track the implementation of the Energy Virtual One-Stop Shop (EVOSS) Act, East of Doing Business (EODB) Act, Executive Order No. 30 and Administrative Order No. 23 with the establishment of unified and streamlined permitting process; c) to maximize benefits from energy projects to the host communities; and d) to implement the other necessary energy programs and projects to spur the total development of the LGUs.

Featured Technology of MIMAROPA SUCs

The featured technology of MIMAROPA State Universities and Colleges (SUCs) aims to provide opportunity to promote and disseminate information on the technologies generated by the SUCs in the region and to encourage adoption or commercialization of publicly funded technologies.

A representative from Mindoro State College of Agriculture and Technology (MinSCAT) presented the Stingless Bee Pollen and Propolis Jam, a beehive product. The raw propolis has a bitter and strong flavor with a rubber-like texture but researchers/professors from the MinSCAT processed the propolis into a jam making the taste more appealing to the

consumers. The product has pharmacological properties such as a) hypotensive agent; b) immune system stimulant; and c) bacteriostatic and bactericidal agents.

Annual/Regional Economic Situationer

Director Sumbeling referred the members to the reference folder for the 4th quarter regional economic situationer 2020 (QRES) and the annual regional economic situationer 2020 (ARES). She requested the concerned agencies to validate the data and provide feedback or corrections on the draft QRES and ARES.

• CY 2020 RDC Accomplishment Report

A ten-minute audio-visual presentation on the RDC CY 2020 accomplishment reports was presented by the secretariat for the information of the Council.

• Project Monitoring Report

Director Sumbeling mentioned that the RDC Secretariat tracked the status of the implementation of ongoing priority projects in the region through the submission of reports from various government agencies to the Regional Project Monitoring Committee (RPMC) using the ProyekTanglaw system.

She said that for the 4th quarter of CY 2020, there were 414 projects reported by different MIMAROPA government offices in the region. Of the reported 414 projects, 103 projects or 24.88 percent encountered problems in implementation. A total of 212 projects or 51.21 percent were reportedly completed. She added that of the reported 414 projects, 363 were regular GAA projects; two (2) were ELCAC projects; 34 were RRP projects; and 15 were ODA projects.

She further cited that DA submitted the implementation of six (6) PRDP I-BUILD subprojects amounting to ₱744.11 million. These subprojects aim to improve the links from the production areas to markets to enhance the efficiency of transporting agricultural products. A total of nine (9) PRDP I-REAP subprojects was also reporting amounting to ₱71.060 million. These subprojects aim to engage broad sections of the sector in the production of marketable surplus through investments in strategic segments of priority commodity value chains and strengthening collaboration between DA and the LGUs.

The DPWH MIMAROPA submitted implementing 167 projects amounting to ₱22,961.55 million. A total of 90 projects amounting to ₱13,921.36 million were already completed, 59 projects amounting to ₱6,685.47 million encountered delays in implementation, and 18 projects amounting to ₱2,354.72 million were ahead of schedule.

Director Sumbeling added that the PPA PMO Mindoro reported implementing the Construction of Coastal Access Road Project in Barangay San Antonio, Calapan City amounting to ₱140.81 million and the Construction of Port Operations Building in Abra de Ilog, Occidental Mindoro amounting to ₱79.83 million. DOTr submitted status report of San Vicente Airport Development Project (Construction of Control Tower and Power House). The allocated budget for the projects was recorded at ₱90.00 million. As of December 31, 2020, the project has a physical accomplishment of 35.87 percent with a slippage of negative 64.13 percent. DICT Luzon Cluster 3 submitted status reports on three (3) projects. The allocated budget for the projects was recorded at ₱31.44 million. The NPC reported eight (8) projects amounting to ₱1,939.58 million for the fourth quarter of 2020.The average physical accomplishment of NPC projects

was 66.74% with an average slippage of negative 10.652%. Of the eight (8) reported projects, six (6) projects amounting to ₱1,642.88 million were behind schedule. Two projects amounting to \$296.70 million were on schedule. The LWUA submitted status report of Improvement and expansion of existing water supply system of Sablayan (Occidental Mindoro) Water District. Allocated budget for the projects was recorded at ₱5 million. As of December 31, 2020, the project has a physical accomplishment of one percent with a slippage of negative seven percent. The DOST submitted the status reports on 35 projects. Allocated budget for the projects was recorded at ₱59.90 million. A total of 11 projects amounting to ₱14.79 million were already completed, six (6) projects amounting to \$\frac{1}{2}\$17.51 million encountered delays in implementation, 16 projects amounting to ₱23.68 million were on schedule, and 2 projects amounting to ₱3.62 million were ahead of schedule. Included in the report were two (2) RRP projects amounting to ₱1.82 million. TESDA reported the status of two (2) programs amounting to ₱4.25 million for the fourth guarter of 2020. These are the 2019 Universal Access to Quality Tertiary Education Act (UAQTEA), and the 2019 Rice Extension Services Program (RESP). Both were reported as completed as of December 31, 2020. The DOLE MIMAROPA reported implementing two (2) ELCAC programs funded under 2020 GAA amounting to ₱1.29 million. The Government Internship Program amounting to ₱1.15 million and the DOLE Integrated Livelihood Program amounting to ₱0.14 million were completed. The DOH reported six (6) projects amounting to ₱119.90 million for the fourth quarter of 2020. The average physical accomplishment of DOH projects was 77.44% with an average slippage of negative 11.09%. Of the six (6) reported projects, four (4) projects amounting to ₱111.54 million were behind schedule. The Repair/Rehabilitation of Main Building and Completion of Wards in San Agustin, Romblon amounting to \$\int\$5.86 million was ahead of schedule, while the Provision of various medical equipment for the Province of Palawan amounting to ₱2.5 million reported no accomplishment

For the SUCs, Director Sumbeling reported that MSC submitted status reports on 12 projects amounting to ₱148.33 million. The average physical accomplishment of MSC projects was 62.37% with an average negative slippage of 11.54%. MinSCAT submitted status reports on 15 projects with allocated budget of ₱218 million. The average physical accomplishment of MinSCAT projects was 82.51% with average negative an slippage negative 1.62%. OMSC reported the status of twelve (12) projects amounting to ₱ 17.64 million. The average physical accomplishment of OMSC projects was 83.84% with an average slippage of positive 3.04%. PSU reported the status of ten (10) projects amounting to ₱242 million. RSU reported the status of four (4) projects amounting to ₱ 69.09 million and WPU reported the status of Construction of College of Business Management Academic Building amounting to ₱10 million. The project was reported completed.

1184 1185 Director Sumbeling reported that the RDC secretariat regularly monitors the status of proposed programs, activities, and projects (PAPs) endorsed by the RDC through a resolution. She said that the RDC approved 21 resolutions endorsing a total of 253 PAPs in the region for possible funding either under the General Appropriations Act (GAA), Public-Private Partnership (PPP), or Special Program. She added that out of the 253 PAPs, 140 were completed, 51 were ongoing, and 62 were proposed to be funded/implemented. All projects that were completed and ongoing will be included in the list of projects to be monitored by the Regional Project Monitoring Committee (RPMC).

For the details of the RDC endorsed projects, Director Sumbeling referred the members to the reference folders for review of the concerned agencies.

• CY 2020 RDC Summary of Attendance

Director Sumbeling presented the summary of attendance of the RDC members in full council and executive committee meetings. RDC encourages the full attendance of its members including the special non-voting members (SNVMs) in all of the meetings to directly respond to or address matters specific to their agencies and mandates. She added that the RDC Chairperson requires the presence of regional directors and/or assistant regional directors in all RDC meetings per RDC Resolution No. 2014-047-313. In CY 2020, four (4) full council (March 6, June 5, September 4, and December 4) and two (2) executive committee meetings (May 8 and July 3) were conducted by the RDC.

 - iv. will make the Commission more vulnerable to parochial accommodation and pressure

Subject: Strategic Development Plan for the Kalayaan Island Group

- 1. The Palawan Council for Sustainable Development (PCSD) initiated the creation of an Inter-Agency Task Force Kalayaan Island Group Technical Working Committee (IATF-KIG TWC). The TWC is tasked to develop a plan for the sustainable development of the nine Philippine occupied features in the KIG with a total budget of ₱90 million (₱10 million per feature) from the Provincial Government of Palawan. The nine features include: Kota Island, Lawak Island, Likas Island, Pagasa Island, Panata Island, Parola Island, Patag Island, Ayungin Shoal, and Rizal Reef.
- 2. The IATF-KIG TWC drafted the Strategic Development Plan and Action Plan for the Kalayaan Island Group (SDPAP-KIG). The plan has 4 key components: (1) develop the KIG to optimize its contribution to Palawan, MIMAROPA region, and national economy; (2) integrate the KIG into the national consciousness and economy; (3) secure our National Patrimony; and (4) consider whole of nation approach in its implementation. It highlights the islands' development advantages and identifies possible areas of collaborations among the private and government sectors in the region geared towards the country's Ambisyon Natin 2040 or the Filipino's collective aspirations for a "matatag, maginhawa, at panatag na buhay para sa lahat".
- 3. During the second quarter Economic Development Committee (EDC) meeting held on May 06, 2021, the PCSD presented and requested the RDC endorsement of the SDPAP for the KIG to secure commitment and funding support from concerned agencies. The Committee recognized the need to safeguard the development and conservation of KIG through strategic sustainable development and protection of its natural resources, fortified Philippine sovereign rights over the KIG features, resilient communities to climate change, and strengthened economy in the municipality of Kalayaan, Palawan.
- 4. The EDC, during the said meeting, recommended RDC endorsement of the SDPAP-KIG subject to the submission of the following: (a) the plan document with accompanying request letter, (b) proforma resolution, and (c) PDC or local endorsement.
- 5. The EDC Chairperson will present the highlights of the SDPAP for the KIG.

BRIEF FROM THE RDC SECRETARIAT

Subject: Gender and Development (GAD) Mechanisms Profiling Form and Inventory of GAD Policies Form

- 1. The Regional Development Council (RDC), during its first quarter meeting on March 6, 2020, in Pasay City passed RDC Resolution No. 2020-070-828, approving the Regional Gender and Development Committee Strategic Plan 2020-2025, which contains the RGADC vision and mission for the region, challenges of the committee in fulfilling the functions as the regional arm in mainstreaming GAD in the region, and annual priority activities to be implemented by the committee.
- 2. The strategic plan was formulated with the assistance of the Philippine Commission on Women (PCW).
- 3. To better guide the committee in accomplishing the RGADC MIMAROPA Strategic Plan 2020-2025, an annual work plan was prepared, which details the activities of the committee for the year.
- 4. Among the activities specified in the strategic plan and 2021 work plan are the 1) profiling of established GAD mechanisms in the region and the 2) inventory of GAD policies in the region.
- 5. Through these activities, RGADC MIMAROPA will be able to assess the functionality of the GAD focal point system (GFPS) of the regional line agencies (RLAs), state colleges and universities (SUCs), and local government units (LGUs) and identify the gaps and challenges in the implementation of GAD mandates and policies at all levels.
- 6. During the RGADC TWG meeting held on October 9, 2020, the Department of Science and Technology (DOST) MIMAROPA and the National Nutrition Council (NNC) MIMAROPA crafted the GAD mechanisms profiling form, while the Department of Health (DOH) MIMAROPA and Commission on Population and Development (PopCom) MIMAROPA developed the inventory form. PCW provided reference materials in the development of the tools.
- 7. The National Economic and Development Authority (NEDA) MIMAROPA as RGADC MIMAROPA Secretariat combined the two crafted forms and transmitted the combined form to Department of Education MIMAROPA as the RGADC MIMAROPA TWG Team Leader on January 28, 2021.

- 8. The GAD Mechanisms Profiling and Inventory of GAD Policies Form will be used to gather information on the preparation and submission of GAD plan and budget (GPB) and GAD accomplishment reports (AR), formulation of GAD code/agenda, establishment of GFPS, and development of GAD database, and adoption and implementation of GAD policies.
- 9. The RGADC MIMAROPA TWG members, the Secretariat, and the PCW reviewed the combined form during its TWG meeting on February 4, 2021.
- 10. The RGADC MIMAROPA, during its second quarter meeting on May 14, 2021, reviewed and approved the final draft of GAD Mechanisms Profiling and Inventory of GAD Policies Form, with the comments of PCW incorporated, and recommended RDC adoption.
- 11. The Committee also approved to recommend to RDC to enjoin all government instrumentalities in the region to fill out and submit the GAD mechanisms profiling and inventory of GAD policies form to RGADC MIMAROPA.
- 12. The RGADC Chairperson will present the draft GAD Mechanisms Profiling and Inventory of GAD Policies Form.
- 13. Action requested: For RDC approval and adoption of the GAD Mechanisms Profiling and Inventory of GAD Policies Form and enjoin all government instrumentalities in the region to accomplish the said Form.

WHEREAS, given the limited resources of the Commission on Population (POPCOM), there is a need for the support of the Sangguniang Kabataan (SK) Councils by providing funds to be utilized for the implementation of various strategies and mechanisms to prevent and reduce teen pregnancy cases;

WHEREAS, all strategies are geared toward encouraging the involvement of the youth including the indigenous people's (IPs) groups in public and civic affairs and strengthening their participation in responsible sexual and reproductive health agenda;

WHEREAS, there is also a need to strengthen partnership and networking at the national and local levels to ensure policy implementation that directly address teen pregnancy reduction and prevention at the grassroots;

WHEREAS, the Regional Population Executive Board (RPEB) of MIMAROPA, during its first quarter meeting held on March 9, 2021, passed a resolution requesting the MIMAROPA Regional Development Council (RDC), through the Social Development Committee (SDC), to seek support from all SK Councils to utilize 10% SK funds in support of the implementation of strategies and mechanism to prevent and reduce teen pregnancy cases in the region;

NOW, THEREFORE, BE IT RESOLVED, to enjoin the Sangguniang Kabataan (SK) Councils to utilize SK funds in support of the implementation of programs, projects, and activities (PPA) geared towards the reduction of teen pregnancy cases in MIMAROPA Region.

RESOLVED FURTHER, that the Provincial, City, and Municipal SK councils are requested to take action on the following: 1) coordinate with local population and development offices on the implementation of PPAs that directly address teen pregnancy reduction and prevention in their locality; 2) adopt resolutions and pass local ordinances in support of teen pregnancy prevention and reduction with appropriate coordination among regional line agencies and funding; and, 3) develop and implement culturally responsive and sensitive teen pregnancy prevention programs for IP youth in their areas of jurisdiction.

Subject: MIMAROPA Gross Regional Domestic Product

- 1. On April 29, 2021, the Philippine Statistics Authority (PSA) conducted simultaneous regional press conferences to release the 2020 Regional Accounts of the Philippines, specifically the Gross Regional Domestic Product (GRDP) by industry and by region, and Gross Regional Domestic Expenditure (GRDE) by expenditure item and by region.
- 2. Similar to all regions, MIMAROPA's economy experienced dismal economic growth in 2020 with negative 7.6 percent growth rate.
- 3. All subsectors suffered a reversal of growth, except for three: information and communication; financial and insurance activities; and public administration and defense and compulsory social activities, which managed to increase at a slower pace.
- 4. On the other hand, for the GRDE of MIMAROPA in 2020, only the government final consumption expenditure posted growth by 9.6 percent. The other expenditure items recorded a decline wherein Exports of goods and services to the rest of the world has the highest contraction of 46.1 percent.
- 5. PSA MIMAROPA will present the details of the GRDP and GRDE for MIMAROPA in 2020.

Subject: Implementation Status of the Republic Act No. 11055

- 1. On August 06, 2018, President Rodrigo R. Duterte signed Republic Act No. 11055 or An Act Establishing Philippine Identification System (PhilSys) Act. The law aims to establish a single national identification system for all citizens and resident aliens of the Republic of the Philippines.
- 2. The PhilSys shall serve as social and economic platform through which all transactions including public and private services can be availed of and shall serve as the link in the promotion of seamless service delivery, enhancing administrative governance, reducing corruption, strengthening financial inclusion, and promoting ease of doing business.
- 3. The Philippine Statistics Authority (PSA) rolled out the first step in the registration process of the project in October 2020. This involved the collection of the registrants' demographic information, followed by setting up of appointment for the biometrics capturing.
- 4. As of April 16, a total of 534,494 registrants was interviewed by the PSA MIMAROPA to gather basic information. This is 12.22% higher than the target number of registrants, which was set at 476,280 registrants.
- 5. Among the five provinces in MIMAROPA, Palawan recorded the highest number of interviewed registrants with 206,153 registrants. This was followed by Oriental Mindoro with 153,638 registrants, Occidental Mindoro with 78,603 registrants, and Romblon with 49,898 registrants. Marinduque recorded the lowest number of interviewed registrants with 46,202 registrants.
- 6. A total of 62 municipalities with 380 barangays in the region were covered during the first step of the program.
- 7. For the Step 2 (biometrics capturing) roll out of the program, a total of 50 municipalities has signed their respective memorandum of agreement with PSA to set-up LGU-based registration.

- 8. The validation of demographic data and capturing of biometric information will be conducted by the PSA MIMAROPA in May to June 2021.
- 9. The PSA MIMAROPA will present the Philippine Identification System Act implementation status in the region.

Subject: MIMAROPA COVID-19 Situational and Vaccine Rollout Report

- 1. President Rodrigo R. Duterte issued Proclamation No. 922, declaring a state of public health emergency throughout the entire Philippines and prompting a whole-of-government approach in addressing the COVID-19 pandemic. On March 12, 2020, the President, upon the recommendation by the IATF, raised the code alert level for COVID-19 to Code Red Sublevel 2 and directed the imposition of stringent social and physical distancing and enhanced response measures.
- 2. The Department of Health-Center for Health Development (DOH-CHD) MIMAROPA conducts surveillance, infection prevention and control, risk communication, contingency planning, and laboratory capacity building.
- 3. As of May 18, 2021, MIMAROPA has recorded a total of 7,291 cumulative number of COVID-19 cases, with 1,509 total active cases. Puerto Princesa City has recorded the highest number of active cases, with 508, while Oriental Mindoro has 467. Palawan has 372, Occidental Mindoro has 100, Romblon has 51, and Marinduque has 11 active cases.
- 4. The government recognizes the huge national endeavor that the country needs to undertake to ensure equal access to vaccines and to implement quality vaccination services. The vaccination against COVID-19 program of the government is an intervention and an integral part of the government's response to the pandemic.
- 5. As of May 17, 2021, based on the National COVID-19 Vaccination Operations Center Bulletin No. 78, there were 37,036 persons from Priority Group A1 (health workers) who were vaccinated with the first dose, while there were 9,473 persons vaccinated with the second dose. Under Priority Group A2 (senior citizens), there were 5,940 persons in the region vaccinated with the first dose, out of the 266,877 master-listed population under Group 2, while there were 108 persons vaccinated with the second dose. Under Priority Group A3 (with comorbidities), there were 155 persons vaccinated with first dose and 1 person vaccinated with the second dose.
- 6. DOH MIMAROPA will present the full COVID-19 situation and vaccine roll-out report for MIMAROPA Region.

Subject: Salient Features of Nationally Determined Contributions

- 1. The Paris Agreement (PA) was adopted by 196 countries at the 21st Conference of Parties (COP21) of the United Nations Framework Convention on Climate Change (UNFCCC) in 2015. The PA is an international treaty on climate change which aims to limit the global average temperature increase to 1.5 to 2 degrees Celsius above pre-industrial levels recognizing that this would significantly help reduce the risks and impacts of climate change.
- 2. Article 4, paragraph 2 of the PA states that each party or country is required to prepare, communicate, and maintain its Nationally Determined Contributions (NDCs). The NDCs are national climate plans which highlight climate actions including climate related targets, policies, and measures of the government to contribute to the attainment of the goals of the Paris Agreement.
- 3. The first Philippine NDC was submitted to the UNFCCC Secretariat on April 15, 2021. The NDC supports the country's national development objectives and priorities of a sustainable industrial development, poverty eradication and inclusive growth, energy security, social and climate justice, and the transformation of its socio-economic sectors towards a climate and disaster-resilient and low carbon economy.
- 4. The Philippine NDC also highlights the importance of participatory approach to planning and implementation of climate programs and actions. It also recognizes the importance of public- private sector collaboration in the future enhancements of the NDC to reflect increasing ambition and economy-wide mitigation potential based on the growth directions and projected climate change adaptation needs of the Filipino people.
- 5. During the second quarter Economic Development Committee (EDC) meeting held on May 06, 2021, the Climate Change Commission (CCC) presented the NDC. The CCC is the lead policy-making body tasked to facilitate the development and implementation of the Philippine NDC. Due to the cross sectoral concerns of the matter, the CCC was requested to present the NDC during the RDC meeting.
- 6. The CCC, will present the salient features of the NDC including the roles of the regional line agencies, local government units, and private sectors, and the NDC next steps/roadmap.

Subject: Updates on the R&D Initiatives by MIMAROPA State Universities and Colleges and Research and Development Institutes

- 1. The MIMAROPA Regional Research, Development, and Innovation Committee (RRDIC), a special committee under the Regional Development Council (RDC), provides central direction to R&D undertakings in the region in accordance with the MIMAROPA R&D Agenda (MRDA) 2018-2022 and the Regional Development Plan.
- 2. During the Funders' Conference held in 2018, priority R&D topics indicated in the MRDA were assigned to MIMAROPA State Universities and Colleges (SUCs) and Research and Development Institutes (RDIs).
- 3. The RRDIC, during its 2nd Quarter Virtual Regular Meeting on May 5, 2021, resolved to present to the RDC 2nd Quarter Full Council Meeting the R&D accomplishments and updates on the status of research topics assigned to MIMAROPA SUCs and RDIs.
- 4. The presentation aims to inform the RDC members on R&D initiatives and accomplishments of SUCs and other RDIs in the region, promote the technologies generated, encourage participation of public and private sectors to R&D undertakings in the region, and create channels through the RDC for knowledge utilization especially for policy development, technology transfer, and commercialization.

Subject: 1st Quarter Regional Economic Situationer (QRES) 2021

- 1. QRES provides a preliminary and indicative assessment of the economic performance of the region using proxy indicators. It does not replace the assessment of the regional economy based on the complete statistical data from official sources.
- 2. MIMAROPA's average inflation rate increased to 5.3 percent in January to March 2021 from the previous year's 3.2 percent of the same period. This was also higher than the previous quarter's 3.7 percent. All provinces registered higher inflation rates.
- 3. The region's working age population increased by 1.4 percent from 2,041,000 in January 2020 to 2,069,000 in January 2021. Labor force participation rate increased by 1.9 percentage points from 58.8 percent in January 2020 to 60.7 percent in January 2021. However, employment rate decreased by 5.7 percentage points from 96.4 percent in January 2020 to 90.7 percent in January 2021.
- 4. Some indicators that show the region's positive economic performance in the first quarter of 2021 are reflected in the production of the agricultural commodities such as palay, banana, coconut, onion, livestock, commercial fishery, municipal marine/inland fishery, and aquaculture.
- 5. The number of registered business names, assisted micro, small, medium enterprises (MSMEs), and registered vehicles increased. The value of mineral production, exports, and imports also increased.
- 6. Due to the COVID-19 pandemic, tourist arrivals, movement of aircrafts and sea vessels including ROROs, passengers and cargoes in air and water transport services all decreased.
- 7. The region remains peaceful, as the volume of crimes decreased compared to previous year's first quarter data.
- 8. The 1st Quarter Regional Economic Situationer 2021 will be distributed to the members for review and validation of data.

Subject: Project Monitoring Report

- 1. The RPMC secretariat tracked the status of the implementation of on-going priority projects in the region through the submission of reports from various government agencies to the Regional Project Monitoring Committee (RPMC) using the "ProyekTanglaw" system.
- 2. For the 1st quarter of CY 2021, there were 291 projects reported by different MIMAROPA government offices, government owned and controlled corporations, local government units, and state universities and colleges, such as: Department of Agriculture (DA), Department of Health Center for Health Development (DOH-CHD), Department of Labor and Employment (DOLE), Department of Science and Technology (DOST), Department of Transportation (DOTr), Department of Public Works and Highways (DPWH), Department of Social Welfare and Development (DSWD), Local Water Utilities Administration (LWUA), National Irrigation Administration (NIA), National Power Corporation (NPC), Population Commission (POPCOM), Provincial Government of Palawan, City Government of Calapan, Marinduque State College (MSC), and Palawan State University (PSU).
- 3. Of the reported 291 projects, 102 projects (35.05 percent) encountered problems in implementation. These were as follows

4. A total of 114 projects or 39.18 percent were reportedly completed.

- 5. These 291 projects generated a total of 8,883 employment opportunities, of which 6,420 (72 percent) employed were men, and 2,463 (28 percent) employed were women.
- 6. No ELCAC and BP2 PAPs were reported for the first quarter of 2021.
- 7. DA reported the implementation status of three PRDP I-BUILD subprojects amounting to \$\frac{1}{2}460.95\$ million. These subprojects aim to improve the links from production areas to markets to enhance the efficiency of transporting agricultural products.

- 9. DPWH reported implementing 166 projects funded to ₱23.043.55 under GAA 2016-2020 amounting million. total ₱14,169.93 million were of 92 projects amounting to already completed, 62 projects amounting ₱7,301.50 million encountered to delays in implementation, and 12 projects amounting ₱1,572.12 million of were ahead schedule.
- 10. DOTr reported implementing four projects amounting to ₱162.01 million. As of March 31, 2021, the project has a physical accomplishment of 52.90 percent with a slippage of negative 32.44 percent.
- 11. NPC reported ten projects amounting to ₱1,762.53 million for the first quarter of 2021. The average physical accomplishment of NPC projects was 68.24 percent with an average slippage of negative 11.58 percent. Of the ten reported projects, seven projects amounting to ₱1,442.33 million were behind schedule. Two projects amounting to ₱296.70 million were on schedule, while one project amounting to ₱23.50 million was ahead of schedule.
- 12. The LWUA submitted status report on the improvement and expansion of existing water supply system of Sablayan (Occidental Mindoro) Water District. Allocated budget for the projects was recorded at ₱5.92 million. As of March 31, 2021, the project has a physical accomplishment of five percent with a slippage of negative 13.66 percent.
- 13. NIA reported implementing 24 projects amounting to ₱628.54 million. A total of 11 projects amounting to ₱177.50 million were already completed, three projects amounting to ₱44.00 million encountered delays in implementation, one project amounting to ₱10.00 million on schedule, and nine projects amounting to ₱397.04 million were ahead of schedule.
- 14. DA submitted the status reports on 15 projects amounting to ₱516.31 million. A total of five projects amounting to ₱25.12 million were

already completed, three projects amounting to ₱20.96 million were on schedule, and seven projects amounting to ₱470.23 million were ahead of schedule. Included in the report were 11 PRDP sub-projects amounting to ₱491.77 million.

- 15. DOST submitted the status report on nine projects amounting to ₱7.20 million. Two projects amounting to ₱1.93 million were already completed, one project amounting to ₱0.01 million encountered delays in implementation, five projects amounting to ₱2.74 million were on schedule, and one project amounting to ₱2.52 million was ahead of schedule.
- DOH reported 11 projects amounting to ₱173.94 million for the first physical 2021.The average accomplishment of DOH projects was 67.51 percent with an average slippage percent. Of the 11 reported negative 10.31 projects, one to ₱10.90 million project amounting was completed, four projects amounting to ₱99.04 million were behind schedule, two projects amounting to ₱19.70 million were on schedule, while four projects amounting to ₱44.30 million were ahead of schedule.
- 17. DOLE reported eight projects amounting to ₱203.94 million for the first quarter of 2021. The average physical accomplishment of DOH projects was 9.06 percent with no slippage.
- 18. DSWD reported 12 projects amounting to ₱6,593.51 million for the first quarter of 2021. The average physical accomplishment of DSWD projects was 78.64 percent with an average slippage of negative 21.35 percent.
- 19. PopCom submitted status report of three projects amounting to ₱1.05 million. The average physical accomplishment of POPCOM projects was 84.09 percent with an average slippage of negative 15.91 percent.
- 20. MSC submitted status reports on eight projects amounting to ₱87.03 million. The average physical accomplishment of MSC projects was 44.01 percent. Out of the eight projects, two projects amounting to ₱15.19 million were completed, while six projects amounting to ₱71.84 million were on schedule
- 21. PSU reported the status of 11 projects amounting to ₱260.00 million for the first quarter of 2021. Of the 11 reported projects, one project amounting to ₱35.00 million was completed, five projects amounting to ₱68.00 million were behind schedule, and four projects amounting to ₱122.00 million were on schedule.
- 22. The Provincial Government of Palawan reported the status of six projects amounting to ₱ 30.09 million for the first quarter of 2021. The average physical accomplishment

of PG Palawan projects was 19.29 percent with an average slippage of negative 1.91 percent.

- 23. The City Government of Calapan reported the status of three projects amounting to ₱22.90 million for the first quarter of 2021. Of the three projects, two projects amounting to ₱22.90 million were behind schedule while one project amounting to ₱13.02 million was ahead of schedule.

Subject: Status of RDC endorsed projects

- 1. The Regional Development Council (RDC) is mandated under Executive Order No. 325, s. 1996 to initiate and coordinate the development, funding, and implementation of regional and special development projects such as those involving several agencies or local government units.
- 2. The Secretariat regularly monitors the status of proposed programs, activities, and projects (PAPs) endorsed by the RDC through a resolution. From 2011-2020, the Secretariat monitored 249 PAPs in the region proposed for funding either under the General Appropriations Act (GAA), Public-Private Partnership (PPP), or special program. Out of the 249 PAPs, 137 were completed, 39 were ongoing, and 73 were proposed to be funded/implemented. All projects that were completed and ongoing will be included in the list of projects to be monitored by the RDC Regional Project Monitoring Committee/Team.
