WHAT : Apprehension of 5 pieces of Bangkal lumber with total volume of 28 board feet and one (1) unit chainsaw-070 STIHL without serial number

WHERE : Sitio Kabongbungan, Barangay Taratak, Bataraza, Palawan

WHEN : April 7, 2021 at around 5:00 in the afternoon

WHY : Violation of Sec.77 of P.D. 705 as further amended otherwise known as Forestry Reform Code of the Philippines and P.D. 9175 otherwise known as Chainsaw Act of 2002

HOW : The composite team of PNP 2<sup>nd</sup> Special Operations Group – Maritime Group Rio Tuba Detachment and Palawan Council for Sustainable Development (PCSD) personnel conducted law enforcement operations in response to report of a reliable informant that resulted to the apprehension of 8 pieces of Bangkal lumber with a total volume of 36 board feet and one (1) unit chainsaw without serial number operated by Mr. Lito Liganap. The apprehended forest products and chainsaw were deposited at 2<sup>nd</sup> SOU-MG Rio Tuba Detachment for temporary safekeeping.
