Last April 29-30, 2021, the BDFE proposal presentation was conducted via zoom meeting where BDFE facilitators and representatives from regions 2, 3, CALABARZON, 5, 7, 8, 9, 10, 12 and CARAGA presented and discussed the details of their financial assistance proposals for 2021. - 3. Authenticated copy of Articles of Incorporation
- 4. Audited financial Report (3 years preceding the date of project implementation)
- Disclosure by the PO of other related business, if any, and extent of ownership by the board
- 6. Signed Work and Financial Plan
- 7. Draft Business Plan
- 8. List and/or Photographs of similar projects previously completed by the PO, if any
- Resolution from the PO Board authorizing their President to enter into a Memorandum of Agreement (MOA) with DENR
- 10.PO Board Resolution certifying that none of its officials or board of directors is an agent or related by consanguinity or affinity up to the fourth civil degree to the officials of DENR-BMB/DENR authorized to process and/or approve the proposal, MOA and the release of funds.
