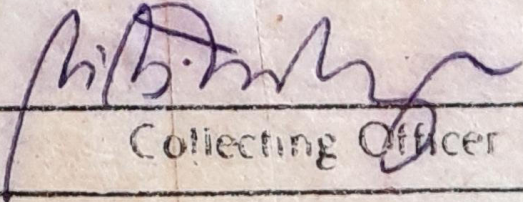

I, the undersigned, hereby make application, pursuant to the provisions of Act No. 3077 and Bureau of Lands Administrative Order No. 8, as amended, for a permit to temporarily or provisionally occupy and use agricultural purposes the tract of land located in the Barrio Sta. Cruz Municipality of Pto. Princesa Province of Palawan bounded containing approximately an area of 553 Hectares as follows:

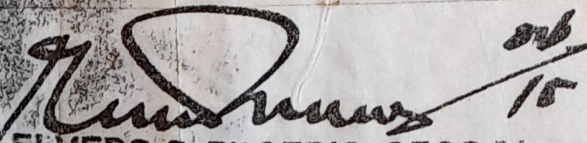
This is to certify that upon verification of Lot 13521 containing an approximate area of 5,537,011.68 square meters located at Barangay Sta. Cruz, Puerto Princesa City Palawan and covered by Cad 800-D, Puerto Princesa Cadastre, module VII-Case 44 as approved by Regional Director Rodolfo A. Paelmo on January 30, 1985, subject area falls within timberland, Project No. 1-0, per LC Map No. 1787 certified on October 11, 1954.



The same area falls within the area coverage of Proclamation No. 2282 dated March 29, 1983 reclassifying portions of the public domain as agricultural land and declaring the same as Alienable and Disposable for Agricultural and Resettlement purposes of the Kilusang Kabuhayan at Kaunlaran Land Management Program of the Kilusang Kabuhayan at Kaunlaran of the then Ministry of Human Settlement. Proclamation No. 2282 was revoked under Memorandum Order No. 17 dated June 17, 1986. Furthermore, Memorandum Order No. 107 dated March 23, 1993 prescribed Administrative Guidelines on status of Proclamation No. 2282 that all lands covered by the said Proclamation which were reclassified as Alienable and Disposable Agricultural Land Prior to March 29, 1983 and used and Administered by KKK-NLSF as Agricultural land shall remain Alienable and Disposable lands.

Portion enclosed in red color which overlaps with CBFM awarded to Nagsaqui Small Coconut Farmers Ass. Inc. covering 140.00 hectares shall be excluded.

This certification is issued upon request of Geodetic Engineer, Lucy Janet R. Pasion for whatever legal purpose it may serve. Issued this 9<sup>th</sup> day of April 2003 upon payment of the required verification fee in the amount of Thirty pesos (P30.00) under the O.R. No. 6250632 dated April 9, 2003.
