The World Wildlife Fund (WWF), is executing the Targeting Regional Investigations for Policing Opportunities and Development (TRIPOD) Project, a Bureau of International Narcotics and Law Enforcement Affairs (INL)-funded, with Freeland Foundation, a Thailand-based Non-Governmental Organization (NGO), as the primary holder of the project. This initiative is being supported by DENR-Biodiversity Management Bureau (BMB).

As part of the strategy to combat wildlife trafficking in the Philippines, the Project will conduct sub-national gap analysis and needs assessment activity which will serve as baseline information to produce a National Assessment Report (NAR). The NAR is a comprehensive report aligned with the International Consortium on Combating Wildlife Crime (ICWC) Analytic Toolkit for Combating Wildlife and Forest Crimes. For this purpose, an assessment workshop will be held with select government agencies relevant to the enforcement of wildlife and related laws.
