These were pursuant to three (3) Memorandum instructions dated 21 February 2022 signed by then Undersecretary for Field Operations and Environment; 29 June 2021 signed by the Assistant Secretary for Enforcement; and 03 August 2020 signed by then Undersecretary for Field Operations, Enforcement and Muslim Affairs. The use of e-FMS is to resolve the issues on discrepancies, uniform standards, etc. reflected in the submitted physical reports from all DENR Field Offices. Furthermore, after more than two (2) years of preparations for its full adoption and operationalization, the final use of the e-FMS by all DENR Field Offices is recommended to be effective in April 2022.
