

IN BRGY. MAGARA, ROXAS, PALAWAN**

Background Information

On the 10th April, 2022, the Undersigned together with PMRB personnel, Mr. Phing Evio, Mr. Pio Viray and Mr. Marvin Dacacin conducted monitoring of mining activities in the Municipality of Roxas, Palawan. The team intercepted one (1) topdown loaded with sixteen (16) sacks of Sand and Gravel (SAG) materials in Brgy. Magara, Roxas, Palawan.

Findings and Observation

1. At 4:30 pm, the team intercepted one top-down hauled with 16 sacks of Sand and Gravel materials. The conveyance has no registered plate number (Photo 1).
2. The undersigned interviewed Mr. Rejhon Bundac. He stated that his family owned the top-down used for the transport of SAG materials. He insisted that the transport was made only during the day of the apprehension (Sunday, April 10, 2022).
3. The hauled SAG materials were supposed to be delivered to a certain Mr. Andong Badenas, Mr. Rejhon Bundac added.

4. Mr. Rejhon Bundac is a minor 16 years of age. The undersigned suggested that it would be best for Mr. Rejhon to contact his guardians and explain their side to the apprehending team.
5. Mrs. Corazon Mirano, guardian of Mr. Rejhon Bundac arrived at the Brgy. Hall of Magara.
6. Mrs. Mirano pleaded that the operation and transport were only done during the day of the apprehension. She claimed that the area of the source materials is titled. The disposition of the SAG materials was intended to be used for an additional funds for the face to face classes.
7. The undersigned explained to Mrs. Corazon that an extraction and commercial disposition of SAG materials without securing proper quarry permits is deemed to be illegal.
8. The apprehended conveyance is given custody to the Brgy. Magara (Annex).

FINDINGS AND RECOMMENDATIONS

1. Based on the field findings, Mrs. Corazon Mirano was found to be in violation of Section 103 of RA 7942, otherwise known as the Philippine Mining Act of 1995, which provides:

Section 103. Theft of Minerals – Any person extracting minerals and disposing the same without a mining agreement, lease, permit, or license or steals minerals or ores or the products thereof from mines or mills or processing plants shall, upon conviction, be imprisoned from six (6) months to six (6) years to pay a fine from Ten thousand pesos (P 10,000.00) to Twenty thousand pesos (P 20,000.00), or both at the discretion of the appropriate court. In addition, he shall be liable to pay damages and compensation for the materials removed, extracted, and disposed of.

A Cease and Desist Order must be issued to affect the same



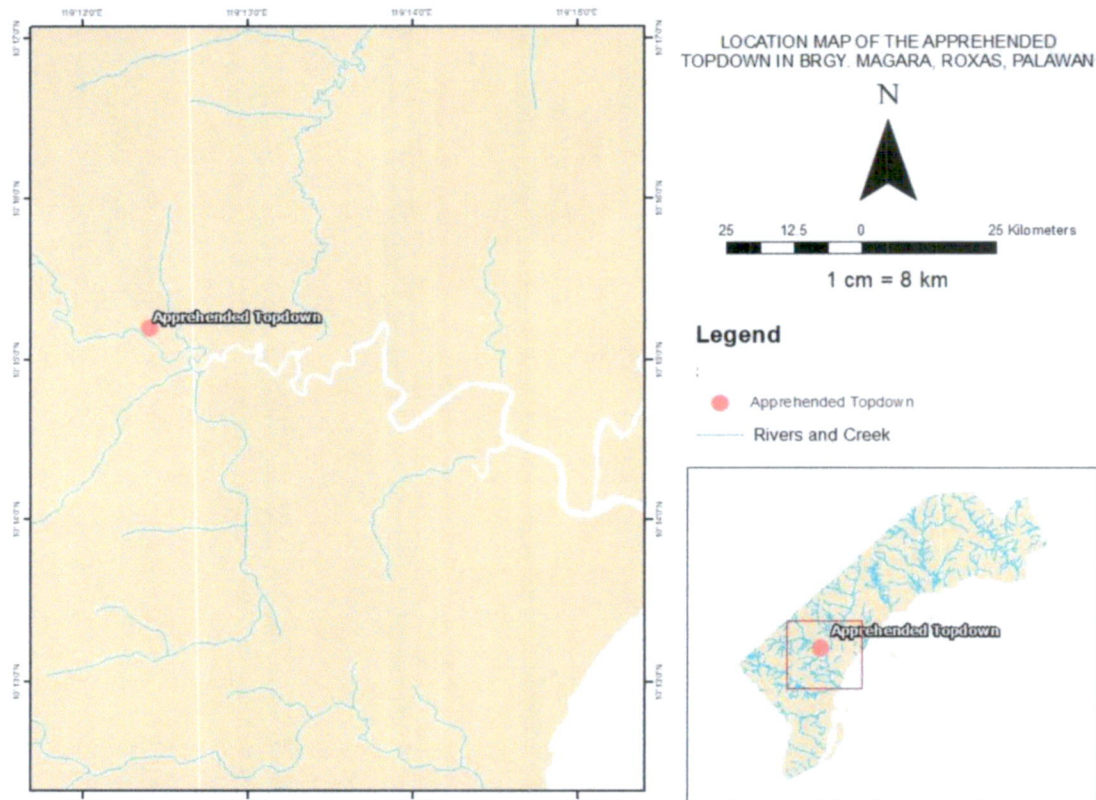
