This refers to the series of Memoranda being received by the Forest Management Bureau (FMB) relative to the submission of numerous MOVs for the Forest Land Use Plans (FLUPs) being formulated by the Local Government Units (LGUs) with the assistance of the Regional Offices, visà-vis FMB Memorandum dated 14 July 2014 (copy attached) requiring the Regions to furnish FMB copy of the approved FLUP.

It was further observed that most of these submissions are partial MOVs and other required documents in the FLUP formulation and adoption. It must be noted that based on existing guidelines, an approved FLUP must have the complete attachment of its MOVs, such as but not limited to: the Letter of Intent, Memorandum of Agreements between DENR and concerned LGU (formulation and adoption), Sangguniang Bayan Resolutions, Executive/Special Orders, Work and Financial Plans and Approval/Affirmation Sheets.

Taking into account our efforts to embrace innovations in public service, and to properly evaluate and archive the submitted plans, please furnish the FMB a soft copy of the approved FLUP, in portable document format (.pdf), with its entire required attachments, including MOVs for that matter, and refrain from partial submission of the same.

Consistent with section 5 of DENR-DILG Joint Memorandum Circular No. 2003-01, step 6 of the FLUP process as indicated in FMB Technical Bulletin No. 2, is hereby amended as follows:

Step 6. FLUP Approval

Upon endorsement of the Sanggunian, the DENR-RD approves the FLUP and thereafter, the DENR-RD and the Mayor executes a MOA for the joint implementation of the FLUP, with the DILG Regional Director as witness. The MOA emphasizes the roles and responsibilities of the LGU and the DENR, their joint partnership and complementation and resources sharing towards the plan implementation. The FLUP shall need to be enacted as an ordinance by the Sanggunian as part of their CLUP.

The DENR- RD shall furnish the FMB a copy of the approved FLUP.
