Respectfully referred herein transmittal letter sent thru email dated 11 April 2022, from Dir. Jaime Llaguno Mabilin, Presidential Complaint Center (PCC), bearing Code No. **WG-AKA-04-11-2022-011**, forwarded to OIC DENR Secretary Jim O. Sampulna, indorsed to the Head Executive Assistant, and further conveyed to the DENR Action Center/Hotline endorsing the letter of Mr. Conrado B. Idia of Sitio Gotok, Sandoval, Bataraza, Palawan, dated 11 April 2022, addressed to President Rodrigo Roa Duterte pertaining to his request seeking assistance on awarding him the “signed” land title over the 33,366-sq.m. parcel of land in Brgy. Iwahig, Bataraza, Palawan for which he initially applied for in 2012. Accordingly, his application was pended without signature due to the titling ban in 2015, for which your Office promised the requesting party to immediately release the signed titled once the suspension is lifted. The titling ban is already lifted in Palawan starting 02 March 2020, however, Mr. Idia claims that until now no signed land title was issued to him and that he was purportedly advised to re-apply for the said document. Hence, he is requesting for assistance, consistent with existing laws, rules and regulations to immediately resolve his request as this has gone for 10 long years already.

Kindly inform directly the requesting party of action taken in this regard furnishing the PCC, HEA, and this Office for monitoring/reference purposes. Expeditious action is requested in accordance with the provisions of Republic Act No. 11032, otherwise known as the Ease of Doing Business and Efficient Government Service Delivery Act of 2018 as implemented and enforced by the Anti-Red Tape Authority. Please be reminded that failure to timely respond to the public’s concern shall be ground for administrative sanctions under existing laws and regulations.

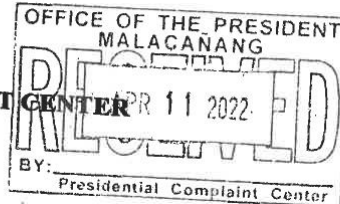
