Good day sir.

This letter is in connection with the show cause memorandum dated April 13, 2022 from your Office regarding the report on the alleged / observed irregularities in the issued documents to Matias Cortuna relative to the apprehension of undocumented forest products (14,047.75 Board Feet) at So. Pakil, Brgy. Cabacao, Abra de Ilog, Occidental Mindoro that I received on April 22, 2022.

I prepared the map using Arc GIS Software based on the Technical Description of CLOA, Geotagged Pictures and instructions given to me by Mr. Joseph Panganiban.

Mr. Joseph Panganiban approached me asking for help in preparing the map of Matias Cortuna. According to him the first map that I submitted to him was declined by the higher authority due to the incomplete details, then, he came back to me for the rectification of the map which he said that is required to insert the pictures showing the first and last tree inside the area of CLOA. When I overlayed the pictures in the Arc GIS software, I informed him that the pictures were falls outside of the area of CLOA, he said that the trees were planted by the 'katutubo' and he instructed me to insert the geotagged pictures of first and last tree and insisted to reflect it in the map.

I followed his instructions considering that he is a permanent personnel of this agency which expected to do the righteous act in terms of doing the public service. I have no intention in participating in any forms of irregularity activities, in line with this issue I just assisted him in preparing the map based on the data and instructions given to me by Mr. Panganiban.
