I had applied for the title 20 yrs ago but was not process my title application because of the complaint of Belinda Rabang (see attach Annex A) that was not investigated but favor the Rabang, and had their lot titled in my subdivision plan as lot no.7 (see attach annex B)

About 20 yrs. later they are instructed by the late CENRO Garaez last May and December 2021 to submit their credentials to prove their claim but they had none to provide to prove the validity of their allegations. Therefore, the claim was set aside.

The case in court against the Rabang is Civil Case 177 for forcible entry and damages.

I believed directly or indirectly some CENRO personnel was involve.

I am hoping and praying for a long time that investigation be done.

1. Mr. Anthony Sumibkay a CENRO personnel who was recommend by CENRO Roxas personnel who received the P20,000.00 payment from me with receipt, signed and claimed to be Engr. Mondoniedo when he received money. (See Attached Annex C)
2. For the signatories, for the withholding of the process of my title, due to the complaint of Belinda Rabang which Christine Sendayen record officer, identified as Mr. Ronnie Lelang and Hilario Regundola.
3. In April 6,2021, we are called for a hearing by Mr. Dela Peña and Luciene Gandeza, but they did not make a transcript even with my inquiry before we start the hearing. (See attached Annex D)
4. On May 23,2021,the Rabang family forcibly enter my property lot.6.In the *sinumpaang salaysay panghukuman* of Mildred Rabang Casencia she stated that they are advised by Jorge Dela Peña LMS11 Land Investigating Officer of CENRO Roxas, to clean the area and later they put fence taking advantage of the heights of pandemic. (See attached Annex E)
5. In the CSW report to CENRO Cruz, of the forest rangers submitted the inventory of cut trees and recommended for administrative hearing due to the fact that PD 705 and RA7161 was violated but I was not summoned to attend. (pls. see attached F) Mildred Cacencia mention that the cut trees used as post is from other area. My question is, “did she present permit from DENR to cut trees?”
6. Enclosed is the copy of the sworn statement of CENRO CRUZ for your guidance and evaluation. (See attach Annex G)
7. Lot no.8 was from our land and it has its own technical description. It was intended for our own use and beside it has a dead end and not connected to adjacent lots.
8. With regards to my donation of 5000 sq m. to the LGU of Port Bartun we have an arrangement that I will identify the area as soon as my title is released.






SUBJECT : **VERIFICATION AND SCALING REPORT ON THE REQUEST OF MS. MARLE JARANILLA RE: CUTTING OF TREES USED AS BARB WIRE POST IN FENCING LOT NO. 6 SITUATED IN BARANGAY PORT BARTON, SAN VICENTE, PALAWAN.**



Please be informed that on July 6, 2021 the undersigned proceeded to Barangay Port Barton, San Vicente, Palawan to conduct verification on the cut trees requested by Mrs. Marle A. Jaranilla to be scaled.

Based from the letter request of Mrs. Jaranilla dated June 24, 2021 the trees were cut by Belinda Rabang and family in order to be used as barbed wire post to fence Lot No. 6.

Around 11:00 AM the undersigned together with Barangay Tanods Mr. Dennis Austria and Mr. Maximo Batistel, Mr. Anatalio Hinayon representative of Mrs. Jaranilla, and Mrs. Mildred Rabang Casencia daughter and representative of Mrs. Belinda Rabang, are all gathered outside the fence while the undersigned is conducting inspection of the wood used as barbed wire post therein and also conducting interview to Mrs. Casencia.

The undersigned noticed that the said wood used as barbed wire post is Putat in local name, under the group of Miscellaneous Species, in saplings sizes, and observed that the woods were cut a year ago which some of these woods are showing decaying process. During interview, Mrs. Casencia mentioned that the wood used as barbed wire posts during the installation of the fence was acquired from the approved Tree plantation of Mr. Florentino Casencia situated in So. Pamuyan also jurisdiction of the same Barangay, the said wood were affected during the cutting and felling of Mangium trees. *(Please ask for the permit of Mr. Casencia to all trees in Pamuyan.)*

The team entered the fenced area with permission given by Mrs. Casencia for verification of the undersigned on the stump of cut trees used as barbed wire posts of the fence as stated in the letter request of Mrs. Jaranilla. The undersigned inventoried cut poles of Basa, Bunot-bunot, Putat, and kansilay species, these said cut poles were stack near its stumps and not used as barbed wire posts of the fence.

According to Mrs. Casencia, during their hearing/meeting last April 6, 2021, they volunteered on the cleaning of the area for the inspection of the personnel of this Office.

Based from the actual verification of the undersigned in the area, the abovementioned cut miscellaneous saplings and poles inside the area were not utilized as barbed wire posts of the fences, and the used posts of the barbed wire in the fences have the possibility that they were obtained from another area because there were only few stumps seen inside the area. *Please verify their permit.*

The undersigned observed that Section 77 of Presidential Decree 705 as amended by Republic Act 7161 was violated in the cutting of the mentioned poles and the wood us as barb wire post. The undersigned hereby recommend that administrative hearing must be conducted for the both parties to determine the perpetrators. *No notice of hearing received by Jaranilla*

**JUDICIAL AFFIDAVIT OF
PABLO I. CRUZ**

This Judicial Affidavit of **PABLO I. CRUZ**, as a witness for the Plaintiff in the above-named case is executed to serve as his direct testimony.

This Judicial Affidavit is being offered to show and prove that:

1. Plaintiff is the approved claimant of Lot 6 and awaiting the issuance of her certificate of title.
2. Defendants have failed to comply with the CENRO directive to present relocation survey results by a competent surveyor in May 11, 2020 and December 14, 2020 despite all the opportunities to do so;
3. Defendants have no documentary evidence to prove their claim over a portion of Plaintiff's Lot 6.
4. The land dispute between the parties in the above-named case has already been disposed of and terminated after Defendant has failed twice to comply with the requirements by the CENRO:

- Page
5. Plaintiff's son reported the matter of Defendants' acts of entering Plaintiff's Lot 6 on June 7, 2021.
 6. Witness' office informed Plaintiff that she will just have to await the lifting of the moratorium on the titling of private lands in San Vicente.
 7. Other matters related to the foregoing.

This Judicial Affidavit was taken at the office of ATTY. JULIUS M. CONCEPCION, numbered consecutively, and each question is followed by the answer of the witness.

1. Q: Do you swear to tell the truth, the whole truth and nothing but the truth?
A: Yes, sir.
2. Are you aware that you could be subject to prosecution for perjury if you state any untruth in this affidavit?
A: Yes, sir.
3. Q: Please state your name and other means of your identity.
A: I am **PABLO I. CRUZ**, Filipino, of legal age, married, and holding office at the Community Environment and Natural Resources Office (CENRO), Brgy. III, Roxas, Palawan.
4. Q: How long have you been connected with CENRO-Roxas?
A: I was promoted as the Community Environment and Natural Resources Officer (CENR Officer) of Roxas and San Vicente on November 5, 2022. I likewise assumed the position as CENR Officer only on January 3, 2022.
5. What is the reason why you are executing this judicial affidavit if any?
A: I have been ordered by the MCTC of Taytay and San Vicente to testify in the case of Marle Jaranilla vs. Rowena Rabang et al. regarding the identification of the Memorandum dated February 8, 2022 with the subject "Completed Staff Work (CSW) Re: Follow-up of letter Complaint from Marle A. Jaranilla, PPC Code No. GI-GDP-12-04-2020-1180 (July 28, 2021).
6. What is the most recent incident in your records in relation to the said parcel of land, based on the records, if there is any?
A: Based on our records, on June 7, 2021 the CENRO-Roxas received an email complaint Paul Hudson Acha Jaranilla, stating therein that the Rabang family violated what was agreed upon during their hearing in CENRO-Roxas, last April

7. Q: What was the agreement by the said parties in your office prior to that, if any?
A: I have no personal knowledge as to their agreement since I was only appointed CENR Officer and was transferred to CENRO-Roxas last January 3, 2022.
8. Q: What else did Paul Jaranilla state in his report, if any?
A: Based on the e-mailed complaint dated June 7, 2021, Mr. Jaranilla requested this Office to stop the Rabangs from cutting their trees and fencing their Lot 6.
9. Q: What did your office do if any?
A: Based on the submitted Memorandum dated July 12, 2021, with subject Verification and scaling report on the request of Ms. Marle Jaranilla, on July 6, 2021, the CENRO-Roxas team launched an investigation on the complaint of Mr. Jaranilla and the team found out that there were cut poles near the tree stumps in the subject area.
10. Q: What else did the team from your office do, if any?
A: Based on records, the team inventoried trees cut and checked the barbed wire posts which were used as fences.
11. Q: What did they find out, if any?
A: Based on their report, the team found out that the barbed wire posts the Rabang family used were old posts brought from another area since the number of posts did not match the tree stumps seen in the subject area.
12. Q: What else did your office team do, if any?
A: Based on their report, the team stated that they interviewed Mildred Rabang-Casencia, daughter and representative of Mrs. Belinda Rabang, who said that they indeed got the barbed wire posts from the approved tree plantation of Mr. Florentino Casencia.
13. Q: What else happened, if any?
A: Based on the records, on July 12, 2021, the CENRO-Roxas received an e-mail from Marle Jaranilla requesting for a copy of the scaling report of the trees cut but due to some regulations requiring us to conduct further investigation we were not able to grant her request immediately.
14. Q: What are the incidents in the history of the land of Marle Jaranilla, based on the records, if any?
A: Based on the letters dated March 11 and April 22, 2020, received by the Office, Ms. Marle Jaranilla complained of the fact that she requested and paid for a survey of her land

the one immediately bounding the property of one Belinda Rabang.

15. Q: What happened to her application based on your records, if any?

A: Based on the records, her application was put on hold due to the moratorium on public land titling.

16. Q: What else happened based on your records, if any?

A: Based on records a certain Belinda Rabang is claiming the land. On May and December 2020, our office, through the then CENRO Emer Garraez, informed Belinda Rabang of the requirements for a formal protest against public land application.

17. Q: What else happened based on your records, if any?

A: Up to this date, there is no record of Belinda Rabang filing and complying with the requirements of formal protest.

18. Q: What did you inform Mrs. Jaranilla about her delayed titling of her Lot 6, if any?

A: We just advised Mrs. Jaranilla to tarry until the prohibition in titling activities in the area is finally lifted, among others.

19. Q: What is the reason for such advice, if any?

A: Because the suspension for the titling activities is not yet lifted by the DENR during that time.

20. Q: Please tell the Honorable Court if you made a memorandum of all that transpired in relation to Marle Jaranilla's Lot 6, if any?

A: I executed a Memorandum dated February 8, 2022 (at this point witness presented a copy of a Memorandum dated February 8, 2022, which is marked as **Exhibit "I" to "I-35"**).

21. Q: Whose signature is this above the name Pablo Cruz in page 3 of the memorandum, if you know (marked as **"I-2-C"**)?

A: That is my signature.

22. Q: Is there anything else you would like to add to your foregoing statements?

A: Yes, the Memorandum dated February 8, 2022, which I signed in my official capacity as the CENR Officer, was prepared by CENRO Roxas personnel based on the records on file.

Furthermore, the said Memorandum was supposedly intended as an interdepartmental communication as it was addressed to the PENRO. Moreover, it serves as our Office answer/reply to PENRO Memorandum dated February 2, 2022, requiring us

to explain in writing the actions and responses that have been taken by this Office to address the 8888 complaint of Ms. Marle Jaranilla.
