This has reference to a complaint received by this Office on 30 March 2022 from Mr. Gene Fornal against the sand and gravel extraction project of Mr. Dennis F. Foja located at Sitio Aurora, Brgy. Pato-o, Odiongan, Romblon. The said project is allegedly affecting not only the livelihood of its surrounding communities but also the environment. Attached in this memorandum is a copy of the letter complaint for your ready reference.

Based on records, Mr. Foja has been granted an Environmental Compliance Certificate (ECC-OL-R4B-2019-0175) for a sand and gravel extraction project located at Brgy. Pato-o, Odiongan, Romblon on 5 July 2019.

Relative thereto, you are hereby directed to conduct an **immediate inspection** on the above-mentioned complaint **within forty-eight (48) hours** from receipt of this Memorandum taking into consideration the compliance of the project operations with the conditions and restrictions set in the ECC in coordination with the complainant, local government unit, and other agencies concerned.

A report with your categorical recommendations shall be submitted to this Office within forty-eight (48) hours from the conduct of inspection.
