Respectfully referred herein letter sent thru email dated 18 February 2022, addressed to the Presidential Complaint Center (PCC) thru Dir. Jaime Llaguno Mabilin, bearing Code No. **PM-GDP-03-07-2022-017 (DENRCO-AS RMD-2022-007318)**, transmitted to OIC DENR Secretary Jim O. Sampulna thru the Head Executive Assistant, and further conveyed to the DENR Action Center/Hotline from Mr. Servillano Valiente, Jr. of Sitio Cambiswer, Brgy. Poblacion, Calintaan, Occidental Mindoro pertaining to his request seeking assistance on his land problem situated at Sitio Cambiswer, Brgy. Poblacion, Calintaan, Occidental Mindoro. Mr. Valiente claims that the 10-hectare parcel of land is being occupied and cultivated by him and his family since 1969 and that they applied for a Certificate of Stewardship Contract (CSC) for it dated 17 May 1987 under CSC No. 041-701903. However, upon their request for renewal in 2009, "DENR-CENRO" declined and that the claimants were advised to plant the subject lot with 10,000 Gmelina trees per hectare. Accordingly, in 2017, "DENR-CENRO" sold the original CSC to a certain Mr. Unisan Madayag, leading to the latter's fencing of the subject lot and harvesting of the Gmelina trees which were planted and nurtured by Mr. Valiente and his family. With this, he seeks for appropriate actions, consistent with existing laws, rules and regulations to immediately resolve this concern and in order to reclaim their rightful proprietorship over the subject lot.

Kindly inform directly the requesting party of action taken in this regard furnishing the PCC, HEA, and this Office for monitoring/reference purposes. Expeditious action is requested in accordance with the provisions of Republic Act No. 11032, otherwise known as the Ease of Doing Business and Efficient Government Service Delivery Act of 2018 as implemented and enforced by the Anti-Red Tape Authority. Please be reminded that failure to timely respond to the public's concern shall be ground for administrative sanctions under existing laws and regulations.
