Respectfully referred herein undated letter sent thru email addressed to President Rodrigo Roa Duterte thru Dir. Jaime Llaguno Mabilin, Presidential Complaint Center (PCC) bearing Code No. PM-CAM-03-09-2022-054, transmitted to OIC DENR Secretary Jim O. Sampulna, indorsed to the Head Executive Assistant, and further conveyed to the DENR Action Center/Hotline from Mr. Gerry Cebuano of Sitio Carig-Carig, Cabugan Island, Brgy. 1, Roxas, Palawan pertaining to his complaint against OIC-CENRO Ronnie B. Gandeza and CENR Employee Ronnie B. Lilang for their alleged administrative incompetence as public officials, ignorance of the law, and alleged harassment. Accordingly, the said officials had executed a one-sided decision over an ongoing case involving parcels of land in Cabugan Island where an applicant for survey authority for the subject lot was allegedly denied by the CENRO in favor of a certain Mr. Sorgio Pellena; while CENR Officer Gandeza allegedly supported a Notice to Vacate of a certain Mrs. Margie Salaber with an ongoing land case. Hence, Mr. Cebuano is requesting for the dismissal from service of the said CENRO employees which merits for your appropriate actions, consistent with existing laws, rules and regulations.

Kindly inform directly the requesting party of action taken in this regard furnishing the PCC, HEA, and this Office for monitoring/reference purposes. Expeditious action is requested in accordance with the provisions of Republic Act No. 11032, otherwise known as the Ease of Doing Business and Efficient Government Service Delivery Act of 2018 as implemented and enforced by the Anti-Red Tape Authority. Please be reminded that failure to timely respond to the public's concern shall be ground for administrative sanctions under existing laws and regulations.





Sir:

This is in connection with the letter we received from your office dated September 21,2020 informing us that our settlement in Sitio Carig-Carig, Cabugan Island is within the easement zone and therefore we were advised to vacate the area to avoid necessary charges.

In this connection, we would like also to inform you that we were here in Cabugan Island for the past 30 years and we didn't know any destruction made by us. We didn't destroy/abused any natural resources in the locality. We are not disastrous people. We had raised our family here and the only means of living we have is through legal fishing.

Relative to this, the government has extended its assistance to us by providing Elementary School for our children's basic educational needs. We think this is one way of recognizing us as legal settlers in this Island. It is not so easy for us to have our houses be demolished. We think that this matter should call the attention of our local Government Unit headed by our Municipal Mayor Hon. Dennis Savando. If ever the Sangguniang Bayan will approved It, there should be a relocation site for us (R.A. 7279 Sec. 28.) If none, where are we going to? And besides, your decision is contradicting the Bayanihan? Heal As One Act stating that we should act as one in order to survive in this worldwide life threatening pandemic situation.

Furtheremore, we were also confused;

- 1. Why was it is that only Cabugan Island residents had received this kind of letter? Whereas, in the same manner, Johnson Island and Green Island residents have also the same situation like ours.
- 2. If the reason is, it is easement zone, then, why is the letter sent selectively. Why Mr. Pellena not included in that letter.
- 3. During the site visit, inspection, and demarcation of easement conducted by the personnel in your office last July 17, 2020 they said that they relocated the area of Mr.& Mrs. Pellina for them to know exactly the boundary of their area (to know if it is easement zone) But why did we received the letter the fact that our area was not included during inspection.
- 4. Lastly, If this letter is from your office why are the letter addresses to wrong names, some are only neck names. We doubt this is just intimidation of those people who are interested this island.

We are hoping so much for your kind consideration regarding our plight
