- 1. Reduced costing and target:
 - a. Php 5M (R7)
 - b. Php 1.5M (NCR and the rest; regions to determine activities to be funded; minimum target: 300,000 seedlings)
- 2. Indicate where the seedlings will be utilized
 - a. For seedling distribution (T1+)
 - b. For new plantation establishment (T1)
 - c. For maintenance and protection (T1)
 - d. For graduated NGP sites adopted by partners (for separate discussion)
- 3. For use in PA
 - a. Seedlings should be endemic / indigenous species
- 4. For use in plantation establishment
 - a. Ensure that areas are already subjected to SMP



GRADUATED NGP AREAS FOR ASSESSMENT AND INVENTORY

Coverage: 2011-2016 NGP Sites

1. To cover areas below 100 ha

2. Unit Cost: P 2,000.00/hectare*

3. Methodology:

a. Sampling Intensity:

i. All sites

ii. 1-20 ha = 100% intensity

iii. Above 20 ha = 5% intensity or 20 ha (whichever is higher), 100% inventory within sample plots

b. Inspection Chart Mapping

Count and coordinates of standing trees per commodity

- Ave. height

Ave. diameter

 Assessing quality of plantations planted with seedlings from MMFN, PO-produced, clonal nurseries

4. Output
