NIDO BAY WQMA (BENB WQMA)

Pursuant to the Section 5 of the Implementing Rules and Regulations of Republic Act 9275 or the Philippine Clean Water Act of 2004, the Department of Environment and Natural Resources (DENR) in coordination with the National Water Resources Board (NWRB) are mandated to designate water quality management areas (WQMA) using appropriate physiographic units such as watershed, river basins or water resources.

In view thereof, the Environmental Management Bureau – MIMAROPA Region has a new WOMA in addition to the already three existing and operational WQMAs within the region. The latest addition was the designation of Bacuit Bay and El Nido Bay in El Nido, Palawan as Water Quality Management Area through the enactment of Department Administrative Order 44 series of 2021 (DAO 2021-44), dated 23 December 2021.

In compliance to the Section 4 of this DAO, this Office would like to request for the names of your permanent and alternate representatives to the Governing Board of the Bacuit-El Nido Bay WQMA.
