Activity : **MPAN Consultation 2022**

Date : **19-23 September 2022 (including travel time)**

Venue : **Metro Manila (venue to be confirmed)**

Background:

As part of the target outputs of the Coastal and Marine Ecosystems Management Program (CMEMP), which main objective is to holistically address the drivers of coastal and marine degradation, the establishment and strengthening of MPA networks is being promoted and conducted to optimize the protection of our coastal and marine habitats and resources as well as to enhance the ecosystem services and benefits that we derived therein.

MPA networking is already being recognized as a strategy to achieve higher biodiversity conservation goals/ targets which include the Philippine Development Plan, Philippine Biodiversity Strategic Action Plan, Aichi Targets and the Sustainable Development Goals. Meanwhile, ongoing discussions with regard to the formal recognition of MPA networks as Other Effective Area-based Conservation Measures (OECM) are also being done. OECMs are already included in and supported by RA 11038 (ENIPAS Act).

While previous capacity-building activities have been done (e.g. MPAN Open Distance Learning) as well as materials being disseminated (e.g. MPAN Toolkit), majority of the field implementers still need further clarification on the process and considerations involved in MPA networking. With this, the Biodiversity Management Bureau conducted a 2-day consultation and leveling-off workshop for the DENR Regional and Field Offices staff last October 2021 via Zoom.

This year, the Bureau aims to update and complete/validate the data for MPANs through the conduct of an MPAN Consultation on September 19-23, 2022, through a face-to-face meeting in Manila.

Objectives:

1. Present the importance of MPAN;
2. Present current list and roadmap of MPANs, frequently-inquired questions
3. Present regional presentation and challenges
4. Present and review steps in establishing MPAN
5. Refine MPAN thresholds
6. Refine MPAN costing
7. Rollout MPAN online group and database
