INFORMATION

The undersigned hereby accuses **RODOLFO O. BERNARDO** of **UNLAWFUL OCCUPATION DESTRUCTION OF FOREST LANDS AND GRAZING LANDS UNDER SECTION 78 OF PRESIDENTIAL DECREE 705**, committed as follows:

That in or about the year 1996 and subsequently thereafter, at the sand bar/lagoon area of the Snake Island in Barangay Manalo, Puerto Princesa City, Philippines and within the jurisdiction of this Honorable Court, the said accused, without any lawful authority, lease, license or permit from the appropriate government agency, did then and there wilfully, unlawfully and feloniously enter, possess and occupy an area thereon which is an unclassified public forest land and declared a National Coastal and Marine Center for Research (NCMR) per DENR Administrative Order No. 2011-12 dated November 3, 2011, and once in occupation thereof, said accused built and rebuilt illegal structures thereon without first securing the necessary permit and/or license from the authorities concerned and when ordered to vacate, he failed and refused and continuously fails and refuses to do so, to the damage and prejudice of the government.


