This is in reference to the Memorandum issued by For. Anastacio A. Santos, MPA, CENRO - Sablayan, Occidental Mindoro and received by this Office on 20 June 2022, recommending for the issuance of a Cease and Desist Order against DPWH MIMAROPA relative to the implementation of the Mindoro Cross Island Road Project located at Brgy. Pag-asa, Sablayan, Occidental Mindoro.

Based on records, DPWH - MIMAROPA has already settled the penalty amounting to FIFTY THOUSAND PESOS (Php 50,000.00) on 07 September 2021 as evidenced by the Resolution issued by this Office on 22 September 2021. In addition, the project was also ordered to suspend its implementation, until and unless a valid Environmental Compliance Certificate (ECC) has been issued in favor of the project.

Relative thereto, you are hereby directed to conduct an immediate inspection on the abovementioned project within forty-eight (48) hours from receipt of this Memorandum taking into consideration its compliance with the suspension order issued by this Office and the status of its ECC application.

A report with your categorical recommendations shall be submitted to this Office within forty-eight (48) hours from the conduct of inspection.
