DMCI POWER CORPORATION (DPC) IN COMPLIANCE WITH THE TERMS AND CONDITIONS STIPULATED IN THE ECCs ISSUED TO

Forwarded herewith the Memorandum of Agreement made and entered into, by and between the DENR-CENRO Quezon and DMCI Power Corporation (DPC), represented by Engr. Rolando Antonio Chavez, Jr.

Please be informed that on July 12, 2021, the Memorandum of Agreement between the CENRO Quezon and the DMCI Power Corporation was signed at DENR-CENRO Quezon, Palawan, The said MOA is in compliance with the terms and conditions stipulated in ECC No. R4B-1703-00100 located at Bgy. Bato-bato, Narra, Palawan and ECC No. ECC-R4B-1803-0004 located at Bgy. Tabon, Quezon, Palawan that the DPC must establish reforestation and carbon sink program in Palawan using endemic/indigenous species in area equivalent to their project area, hence, ten (10) hectares area located at Bgy. Taritien, Narra, Palawan was allocated to DMCI Power Corporation for the said program. The identified area is under the National Greening Program C.Y. 2012 and fall within timberland as per L.C. Map No. 1586 Project 10-D, Block-B.

MEMORANDUM OF AGREEMENT

KNOW ALL MEN BY THESE PRESENTS:

This Memorandum of Agreement (MOA) is made and entered into, by and between:

The DEPARTMENT OF ENVIRONMENT AND NATURAL RESOURCES MIMAROPA REGION with Office address at Bgy. Alfonso XIII, Quezon Palawan, represented by the OIC, Community Environment and Natural Resources Officer LEONARD T. CALUYA.

and

DMCI Power Corporation (DPC), with office address located at NPC Compound, Bgy. Irawan, Puerto Princesa City, Palawan represented herein by its duly authorized representative, Plant Manager, **ENGR. ROLANDO ANTONIO B. CHAVEZ, JR.**

WITHNESSETH

WHEREAS, Executive Order No. 26, series of 2011 institutionalized a National Greening Program (NGP) that harmonizes all greening efforts of all sectors towards poverty reduction, food and water security, biodiversity conservation and climate mitigation and adaptation through social mobilization to plant and grow at least 1.5 billion trees covering about 1.5 million hectares nationwide within forestlands, mangroves and protected areas, ancestral domains, civil and military reservation, urban areas and other suitable areas from 2011 to 2016;

WHEREAS, Executive Order No. 193, series of 2015 or the Extended National Greening Program (eNGP), the National Greening Program is hereby expanded to cover all the remaining unproductive, denuded and degraded forestlands which contribute to environment- related risks such as soil erosion, landslides and flooding and its period of implementation is likewise extended from 2016 to 2028;

WHEREAS, The DENR is mandated to conserve, develop, protect and utilize the natural resources of the Philippines toward economic upliftment and general well-being of the present and future generation and the same time is in the front line of National Greening Program (NGP) implementation;

WHEREAS, the DMCI POWER CORPORATION (DPC), pursuant to its commitment towards environmental sustainability and its goal to help preserving the county's biodiversity in collaboration with the government and other concerned entities, recognizes the relevance of reforestation; and

WHEREAS, the DMCI POWER CORPORATION (DPC), desires to provide conservation and management assistance to the government for the protection of the environment and natural resources particularly by way or establishing and maintaining a total of 10 hectares reforestation project within Barangay Taritien, Narra, Palawan. The identified area is under the National Greening Program C.Y. 2012 and falls within timberland as per L.C. Map No. 1586 Project 10-D, Block-B.

NOW THEREFORE, the parties hereby agree on the following terms and conditions;

A. DENR shall:

- 1. Provide technical assistance and cooperation deemed necessary to ensure success of the project execution; and
- Conduct quarterly monitoring, documentation and evaluation of the Project site to
 ensure that the program's implementation and progress strictly adheres with
 environmental protection and conservation measures and processes; and

3. Upon completion of the activity, the DENR will issue to DMCI Power Corporation (DPC), a Certificate of Completion.

B. The DMCI Power Corporation (DPC), shall:

- 1. Provide manpower, funding and other resources to reforest the 10 hectares of forestland in Bgy. Taritien, Narra, Palawan;
- Provide and plant 17, 500 endemic/native forest trees and 7, 500 bamboo species of seedlings and labor services in the conduct of tree planting activity in coordination with the Office of the DENR;
- 3. Submit to the DENR a progress report on the activities undertaken with photos annually for the period of four (4) years from the planting, maintenance and protection activities:
- 4. Prepare and execute maintenance plan for the period of three (3) years;
- 5. Ensure that at least 85% survival rate of the seedlings planted will be attained; and
- Assist the DENR in the conduct of quarterly monitoring, documentation and evaluation of the said project.

This Agreement shall commence upon signing and shall continue to be valid and binding among the parties, their respective officers, representatives and successors-in-interest for a period of four (4) years there from.

A party shall not transfer or assign this Agreement or the rights or obligations hereunder, without prior written consent and approval of both parties.


