Respectfully referred herein Dumarán, Palawan Municipal Resolution No. 036, series of 2022 sent thru email dated 17 April 2022, coursed thru the Presidential Complaint Center (PCC) thru Dir. Jaime Llaguno Mabilin bearing Code No. **PM-DAVE-06-29-2022-019**, transmitted to the Office of the DENR Secretary, indorsed to the Head Executive Assistant, and further conveyed to the DENR Action Center/Hotline from **the Office of the Sangguniang Bayan, Municipality of Dumarán, Province of Palawan**, represented by its Secretary, **Ms. Hellary A. Pagliawan** reiterating their previous request to reclassify some parcels of land in Dumarán, Palawan from timberland to alienable and disposable lands paving way for its potential use for settlement projects, infrastructure projects, agriculture, and tourism development. Accordingly, we previously referred this concern to CENRO Roxas, Palawan dated 03 June 2021 under PCC Code No. **GL-CYR-05-14-2021-018**, however, the requesting party claims that no resolutions were furnished to them. Hence, this follow-up request, which merits your appropriate action, consistent with existing laws, rules and regulations.

Kindly inform directly the requesting party of action taken in this regard furnishing the PCC, HEA, and this Office for monitoring/reference purposes. Expeditious action is requested in accordance with the provisions of Republic Act No. 11032, otherwise known as the Ease of Doing Business and Efficient Government Service Delivery Act of 2018 as implemented and enforced by the Anti-Red Tape Authority. Please be reminded that failure to timely respond to the public's concern shall be ground for administrative sanctions under existing laws and regulations.
