Referred is the letter dated August 11, 2022 from Atty. Robert A. Chan, Executive Director, Palawan NGO Network, Inc. relative the above subject.

The para-enforcers of PNNI were able to apprehend one (1) abandoned STIHL 070 chainsaw used to cut fresh Ipil tree in the forest of So. Ibangley, Barangay Abongan, Taytay, Palawan on July 28, 2022 without any cutting permit from DENR. The PNNI is requesting us to initiate the necessary administrative proceedings for adjudication and forfeiture of the said chainsaw pursuant to DAO 97-32 and in relation to PD 705, as amended.

The PENRO will facilitate the turn-over of chainsaw (tampered) with Oregon Guide Bar and the original documents (*seizure receipt, pinagsamang sinumpaang salaysay nina Eduardo G. Coroña and Teofilo Tredez and two (2) pieces photographs*) today (August 17, 2022) to the Office of Palawan Council for Sustainable Development at PCSD Building, Barangay Sta. Monica, Puerto Princesa City pursuant to Paragraph 2, Section 9 of RA 9175 or the Chainsaw Act of 2002.

Please find the attached photo copies of seizure receipt, pinagsamang sinumpaang salaysay nina Eduardo G. Coroña and Teofilo Tredez and two (2) pieces photographs with caption for reference and guidance.

In line with this, you are hereby instructed to conduct monitoring, surveillance and further investigation in the area to identify the perpetrators and file criminal case, if so warrant.
