VERIFICATION AND FURTHER AVAILABLE DATA**


Respectfully submitting the control and projected map of Altai Philippines Mining Corporation (APMC) tenement in San Fernando, Romblon produced by this Office which is on continued consolidation of available maps. Based on the projection of our control map, parcel 2 of the approved MPSA overlaps with Mt. Guiting-guiting Natural Park (MGGNP). Accordingly, projected cadastral map shows overlapping lots with the approved MPSA and timberland.

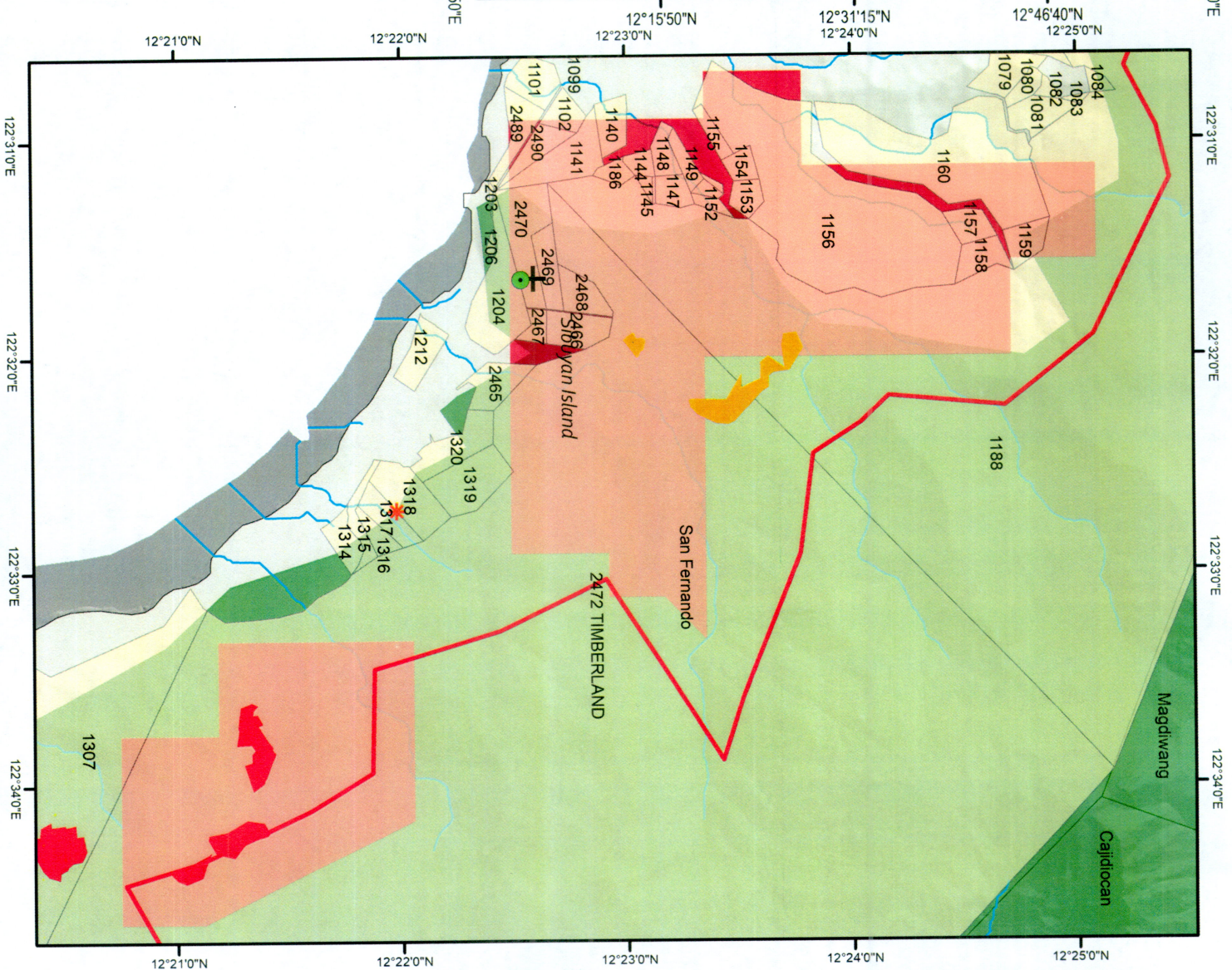
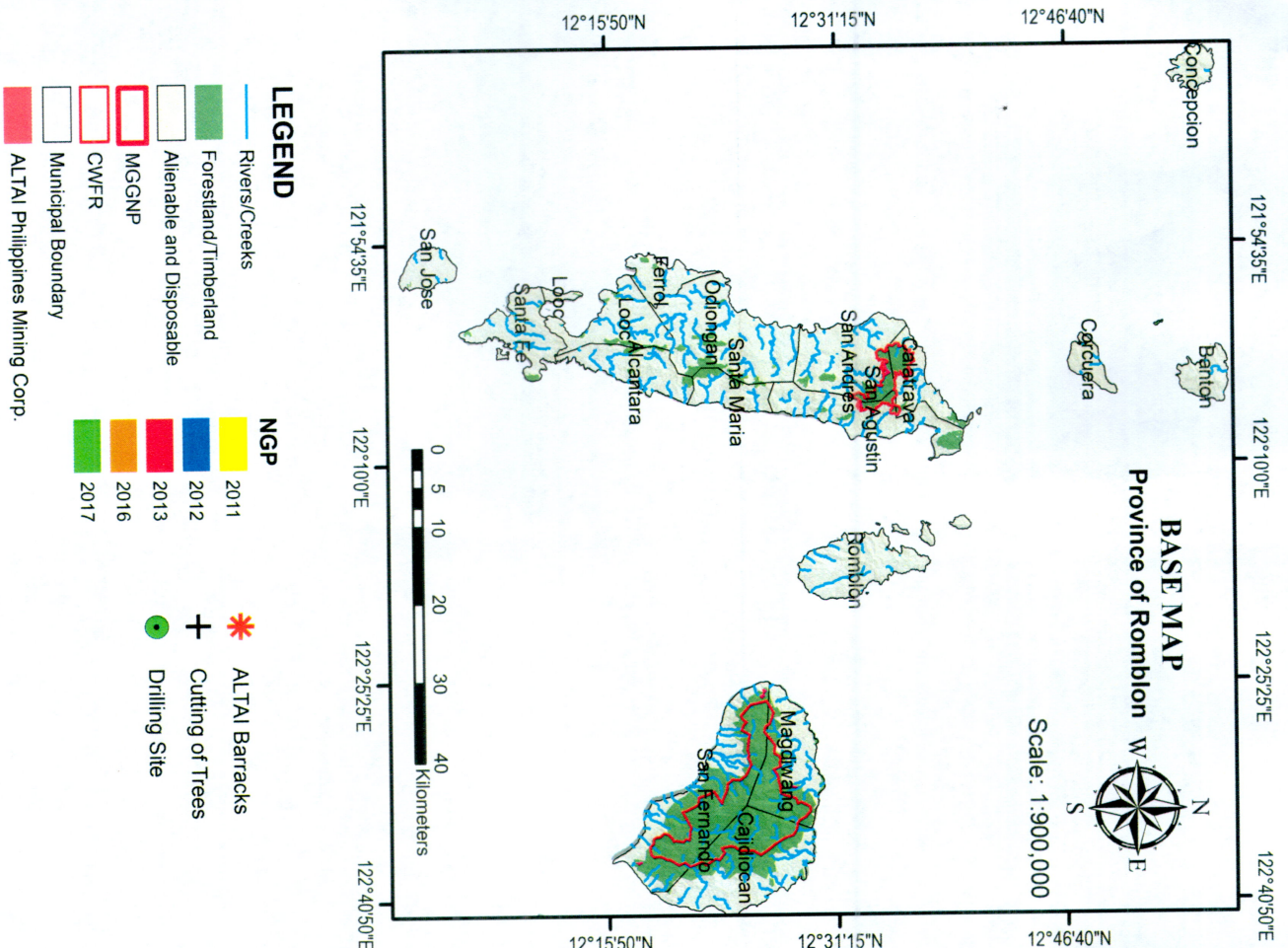
However, a memorandum from The Regional Technical Director for Forestry and The Chief for Land Evaluation Staff dated 14 September 2005 provided by APMC with the subject, *Report on the delineation of 4MCO CBFM area and the proposed 100-meter buffer zone of Mt. Guiting-guiting Natural Park traversing the mining area of ALTAI Philippines Mining Corp. located within the Municipality of San Fernando, Romblon*, showed that there was no encroachment of the approved MPSA with MGGNP. Likewise, 455.88 ha of 4MCO CBFM area falls within the MPSA.

In this regard, we would like to request a verification of these two conflicting maps and provide this Office a copy of shapefiles of the corrected map and the control map of the DENR MIMAROPA Regional Office as basis of our future projection.

Attached is the abovementioned map produced by this Office and memorandum.

Forwarded herewith is the report of Regional Composite Survey Team No. 4 on the above subject which is self-explanatory.

The buffer zone boundary of Mt. Guiting-guiting Natural Park was adjusted from the proposed 100-meter buffer zone boundary due to difficult terrain and inaccessible predetermined points. Thus the buffer zone line exceeds more than 100 meters from the boundary of Natural Park.



In compliance with the Regional Special Order No. 145 dated August 03, 2005, submitted herewith is the narrative report on the extent of 4MCO CBFM overlaps with ALTAI Philippines Mining Corporation (APMC) and the established buffer zone of Mt. Guiting-Guiting Natural Park, situated at Barangays España and Taclobo, San Fernando, Romblon.

Based on the actual field survey, the area of 4MCO CBFM affected by the ALTAI Philippines Mining Corporation (APMC) is 455.88 hectares while the remaining 258.06 hectares falls outside the mining claim.

The established buffer zone boundary line stretches up to 13.154 kilometers parallel along the boundary of Guiting-Guiting Natural Park. However, the proposed 100-meter buffer zone boundary was not maintained on the ground due to rugged terrain and difficult topography. Some predetermined points on the map are not accessible on the ground; hence, monuments were erected to the closest possible points along the boundary of the park. Thus buffer zone boundary line exceeds more than the proposed 100-meter buffer zone.





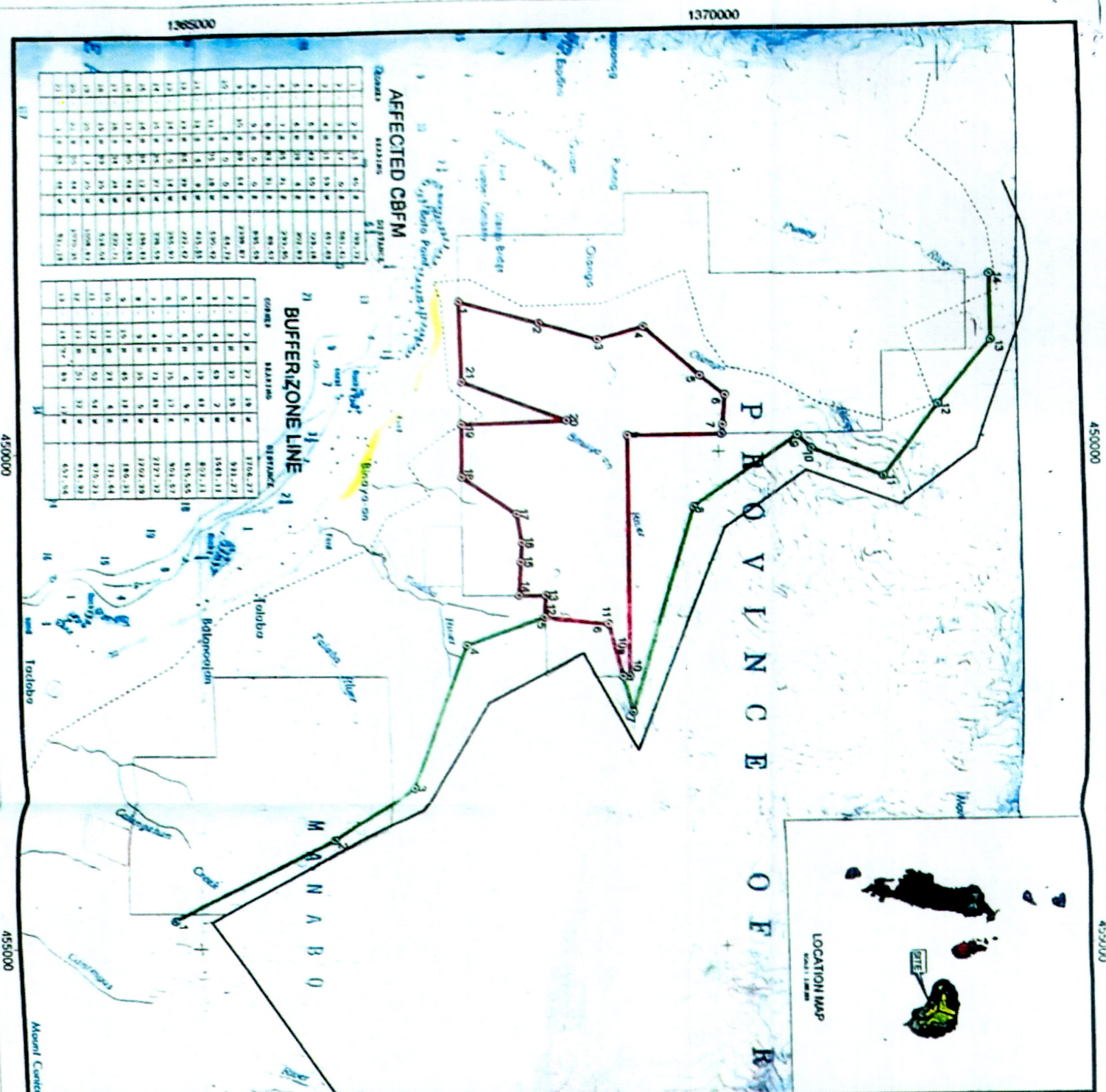

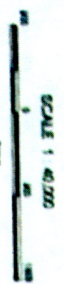
