Respectfully forwarding herewith is the Court **Order** dated 24th of August from Municipal Circuit Trial Court Coron-Busuanga-Gaudencio E. Abordo, Province of Palawan on the case filed against Gil Dador & Brix Dave Dela Cruz under Criminal Case No. 4259 for violation of section 77 of P.D. No. 705 (cutting, gathering and/or collecting Timber, or other Forest Products without License).

On the Court Order, after careful evaluation of the said case, it appears that the Honorable Court Lacks jurisdiction for the consideration of that the market value of the LUMBERS involved and penalties applicable as provided in reference to Article 309 and 310 of the revised Penal Code.

Accordingly, since, the amount involved is THIRTY FOUR THOUSAND AND ONE HUNDRED PESOS, (P 34,100.00) Philippine Currency, the penalty is *PRISION CORRECTIONAL IN ITS MINIMUM AND MEDIUM PERIODS*. Applying the provision of Section 310 of the RPC, *TWO DEGREES HIGHER ID PRISION CORRECTIONAL MAXIMUM to PRISION MAYOR MINIMUM*, a penalty which carries imprisonment of six (6) years and one (1) day up to eight (8) years, which the honorable court clearly Lacks Jurisdiction.

On the matter, for apparent Lacks of Jurisdiction, the case was ordered by the court to be Dismissed without Prejudice to its re filling with proper court.

Pertaining to this case, in reference to memorandum dated August 24, 2022 for the Regional Executive Director, thru the Legal Division, DENR MIMAROPA Region and The PENR Officer, Palawan from the OIC, CENR Officer Calamianes Island, this office requested to seek assistance and advice on the matter.

ORDER

Filed before this Honorable Court is the INFORMATION for Violation of Section 77 of PD 705, as amended, AGAINST the Accused for allegedly POSSESSING and TRANSPORTING 682 BOARD FEET OF AKLE TREE, with an estimated total market value of more or less THIRTY FOUR THOUSAND AND ONE HUNDRED PESOS, (P 34,100.00) PHILIPPINE CURRENCY.

Upon receipt of the Information, this Court has issued an Order finding probable cause and a Warrant of Arrest.

However, after a careful evaluation of this case, it appears that this Honorable Court LACKS JURISDICTION considering the market value of the LUMBERS involved and the penalty applicable as provided under Article 309 and 310 of the Revised Penal Code.

Section 68 of PD 705 as amended, refers to Articles 309 and 310 of the RPC for the penalties to be imposed on violators. Violation of Section 68 of PD 705, as amended, is punished as qualified theft. The law treats cutting, gathering, collecting and possessing timber or other forest products without license as an offense as grave as and equivalent to the felony of qualified theft. (Edwin Talabis, Petitioner, vs. People of the Philippines. Respondent, G.R. No. 214647, March 04, 2020)

Article 309 and 310 of the Revised Penal Code provides:

"ART. 309. Penalties. - Any person guilty of theft shall be punished by:

"1. The penalty of prision mayor in its minimum and medium periods, if the value of the thing stolen is more than One million two hundred thousand pesos (P1,200,000) but does not exceed Two million two hundred thousand pesos (P2,200,000); but if the value of the thing stolen exceeds the latter amount, the penalty shall be the maximum period of the one prescribed in this paragraph, and one (1) year for each additional One

million pesos (P1,000,000). but the total of the penalty which may be imposed shall not exceed twenty (20) years. In such cases, and in connection with the accessory penalties which may be imposed and for the purpose of the other provisions of this Code, the penalty shall be termed prision mayor or reclusion temporal, as the case may be.

- "2. The penalty of prision correctional in its medium and maximum periods, if the value of the thing stolen is more than Six hundred thousand pesos (P600,000) but does not exceed One million two hundred thousand pesos (P1,200,000).
- "3. The penalty of prision correctional in its minimum and medium periods, if the value of the property stolen is more than Twenty thousand pesos (P20,000) but does not exceed Six hundred thousand pesos (P600,000).
- "4. Arresto mayor in its medium period to prision correccional in its minimum period, if the value of the property stolen is over Five thousand pesos (P5,000) but does not exceed Twenty thousand pesos (P20,000).
- "5. Arresto mayor to its full extent, if such value is over Five hundred pesos (P500) but does not exceed Five thousand pesos (P5,000).
- "6. Arresto mayor in its minimum and medium periods, if such value does not exceed Five hundred pesos (P500).
- "7. Arresto menor or a fine not exceeding Twenty thousand pesos (P20.000), if the theft is committed under the circumstances enumerated in paragraph 3 of the next preceding article and the value of the thing stolen does not exceed Five hundred pesos (P500). If such value exceeds said amount, the provisions of any of the five preceding-subdivisions shall be made applicable.
- "8. Arresto menor in its minimum period or a fine of not exceeding Five thousand pesos (P5,000), when the value of the thing stolen is not over Five hundred pesos (P500), and the offender shall have acted under the impulse of hunger, poverty, or the difficulty of earning a livelihood for the support of himself or his family."

Article 310. Qualified theft. - The crime of theft shall be punished by the penalties next higher by two degrees than those respectively specified in the next preceding article, if committed by a domestic servant, or with grave abuse of confidence, or if the property stolen is motor vehicle, mail matter or large cattle or consists of coconuts taken from the premises of the plantation or fish taken from a fishpond or fishery, or if property is taken on the occasion of fire, earthquake, typhoon, volcanic eruption, or any

> other calamity, vehicular accident or civil disturbance. (As amended by R.A. 120 and B.P. Blg. 71. May 1, 1980).

And since the amount involved is THIRTY FOUR THOUSAND AND ONE HUNDRED PESOS, (P 34,100.00) PHILIPPINE CURRENCY, the penalty is PRISION CORRECIONAL IN ITS MINIMUM AND MEDIUM PERIODS. Applying the provision of Section 310 of the RPC, TWO DEGREES HIGHER IS PRISION CORRECIONAL MAXIMUM to PRISION MAYOR MINIMUM, a penalty which carries imprisonment of 6 years and 1 day up to 8 years, which this Honorable Court clearly LACKS JURISDICTION.

WHEREFORE, foregoing premises considered, for apparent LACK OF JURISDICTION, this case is hereby ordered DISMISSED WITHOUT PREJUDICE TO ITS RE FILING with the proper court. The BOND previously posted under O.R. No. 5188039 D and 5188040 D is hereby ordered release in favor of the bondsman.

Let a Copy of this Order of Dismissal be furnished the Office of the Provincial Prosecutor of Palawan for appropriate action.

RESOLUTION

The above-complaint for Violation of Section 77 of PD No. 705, as amended by EO No. 277 and RA No. 7161 was filed by PMSg Gerynn S Lagrada of the PNP Maritime Group, 2nd Special Operations (PNP-Maritime 2nd SOU), Coron Detachment, against respondents Gil L. Dador, Brix Dave D. Dela Cruz and TDD (CICL) and is now due for resolution.

From the complainant's witnesses account, it was alleged that on April 30, 2021, a joint operation was conducted by the operatives from the PNP MG 2nd SOU Coron detachment, DENR-CENRO Coron and members of Busuanga Pasture Reserve Management Office (BPRMO). The operation started after they received an information about illegal hauling of lumber using wooden skid "kadang" which was allegedly taking place in Sitio Matong, Barangay Old Busuanga, Busuanga, Palawan. They then planned and conducted patrol operation to verify such information. While the operatives were patrolling at the place reported at around 5:21 o'clock in the afternoon of April 30, 2021, they happened to see three male individuals who were hauling a long and big "Akle Tree" using three carabaos and a wooden skid. They then approached said men and asked them to put down their bolos. Upon inquiry, the operatives identified said person as respondents Brix Dave D. Dela Cruz, Gil L. Dador and TDDC (CICL). Since there was no permit or authority presented by the respondents, the operatives declared an arrest.

Further investigation disclosed that the total volume and market value of lumber were computed at 1.608 cubic meter or equivalent to 682 board feet of Akle Tree Species with a market value of Php34, 100. 00.

In accordance with the Rules on Criminal Procedure, corresponding subpoena was sent to the respondents in order to afford them sufficient opportunity to controvert the afore-stated allegations. To date however, no such counter-affidavits were submitted by the respondent.

Based from the uncontroverted facts and evidence, it was found out that sufficient ground exists that would engender a well-founded belief that a violation of Section 77 of PD No. 705, as amended was committed by respondents Brix Dave D. Dela Cruz and Gil L. Dador, who acted in a common criminal design to commit such violation. At the time of their apprehension, they were not armed with the corresponding permit or authority issued by competent government agency. Thus, Section 77 of P.D. No. 705, amending the provision of Section 68 thereof, specifically provides that:

SECTION 77. Cutting, Gathering and/or Collecting Timber, or Other Forest Products Without License. Any person who shall cut, gather, collect, remove timber or other forest products from any forest land, or timber from alienable or disposable public land, or from private land, without any authority, or possess timber or other forest products without the legal documents as required under existing forest laws and regulations, shall be punished with the penalties imposed under Articles 309 and 310 of the Revised Penal Code: Provided, That in the case of partnerships, associations, or corporations, the officers who ordered the cutting,



gathering, collection or possession shall be liable, and if such officers are aliens, they shall, in addition to the penalty, be deported without further proceedings on the part of the Commission on Immigration and Deportation.

XXX

From the Certification issued by Ms. Marianne B. Cayupan, Social Welfare Officer I from MSWDO of Busuanga, Palawan, minor TDD acted without discernment, hence, the criminal complaint against him should be dismissed without prejudice to appropriate intervention that might be done by concerned agencies with the active participation of his parents and/or guardian and the MSWDO.

WHEREFORE, IN VIEW OF THE ABOVE, it is recommended that corresponding Information for Violation of Section 77 (formerly Section 68) of PD No. 705, as amended by EO No. 277 and RA No. 7161 be filed against respondents Brix Dave D. Dela Cruz and Gil L. Dador before the proper court.

The complaint against TDD is hereby dismissed for lack of probable cause. Furthermore, let a copy of this resolution be furnished to MSWDO of Busuanga, Palawan for the conduct of appropriate intervention upon minor TDD.

In connection with the above references, please be informed that about 5:21 PM of April 30, 2021, personnel of this Unit led by PMSg Gerynn S Lagrada, PNCOIC, 2nd SOU-MG Coron Detachment under the supervision of PLTCOL ERVIN GLENN U PROVIDO, Commander 2nd SOU-MG together with the personnel of DENR-CENRO Coron led by Elizalde Segundo, Forest Technician 2 and Richard John P Galagate, Project Operation Control Officer, Busuanga Pasture Reserve Management Office and the personnel of BPRMO Busuanga conducted Joint Intel driven operation re- anti-llegal logging operation at the mountainous terrain area of Sitio Matong, Brgy. The minor is the second child among 11 children of Mr. Billy and Mrs. Merlina Dela Cruz. His father is a construction worker and his income serves to support the daily needs of their family. His mother is a plain housewife and responsible to perform household chores. According to him, the incident happened last April 30, 2021 when his uncle arrived in their house and called his elder brother. He just thought that his uncle needs help to get firewood so he left their house together with his uncle and brother. When they were caught by the PNP Personnel, the minor was afraid and not aware that what he did was against the law.

During the interview with the minor, he was observed to be firmed on his statement. He is serious and focused although sometimes he cannot maintain eye-to-eye contact with the Social Worker. He also told to the Social Worker that he is afraid of what will happen to him in the future because he realized that what he did is wrong.

The minor has already the ability to understand what is right and wrong and its consequences but in this case he acted upon without discernment.
