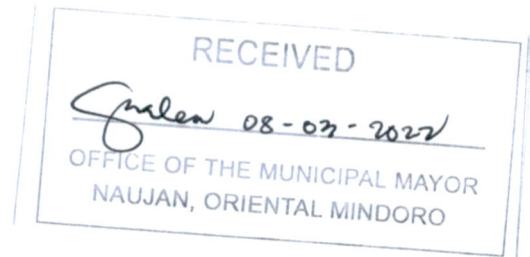

This refers to the attached request<sup>1</sup> dated April 21, 2022 of the Office of the Solicitor General (OSG), through Assistant Solicitor General Ellaine Rose A. Sanchez-Corro and Senior State Solicitor Melanie P. Pimentel, for the service of the Writ of Execution in Civil Case Nos. R-4696, R-4699, R-4701, R-4704, R-4705, R-4707, R-4708, R-4709 entitled *Republic of the Philippines, represented by the DENR versus Ismael Icalla, Virgilio Ramirez, et al.* for Recovery of Possession.

Inasmuch as we would like to be of help in the execution of the final decision, we can only extend our technical assistance in the conduct of the necessary survey to identify the metes and bounds of Proclamation No. 809<sup>2</sup>. On the other hand, we recognize your authority under the Local Government Code and other related laws to initiate the relocation and/or resettlement of the occupants (the defendants in the civil cases) in the reservation, and return the possession of the area to the Mangyans.

In view of the foregoing, we would like to request for a formal meeting with you and concerned barangay officials, together with the lawyers from the OSG, officials from the National Commission on Indigenous Peoples (NCIP), officials and personnel from the PENRO Oriental Mindoro and CENRO Socorro, Oriental Mindoro to ensure the smooth execution of said final decision.
