This pertains to your Memorandum dated 29 July 2022 referring the Memorandum from DENR MIMAROPA dated 27 June 2022 regarding the FY 2022 SPMS indicator on "15% open-access/untenured lands of the public domain placed under appropriate management arrangement/tenure".

Please be informed that the said indicator is not a new target since it was included in the Performance Information stipulated in the General Appropriation Act for the DENR Annual Budget started FY 2017. To accomplish the target, activities on the processing and issuance of tenure instrument/management arrangement is included in the Forestry Sector Unit of Work Measurement (UWM) under the Natural Resources Management Arrangement/Agreement and Permit Issuance. Along with this, we also considered the Comprehensive Site Development (CSD) contracts issued under National Greening Program with maintenance and protection initiatives. Per review of this Office, the DENR MIMAROPA had a total of 28,203.40 hectares placed under appropriate management arrangement covering a period of FY 2017-2020. Out of these, 27,835.19 hectares management arrangement issued through NGP and 368.21 hectares from issued tenure.

Moreover, this indicator is a continuing target for FY 2023-2028 but were reduced to 10% of two (2) million hectares open-access/untenured lands of the public domain placed under appropriate management arrangement/tenure based on the FY 2022 baseline.

Further, on the request to issue or come-up with a guideline on the appropriate management arrangement for those untenured NGP graduated sites, please be informed that we had already existing policy on this. The DENR Administrative Order No. 2021-20, "Guidelines in managing untenured forestlands with plantations established through government funds" issued on 30 June 2021 aims to (a) place parcels of forestland that were developed as plantations using government funds under any appropriate tenure instrument or management agreement; (b) identify areas of forestland with plantations developed using government funds or under National Greening Program and other similar projects, that are not under any existing tenure program of the Department and recommend management options; and (c) offer untenured areas to qualified investors and provide appropriate tenure instruments or management arrangement.

This refers to the Memorandum from DENR MIMAROPA dated 27 June 2022 regarding the FY 2022 SPMS indicator "15% open-access/untenured lands of the public domain placed under appropriate management arrangement/tenure". Accordingly, the said target is not realistic.

The Region has an approximately 210,437.56 hectares of open-access/untenured lands of public domain, and 15% of which is 31,565.634 hectares. Based on their experience, the average area per tenurial instrument issued is below one (1) hectare. For them, it is impossible to accomplish 31,000 hectares for tenurial issuance activity in a year. Also, not all open-access/untenured lands are accessible are inhabited. In view of this, it is requested that the 15% target shall be based on the untenured NGP graduates sites instead. Accordingly, graduated NGP sites, a replacement target area, is more rational and practical since the government has already invested on these areas. In relation, the Region is requesting the Bureau to issue guidelines on the appropriate tenure or management arrangement for uninhabited NGP graduated sites.

Please be informed that the said indicator is also a Performance Indicator contained in the General Appropriation Act for the DENR Annual Budget. We were informed that the Bureau is currently doing a review on the said indicator with the Regional Offices. Hence, we are forwarding the request of DENR MIMAROPA for consideration.



This is to respectfully request for reconsideration on the FY 2022 SPMS indicator of 15% open-access/ untenured lands of the public domain placed under appropriate management arrangement/tenure" under the Natural Resources Enforcement and Regulatory Program. This office feels that the said target is not realistic.

Currently, the DENR MIMAROPA has approximately 210,437.56 hectares of open-access/untenured lands of the public domain, and 15% of this is equivalent to 31,565.634. Based on our experience/historical data, the tenurial instruments we issued were mostly below an average of one (1) hectare per tenure. Hence, it is quite impossible for us to process 31,000 tenurial instruments. Notwithstanding the fact that not all these open-access/untenured lands are accessible (refer to sample attached map of Occidental Mindoro) and are inhabited.

Foregoing considered, we would like to seek authority/permission that the 15% target shall be based on the **untenured NGP graduated sites**. Aside from it is realistic, targeting the NGP graduated sites is more rational and practical since we already invested on these areas. The untenured NGP graduated sites in MIMAROPA are as follows:


