This is to extend our gratitude for the cooperation given by your representatives to the recently concluded first part of our Webinar Series on Ambitious City Promises (ACP), under the **Harnessing Cities' Share in the Implementation of the Environment and Natural Resources Component of the Philippines' Nationally Determined Contribution**. Hopefully, your team will be able to apply the knowledge learned. Another activity in the same program is the development of **The National Urban Green Spaces Action Plan 2023-2030**. The NUGSAP aims to develop a clear plan and approach on how to implement Urban Green Spaces (UGS) in the country.
