# ONLINE POLICY CONSULTATION ON VARIOUS POLICY PROPOSALS UNDER THE FORESTRY SECTOR

#### I. Rationale

The Forest Management Bureau is mandated to provide technical guidance to the DENR Central and field offices in the effective protection, development, and conservation of forestlands and watersheds, and to recommend policies and programs towards the achievement of sustainable forest management, based on science and principles of good forest governance.

As part of this mandate and to ensure the participation of the DENR Field Offices in the policy development process, an Online Policy Consultation on various forestry-related policy proposals shall be spearheaded by the Forest Management Bureau on 23 August 2022 via Zoom Teleconference.

## II. Objectives and Expected Output

The Online Policy Consultation aims to solicit inputs and recommendations from the DENR Field Offices on the following draft policy proposals concerning the forestry sector:

- 1. Draft Guidelines Amending Certain Provisions of DENR Administrative Order No. 2008-22 re: Revised Guidelines on the Deputation of Environment and Natural Resources Officers (ENRO);
- 2. Draft Guidelines on the Disposition of Turned-Over Logs Derived from Tree Cutting Permits; and
- Draft Guidelines on the Establishment of Storage Facilities for Seized and/or Confiscated Illegal Forest Products, Including Machinery, Equipment, Tools and Implements Used in Violation of PD 705, As Amended.

The Workshop shall result to the final working draft of the abovementioned guidelines for the review and endorsement of the FMB Policy Review Committee and the DENR Policy Technical Working Group prior to the consideration and approval of the Secretary.
