Greetings! This refers to your "**NOTICE TO VACATE**", dated November 07, 2022 (Copy hereto append for your reference marked as "*ANNEX-A1 & A2"*), directing the undersigned to voluntarily **REMOVE THE STRUCTURES** that we built and **VACATE THE AREA** of the parcel of land we occupied and possessed covered under Land Classification Map (LCM) No. 3400, Project No. 12-S, certified on October 15, 2015, in violation of certain provisions of P.D. No. 705, specifically Sec. 20 & Sec. 78 thereof, Thirty (30) Days upon receipt respectively.

Relatively, I was invited to attend a meeting last May 10, 2022 @ 1000H through your invitation letter dated April 29, 2022, (Copy hereto append for your reference marked as "ANNEX-B1 & B2"), to discuss my complains against GLECERIO CABALLERO & his cohorts, through "888 Citizens' Complaint Hotline, TR No. w20220420-877-36", dated April 20, 2022, (Copy hereto append for your reference marked as "ANNEX-C1 & C2"), whom entered and took possession over my claimed surveyed lot by means of force, violence and intimidation by forcibly entering the said area when he was informed of my possession and occupation, he refused to listen to the timely demand and/or advise to cease and desist from entering, taking over and possession of the same, and have in fact caused the caretaker to be manhandled, shoved and pushed around by said person & his cohorts, (Copies of Bgy. Complaints, Case No. VII-24-15, hereto append for your reference marked as "ANNEX-D1, D2, D3, & D4").

The undesigned also sent a "Complaint Letter" addressed to MR. FLORENCIO C. DIAZ, CENRO – DENR Office – Brooke's Point, Palawan, dated September 01, 2015 reiterating my previous encroachment of MR. ISIAS BARRAMEDA & his cohorts on the same subject Area whom I acquired "Possessory Rights, (Copy hereto append for your reference marked as "ANNEX-E") & my duly notarized "AFFIDAVIT OF MERITS", dated August 07, 2015, deposing and stating the facts how did I acquired said possessory rights accordingly, supported by duly notarized "AFFIDAVIT OF MERITS" of NEMENCIO CORPUZ & ESTHER GALICIA, (Copies hereto append for your reference marked as "ANNEX-F1, F2, F3, & F4"). A copy of the survey map/plan duly signed/attested by DENR Personnel of the area occupied/claimed by REBOMAFEL O. TAGLE, et. al, hereto append for your reference marked as "ANNEX-G",

For clarifications, the undersigned denies fencing on the area for I knew that it's prohibited by law to fence it without a fencing permit, fences on subdivided areas were done by other occupants who encroached my claimed area, (Copy of photos hereto append for your reference marked as "**ANNEX-H**"). The undersigned together with my family only planted fruit bearing trees and rice since the beginning up to the present. In view hereof, I am respectfully requesting your good Office for consideration of my possessory rights of the said area. I strongly believed that our government in the near future shall re-classify the area from Timberland to Alienable & Disposable, in line with the mandate of **E.O. No. 75** of the former **PRES. RODRIGO R. DUTERTE**, dated February, 16, 2019. Please guide & help the undersigned to fulfill & comply all government agencies involved requirements to validate my claim accordingly.

Thank you and upon receipt hereof, please acknowledge this official communication and action/s taken as requested within the prescribed period in accordance with the provisions of **RA11032**, otherwise known as the "*Ease of Doing Business and Efficient Government Service Delivery Act of 2018*".

It is informed that during the actual verification, investigation and projection of the alleged illegal occupation at Sitio Gadsan, Barangay Rio Tuba, Bataraza, Palawan by our personnel on April 26, 2022, they have found out that an area falls within timberland classification. As per records of this office, It was learned that the area was first claim/ occupied by Mr. Glecerio Caballero. Further, records show that this office had filed a case against Mr. Glecerio Caballero and other forest land occupants in the area for violation of Section78 of PD 705 as amended.

For further verification and investigation, Ms. Neneta Nuevacubeta- Abaca, Mr. Glenn Perez and Mrs. Beverly Perez, Mr. Glecerio Caballero, and Mr. Neal G. Momo (son of Mrs. Nila Momo) was invited, on May 10, 2022 and August 16, 2022 at CENRO Brooke's Point for a dialogue/meeting. In that meeting, none of them has legal documents presented.

Further, on the meeting Mr. Glecerio Caballero admitted that he was subdivided the area for residential lots. All of them occupied parcel of lot in the area which they planted pineapple, different fruit trees and crops. Some of them enclosed their occupied area with fence, concrete fence.

In view of the foregoing, this Office is hereby notify you that your occupation and undertakings on the area of land within timberland area per Land Classification Map No. 3400, Project No. 12-S, certified on October 15, 2015 without lawful authority is violation under the provisions of P.D. No 705 as amended. By reason thereof, you are hereby directed to voluntarily **REMOVE THE STRUCTURES** that you built and **VACATE THE AREA** you are occupying in violation of the following provisions of law:

"ANNEX - A2"

Presidential Decree No. 705, as amended, otherwise known as the Revised Forestry Code of the Philippines.

Section 20. No person may utilize, exploit, occupy, possess or conduct any activity within forestland xxx, unless he had been authorized to do so under a license agreement, lease, license or permit;

Section 78. Any person who enters and occupies, or possess xxx any forestland or grazing land or part thereof xxx or refuses to vacate the area when ordered to do so pursuant to the provisions of Section 53 hereof.

In view hereof, this Office is giving you a period of **THIRTY (30) DAYS** upon receipt of this Notice to comply, otherwise, we will be compelled to file a case's against you before the proper court

We are hoping you will give this matter your preterential and utmost attention in order to avoid a costly litigation.

Dear Sir:

This is to formally file a COMPLAINT with your office regarding the encroachment made on the land situated in Cory Village, Rio Tuba, Palawan. I have brought this matter to your attention sometime in August 2015 and I now reiterate my Complaint and request for action on the matter.

Sometime in April 1990 I acquired possessory rights over a timberland in Cory Village, Rio Tuba, Palawan. The area of about 15.06 Hectares was surveyed and delineated by the Rio Tuba Nickel Mining Corporation (RTNMC) on July 1996 with technical description duly plotted. (Annex "A"). At the time of my possession, the area was an irrigated rice land and planted with cashew, pineapple, banana mango, calamansi and atis. A small nipa house was also constructed on the area. Unfortunately, the house burned down and so were other cashew trees. However, another house was constructed where my long-time caretaker still resides.

Over a month ago, my caretaker reported that he was harassed by Mr. Isaias Barrameda. It was then that I learned that Mr. Barrameda and five others (namely: Glenda Fulgencio, Leo Fulgencio, Alyas "Manoy" Fulgencio, Ben Katakata, and Edison Barrameda, Sr.) have already encroached into the area over which I have a prior possessory right. My prior possessory right is duly supported by Affidavits of witnesses who have personal knowledge therof. (Annex B, C, D).

I have brought this matter before the Barangay of Rio Tuba. However, Bgy. Captain Gomer L. Miano has endorsed this matter to your office, as contained in his letter to you on August 18, 2015. (Annex E).

Hence, I now appeal to your office for immediate action on this matter for the protection of my rights as prior and long-time possessor of the land.
